The Bill makes a technical change to existing law and to permit the independent police review authority access to juvenile records to carry out their investigations. It's a technical change. I know of no opposition."

Bost: "You know, I'm looking at your language here. Has this Bill been amended from its..."

Burns: "We adopted a Committee Amendment to make the Bill better at the request of the Cook County State's Attorney."

Bost: "But when... when you got this job and you promised the people that you'd come here and serve, you realize that, you know, you should pay attention to your language of your Bill when it first comes out. This is your first Bill and you had to amend it already?"

Burns: "Well, we wanted to make it a better Bill and there were some comments that we received and we thought it would be better to go ahead and take those comments and I think that we have a better product as a consequence."

Bost: "So... so, what you're saying is is the first Bill you presented wasn't a better Bill. So, your first Bill's not a really good Bill unless it's amended."

Burns: "We wanted to make it the best Bill that it could be for this special process."

Bost: "I'd like to go more on to the question of Representative Eddy. He... what exactly is your job, again, outside of this... this chamber?"

Burns: "I just work for a small public affairs firm."

Bost: "Public relations? Is that..."

Burns: "We do public relations, correct."

Bost: "Okay. And how do juveniles feel about this? It says it deals with juveniles."

Burns: "Well, I think juveniles will be happy to know that this Bill is out there because it will make it easier for the independent police review agency to investigate issues where juveniles are involved."

Bost: "You know, it says juvenile just... Do you have any children?"

Burns: "I do. I have one daughter."

Bost: "And her age?"

Burns: "She is 17 months."

Bost: "Oh. So, you haven't learned this yet. Just so you know, juveniles really don't think there is any justice, but... once they get up to that level and they're around your house..."

Burns: "When she wants her milk, she certainly knows how to protest."

Bost: "But... but they get... they get justice at that age. They really do. Representative, you say that the... that your staff... when you said the House staff agreed with this Bill and actually... they were the ones that suggested the Amendment or who suggested it?"

Burns: "The Amendment was a sug... was at the suggestion of the Cook County State's Attorneys Office."

Bost: "Okay."

Burns: "And it just tightened up the language that was in the underlying Bill."

Bost: "And your staff felt that this was a good Bill for you?"

Burns: "They did. You know, there's a cur... under cur..."

Bost: "We're just... we're just trying to find out what your expertise in... is in this area."

Burns: "Thank... My expertise in it is that I'm a citizen of the City of Chicago and resident of the State of Illinois and a Member of this House and was trying to do a Bill that would make a difference for the folks back home and make it easier for the city to investigate issues of police misconduct. And so, that's why I was happy to sponsor the Bill."

Bost: "So... so, what I really need to know... so, this will be specifically for Chicago not... not just for Cook County?"

Burns: "Actually, the way the Bill is written if any other municipality through ordinance creates the same kind of civilian organization as the City of Chicago to investigate these kinds of cases, then they would be covered by this statute."

Bost: "But... but it's specifically written for Chicago?"

Burns: "It is not."

Bost: "Okay. It's not special legislation?"

Burns: "It is not special legislation."

Bost: "Well, why... if it's not special, why would you carry it?"

Burns: "It was needed and important. That's why I decided to carry it."

Bost: "So, it's important, but not special legislation?"

Burns: "Not special legislation..."

Speaker Mautino: "Could the Gentleman bring his remarks to a close."

Burns: "...in the way that you define the term."

Bost: "Well, thank you, Mr. Speaker. I... I don't know. I kind of think it does lean specifically for Chicago and as downstaters, I think we should keep a very close eye on it. Thank you. Thank you for the questions."

Speaker Mautino: "The Gentleman from Chicago, Representative Lang. For what reason do you rise?"

Lang: "Well, first of all. Mr. Speaker..."

Speaker Mautino: "From Cook."

Lang: "...I'm not from Chicago."

Speaker Mautino: "From Cook. The Gentleman from Cook."

Lang: "Not that I mind. It's a wonderful city; I represent part of it. I... And we'll get back to you in a minute, Sir, but will the Sponsor yield?"

Burns: "Yes."

Speaker Mautino: "Indicates he will."

Lang: "I thought he might. Representative, I just want to straighten this out for the record and for all these wonderful people in the gallery. This is your first Bill."

Burns: "This is my first Bill as a Member of the House."

Lang: "Now, you handled quite a few Bills when you were in the Senate, did you not, as a staff person?"

Burns: "I did."

Lang: "Yeah. So, is this something left over from your agenda from another year, Sir?"

Burns: "It is not, Representative. It was... it's a Bill that the City of Chicago came to me with that they wanted to deal with this Legislative Session."

Lang: "Well, who from the city? The entire city, all eight million people showed up in your office. Who came to you about this Bill?"

Burns: "Some... some folks from the city's department of intergovernmental affairs and some folks from the police review agency."

Lang: "All of them?"

Burns: "Not all of them."

Lang: "Several of them all at once converged on your office."

Burns: "I asked to meet with folks from the City of Chicago to find out what issues they were going to be working on this Legislative Session and they offered this Bill as an

- opportunity for me to be helpful to the folks back in my district."
- Lang: "Now, has this been a big agenda item for you throughout your whole life that you would make this your very first Bill?"
- Burns: "Having worked in the Senate, I tried to find a Bill that was going to be appropriate for this process but would also be important to the people of my district."
- Lang: "So... and you've checked with the people of your district about this particular Bill. Did you do a survey, a phone poll? How do you know, Sir?"
- Burns: "I talked to some folks in my district that, you know, advised me on policy issues and they thought it was a good approach to take."
- Lang: "Really. And do you have other policy issues that you've gotten out of your constituents? You might... The reason I ask is you might save some of us the need to have a local meeting. Maybe you can give us all information that you've gathered from your constituents. Would you share it with us?"
- Burns: "The basic issue, you know, is that we have this independent agency and it's not covered under State Law until it's going to slow down the process. We're investigating a... police cases, cases of misconduct and if that's a big issue in the community where you have qui... a issue of what's going on with those cases and closing out the investigations, as you know, justice delayed is justice denied. So, that's why I'm sponsoring the Bill."

Lang: "Justice delayed is justice denied. That's very good.

Are you aware, Sir, that your answer was like when I ask you the time and you just tell me how to build a clock? I didn't ask you that question that you answered. So, let me ask you this. It's really more of a personnel issue. I know this is your first Bill."

Burns: "Yes."

Lang: "It's very important to you."

Burns: "Yes."

Lang: "There's 118 Members out here on the House Floor and you could only find one cosponsor and a dentist at that? This is the only cosponsor you could find to help you with this Bill?"

Burns: "Well, I... I would encourage all the Members of this Body to sign on to the Bill, but I'm happy to have Representative Miller's support and hope that everyone will vote for the Bill."

Lang: "You understand now that you've mentioned his name in debate we're going to be hearing from him next."

Burns: "I saw his light on anyway, so..."

Lang: "All right. So, I noticed that your Senate Sponsor is Senator Raoul."

Speaker Mautino: "Gentleman, bring his remarks to a close."

Lang: "That was 5 minutes. I wasted some of it telling you I wasn't from Chicago. All right. Last question. Senator Raoul has a similar Bill in the Senate. Is he your Senator?"

Burns: "He is my Senator."

Lang: "Did he run his Bill yet?"

Burns: "I'm not sure where it is in the process. My understanding is it's on... it's out of committee and on the floor."

Lang: "Don't you think he's going to be pretty darn ticked off that his freshman Representative ran the Bill before he did? What about the protocol? Maybe you should take this out of the record and check with him, Sir?"

Burns: "Well, I... you know, if I have an opportunity to talk to him, I will definitely touch base with him, but I'd like to proceed with the Bill."

Lang: "Well, you want to just take this out of the record and we can come back to it while you check with your Senator?"

Burns: "I appreciate the recommendation, but I'd like to continue forward with the..."

Lang: "One thing I should tell you. You should never tick off your Senator. Thank you, Sir."

Speaker Mautino: "Representative Reboletti."

Reboletti: "Thank you, Speaker. Will the Sponsor yield?"

Speaker Mautino: "He indicates he will."

Reboletti: "Representative, I'm going to ask you some actual questions about this Bill. I know that Representative Black is not here to join in with Representative Lang, but some of my Members have questions regarding the actual need for this. Did the City of Chicago actually put together their own authority to review cases of police misconduct? Is that what you're saying?"

Burns: "Yes, Representative."

Reboletti: "And why is this needed now if you were able to create the… the City of Chicago was able to do this without

our assistance, why do they need to go look at juvenile files?"

- Burns: "Well, because under current law the only agency... police agencies are the only ones that have access to these files. So, because the City of Chicago has created a new entity to investigate these cases, they weren't covered under the current law. So, what this Bill does is add agencies that are created like this, by ordinance, so that they can have access to this information under certain circumstances."
- Reboletti: "What are they hoping to find in these juvenile files that have been sealed? I know there are police misconduct issues; I know they need to be investigated. These are usually just dispositions of what happened at trial. Are we talking about coerced confession or some type of prosecutorial misconduct?"
- Burns: "The basic issue is that about 11 percent of the investigations that are handled by the authority involved at least one juvenile victim or a witness to the alleged misconduct. And so, having access to those files gives you more information about who was involved in those... in that particular incident and that's very important in terms of doing a thorough investigation."
- Reboletti: "So, it's an issue of finding out additional information so that this independent authority that's being created is able to make sure that they've talked to everybody before they move forward on a police misconduct investigation."

Burns: "That's correct."

Reboletti: "Now, earlier, you objected to one of my colleague's questions over here. Are you licensed to practice law?"

Burns: "Thankfully, I am not."

Reboletti: "Thankfully, you're not. Well, Representative Burns, I'd have to ask you to take your Bill out of the record because I think the Lawyers Caucus may have some objections to it, as of right now. Would you consider doing that?"

Burns: "No. You know, I'm unaware of any opposition. We worked to amend the Bill in committee so that it would be a better Bill. In fact, the Cook County State's Attorneys Office offered several suggestions that we've incorporated. And so, I'd like to proceed and move this Bill over to the Senate so that we can get it to the Governor's desk and move forward."

Reboletti: "Well, I can appreciate that, but I think you probably have about 10 angry lawyers on this House Floor. So, I would ask everybody to reconsider their positions. Thank you."

Speaker Mautino: "Representative Sullivan."

Sullivan: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Burns: "Yes."

Speaker Mautino: "Indicates he will."

Sullivan: "Representative, I know it's fun for a freshman's first Bill. I do have some substantive questions I'd like to ask. When you're talking about reviewing records, are you talking about any records or specifically juvenile records?"

Burns: "Specifically juvenile records."

- Sullivan: "Okay. I just wanted to get that on the record as what we're talking about. I believe that you worked out some language for confidentiality in regard to these records. Can you clarify what your agreement was with the State's Attorneys Office?"
- Burns: "Well, the Amendment that we adopted in committee provides that the agency may not disclose or release the information of these records to the general public."
- Sullivan: "Okay. Throughout your Bill, it talks of and I'll read directly from the Bill. It says... you'll see this language. It says, 'created by ordinance and charged by a unit of local government with the duty investigating the conduct of law enforcement officers.' So, they're going to pass an ordinance that says they can view these records. Within that ordinance is there any requirement, under your Bill, on who can see the records and what are the procedures to secure those records?"
- Burns: "It's the persons or staff charged with the duty of investigating the police conduct. So, those are the only folks at the agency... excuse me... the authority who are permitted to review those records."
- Sullivan: "Right. Do you see the potential problem that... that, you know, potentially could be fixed in the Senate. Your Bill is giving authority to people to review the records, but it is not talking about how to secure those records, who can say other than an ordinance is prescribed. So, there seems to be a gap in my opinion on who and what are the procedures by which they can review them and they're secured."

Burns: "Well, I'm not sure if I see the same gap that you see,

Representative. My understanding is that, under current
law, the current law just has it the police department has
access to these records."

Sullivan: "Sure."

Burns: "And it's not delineated in current statute who in the police department has access to these records and that... in terms of review. What we wanted to do was amend the statute to include this new agency and make it very clear these records cannot become public under any circumstances."

Sullivan: "And while police departments can review the records, 'cause they're part of law enforcement, they have policies and procedures in place by which they can review and disseminate the information. You're asking for these folks to be able to review it by ordinance. In your legislation it does not point out what those policies will be, so the City of Chicago could pass an ordinance that says Mr. Smith gets to review the records and that would be the end of the policies and procedures by which to secure these records."

Burns: "Well, my understanding, Representative, is that in the language they... the agency has to be specifically charged in that ordinance with the responsibility of investigating these sorts of cases. We drew... we drafted the language as narrowly as possible to deal with this... this circumstance. The independent police review authority is the only one of its kind in the entire state."

Sullivan: "Okay. Thank you. To the Bill. Ladies and Gentlemen, we understand where the Representative's going

with this. Just be careful with it because the City of Chicago could just pass any ordinance that they want saying anything that they want to open up these records to this independent authority. I am just concerned about what is the line... the chain of command of these records so they don't get disseminated to folks that shouldn't get it. Thank you."

Speaker Mautino: "Further questions? The Gentleman from Cook, Dr. Miller."

Miller: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Mautino: "Indicates he will."

Miller: "At least somebody maybe can help you out. That's with Representative Burns since my name is listed. I noticed that the Senate Sponsor is also in the chamber. Is he here to help you with this Bill?"

Burns: "I'm not sure. He's standing a bit away from me, so I would not... I would not assume that he's here to help me on this particular legislative matter."

Miller: "So, you're not sure what he's doing here regardless, right? But it's not to help you?"

Burns: "I'm not sure exactly why he's here, but I'm sure it's for an important purpose for the people of the great State of Illinois. He carries a number of my Bills over in the Senate and so, I'm happy..."

Miller: "Well, you mentioned... you mentioned the Senate and you came from the Senate. Does... how does past President...

President Jones feel about this Bill?"

Burns: "I have not had any..."

- Miller: "Especially you being a House Member? You being a House Member now, how does Senate President Jones, past President, feel about this?"
- Burns: "Are you asking me how he feels about the Bill or how he feels about me being a Member of the House or both?"
- Miller: "Well, I can imagine what he would say if you were a Member of the House. I'm sure other Members of the House would know he would... may say about it, but since we're talking about the Bill, let's talk about the Bill."
- Burns: "To answer your question, Representative. I have not had the opportunity to discuss this issue with the former Senate President."
- Miller: "Well, he may be for this or against this. You don't know?"
- Burns: "I have no idea where... what his position on this Bill is."
- Miller: "Well, why don't you go back to the Senate and find out?"
- Burns: "'Cause he's not there."
- Miller: "Oh, okay. All right. Okay. All right. Just wanted to make sure. Let me ask you something. I mean, did you know that there comes a time... you know, is this one of those times when we need to have a certain call. Did you know that?"
- Burns: "I'm sorry. Can you repeat your question? It was a little loud in here..."
- Miller: "I'm asking... I'm asking the question. Did you know that there comes a time when we need a certain... to heed a certain call? Did you know that?"

- Burns: "I'm familiar with this. I think I know where you're going, but please continue, Representative."
- Miller: "Well, when the world must come together as one... is this one of those Bills that the world must come together as one?"

- Miller: "And speaking of 'green' lights, do you know what the Century Club is?"
- Burns: "I believe I am aware of the Century Club."
- Miller: "Oh. Well, did you know we can't go on day to day pretending? Did you know that? That these Bills are important like this. Is this still important?"
- Burns: "This Bill is important to the people of the City of Chicago and the State of Illinois and it's a very important Bill and I'd appreciate your support on it."
- Miller: "Well, I would argue, Representative Burns, that we are all part of God's great big family and in truth... and the truth, you know, love is all we need. Did you know that?"
- Burns: "I was aware of that. I was aware of."
- Miller: "Did you know we are the world? We are the children...

 Representative Burns, serious. You know, we are the children."
- Burns: "I'm certainly..."
- Miller: "Is this is for the children? Is this for the children? Answer the question?"

- Burns: "This is for the children. This will help to make sure when there are cases involving juveniles that the… the authority will have access to the records that are important to carrying out the investigation."

- McCarthy: "Thank you, Mr. Speaker. I move the previous question."

- Burns: "Thank you, Ladies and Gentlemen of the House. I would appreciate your support on this Bill. Thank you very much."

Lyons: "Mr. Speaker, for the point of personal privilege."

Speaker Mautino: "State your point."

Lyons: "Ladies and Gentlemen, this morning I was privileged enough to put in House Joint Resolution 37, which I'm sure we'll be voting on at some point in time in the future. But what House Joint Resolution 37 does is it honors the Hemophilia Foundation of Illinois on their 60th anniversary. And sitting up in the gallery above the Democratic side are members of the Hemophilia Foundation of Illinois. I'd appreciate a nice, warm Springfield welcome. Thank you. And God love you for all the work you do."

Speaker Mautino: "Welcome to Springfield. Mr. Clerk, on page 52 of the Calendar appears House Bill 47. Representative Brady. Mr. Clerk, read the Bill."

Clerk Mahoney: "House Bill 47, a Bill for an Act concerning government. Third Reading of this House Bill."

Speaker Mautino: "Mr. Brady."

Brady: "Thank you very much, Mr. Speaker. Ladies and Gentlemen of the House, House Bill 47 simply seeks to protect medical records as it pertains to emergency dispatching for law enforcement agencies to better serve those that they're... responding to and to be made aware of special concerns, disabilities an individual may have so they could respond and act appropriately when trying to assist them. I'll be happy to answer any questions."

Speaker Mautino: "And on House Bill 47, Representative Franks."

Franks: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Mautino: "Indicates he will."

Franks: "Representative, I'm not sure I understand what you're trying to accomplish with this Bill. Our analysis indicates that you're looking to exempt physical or mental status. Could you describe this some more?"

Brady: "Sure. The initiative is that of one of my local law enforcement agencies. And what it would do is that if a family would voluntarily share information to that law enforcement agency for means of dispatching, for instance, if the individual might have autism. They may... the individual might have some other type of disability that the law enforcement agency would share only with responding emergency crew or law enforcement that that information under the Freedom of Information Act would not be shared with any other individual, if that... if that FOIA was filed with that agency."

Franks: "Why?"

Brady: "Because the town attorneys had a... kind of a feeling of a gray area that existed in the FOIA and we have worked with the Illinois Press Association. We may have an Amendment that they want to put on in the Senate which I said I'd be happy to work with them on. They have drafted some other language. They kind of feel that it's already covered. But we're just trying to make sure that when the families voluntarily give this information are being told from the program that this information will not be shared only with law enforcement officials for the protection and

safety of the individuals they may be responding to to render help, that that's in fact the situation."

Franks: "'Cause I see the Press Association is opposed at this point."

Brady: "They were opposed and the last that I knew was that they were drafting some language. It was agreed to language and I haven't heard back from them, quite frankly."

Franks: "Well, could we hold off then and move it to Second until we get the language so we can make this an agreed Bill because it's the first week of what we're doing this. I'd like to make sure we get it right, if we could?"

Brady: "Sure. I'll be happy to do that. I just thought we had... had left things that they were going to try to add something over in the Senate. They were going to get me something; I just haven't seen anything from them yet."

Franks: "Well, perhaps we can wait a day if we don't hear back from them."

Brady: "I'll be happy to, Representative, sure."

Franks: "Thank you."

Brady: "Sure."

Franks: "Thank you."

Speaker Mautino: "Mr. Clerk, would you take this Bill out of the record. Mr. Clerk, on page 52 of the Calendar is House Bill 65. Representative Ford. Out of the record. Mr. Clerk, on page 55 of the Calendar appears House Bill 761. Representative Howard. Mr. Clerk, read the Bill."

Clerk Mahoney: "House Bill 761, a Bill for an Act concerning courts. Third Reading of this House Bill."

Speaker Mautino: "Representative Howard."

"Thank you very much, Mr. Speaker. House Bill 761 Howard: amends the Juvenile Court Act of 1987. It provides that the... that if the minor is in the custody of the Illinois Department of Children and Family Services of the State of Illinois, that pursuant to an order entered under the Delinquent Minors Article, the court shall permanency hearings as set out in the Abused, Neglected or Dependent Minors Article of the Juvenile Court Act. Currently, if a minor is in the custody of the Illinois Department of Children and Family Services, pursuant to an order of Abused, Neglected or Dependent Minors Article, the court can conduct dependency hear... a permanency hearing and the department would like that to be the same with the delinquency situations. I would ask that my colleagues please vote 'yes' on this legislation."

Speaker Mautino: "On House Bill 761, Representative Reboletti." Reboletti: "Thank you, Speaker. Will the Sponsor yield?" Speaker Mautino: "Indicates she will."

Reboletti: "Representative, why did DCFS make this request?

What would make... How will the system benefit from this being consistent with the other types of hearings from the DCFS placement?"

Howard: "Obviously, they're having a difficult time trying to assist these young people and they feel that if this was in place, then they would not have the problem. So, they..."

Reboletti: "Would there be additional services or counseling or education available to them..."

Howard: "Certainly, all..."

Reboletti: "...that's not available right now."

Howard: "Yes. Certainly. All of that and other things that would come because they have the authority to do certain things that they cannot do now."

Howard: "There was the point where they raised the question, but they do understand now having been convinced by the department that they need this. At one point they said that we don't… we don't have anything to do with that, but they are now not opposed to the Bill."

Reboletti: "Thank you, Representative. I urge an 'aye' vote."

Speaker Mautino: "Seeing no one else seeking recognition, the question is, 'Shall this Bill pass?' All in favor vote 'yes'; opposed vote 'no'. And the voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wished? Mr. Clerk, take the record. On House Bill 761, 111 voting 'yes', 0 voting 'no', 0 voting 'present'. The Bill is declared passed. Mr. Clerk, on page 55 of the Calendar appears House Bill 760. Representative Kosel. Mr. Clerk, read the Bill."

Clerk Mahoney: "House Bill 760, a Bill for an Act concerning government. Third Reading of this House Bill."

Speaker Mautino: "Representative Kosel."

- Kosel: "Thank you, Mr. Speaker. Ladies and Gentlemen of the House, this Bill was passed last year and got caught up in the Senate and was not ever brought to the Governor for his signature. Last year it was 4720. This year... it declares; it's exactly the same. It declares the month of April as Parkinson Awareness Month, this year and every year going forward. And I would ask for your approval."
- Speaker Mautino: "No one seeking recognition. The question is, 'Shall this Bill pass?' House Bill 760, on that... those in favor vote 'yes'; opposed vote 'no'. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Mr. Clerk, take the record. On House Bill 760, 111 voting 'yes', 0 voting 'no', 0 voting 'present'. This Bill is declared passed. On... Mr. Clerk, on page 55 of the Calendar appears House Bill 751. Representative Ryg. Mr. Clerk, read the Bill."
- Clerk Mahoney: "House Bill 751, a Bill for an Act concerning health. Third Reading of this House Bill."

Speaker Mautino: "Representative Ryg."

Ryg: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. House Bill 751 amends the Mental Health and Developmental Disabilities Administrative Act, the State Property Control Act and the Community Services Act to require the net proceeds of the sale of the state mental health facility or state developmental disabilities facility would be deposited into the Community Mental Health Medicaid Trust Fund and the Community Developmental Disability Services Medicaid Trust Fund respectfully. Be happy to answer any questions."

Speaker Mautino: "Thank you, Representative. On House Bill 751, Representative Bellock."

Bellock: "Thank you very much, Mr. Speaker. To the Bill. This is an extremely important Bill because in this environment that we're in right now with maybe a closure of an institution or with the blueprint talking about closing institutions, it's very important that we get the money from... if an institution closes, that would follow individuals into the community. And that's exactly what this Bill does. Up until this time, if an institution would close, the money would go into the General Revenue Fund; it would not follow into a community environment which is what we're attempting to do. Thank you."

Speaker Mautino: "Thank you. And the Gentleman from Jackson,
Representative Bost, for what reason do you seek
recognition?"

Bost: "Will the Sponsor yield?"

Speaker Mautino: "Indicates she will."

Bost: "Representative, is there anything in the Bill… this is the first time I'm getting an opportunity to look at this… is there anything in the Bill that would possibly slow down the closures of existing facilities?"

Ryg: "No, this would simply say where the revenues when the closure is det...."

Bost: "So... so, could it be construed that this might encourage closing of existing facilities?"

Ryg: "No, this is intended to direct the revenues from a closure."

Bost: "Okay. But... but what I'm saying is is that... maybe I should ask... AFSCME, do they have a position on this?"

Ryg: "Not that I'm aware of."

I just know that we have a facility in my district or just right on the edge of my district, mine and Representative Phelps's district, and it does a wonderful job and it is a very successful service that is provided and we just have a concern that maybe, you know, anything that might just encourage them to have any closures there, we don't… we don't want to see that."

Ryg: "Well, actually, Representative, this Bill would provide that the Department of Human Services could allocate services to other state-operated centers if there was a need for staffing in maintenance and operations."

Bost: "Okay. Thank you very much."

Speaker Mautino: "No one else seeking recognition. The question is, 'Shall this Bill pass?' All in favor vote 'yes'; opposed vote 'no'. And the voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Mr. Clerk, take the record. House Bill 751, having received 111 'yes', 0 'no', 0 voting 'present', is declared passed. Mr. Clerk, on the Calendar, page 52, appears House Bill 159. Representative Mathias. Mr. Clerk, read the Bill."

Clerk Mahoney: "House Bill 159, a Bill for an Act concerning local government. Third Reading of this House Bill."

Speaker Mautino: "Mr. Mathias."

Mathias: "Thank... thank you, Mr. Speaker. House Bill 159 increases the threshold to \$10 thousand for municipal

contracts addressing public improvements in special service areas. The threshold is pretty standard now for other governmental units. Part of the Bill basically says that if... if the value is under 10 thousand the municipality can do the work themselves rather then letting it out for bid. And I ask for your 'aye' vote."

- Speaker Mautino: "No one seeking recognition on House Bill 159, the question is, 'Shall this Bill pass?' All in favor vote 'yes'; opposed vote 'no'. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Representative Poe, Representative Burns. Mr. Clerk, take the record. House Bill 159, receiving 77 'yes' votes, 34 'no' votes, and 0 'presents', is declared passed. Mr. Clerk, on page 52 of the Calendar appears House Bill 65. Representative Ford. Read the Bill."
- Clerk Mahoney: "House Bill 65, a Bill for an Act concerning state employment. Third Reading of this House Bill."

 Speaker Mautino: "Representative Ford."
- Ford: "Thank you, Mr. Speaker and Members of the House. House Bill 65 is the State Application Act. This Bill passed last year or last Session and I bring it back so that we can get the passage one more time so we get it signed by the Governor. This Bill removes the question off the application as to whether or not a person has ever been convicted of a nonviolent offense. And I ask for a favorable vote."
- Speaker Mautino: "Seeking recognition is the Gentleman from Crawford, Representative Eddy."

Eddy: "Would the Sponsor yield?"

Speaker Mautino: "Indicates he will."

Eddy: "Representative, I want to make sure that we get something straight regarding this Bill and last year, if we could. I thought in your opening comments that you said that this Bill passed last year."

Ford: "Yes, Representative."

Eddy: "Can you... can you tell me..."

Ford: "It passed the previous Session."

Eddy: "The previous Session which is the 95th General Assembly."

Ford: "Yes."

Eddy: "I'm looking at House Bill 4612 which is identical to this Bill that last year had 45 'yes' votes and 63 'no' votes. I want to make sure that you have an opportunity to... to check the comment you made. You might have been thinking of a different Bill and I want to get the record corrected regarding that. So, you might want to check what the Bill number was that passed that had this language."

Ford: "Well, I'm glad you mentioned that because one of the reasons that this Bill comes back in this language and the reason why the Bill that you named, that Bill failed. But your side and other people in this Body recommended that I remove certain things from the Bill and they would support it. And that Bill that passed was 1332. 4612 was a Bill that had veterans' preference in it. I removed veterans' preference and I brought it back in a form that passed in the 95th at the advice of your side and Members on my side."

Eddy: "Representative, there's a great deal of confusion regarding that because our analysis indicates that this Bill is identical to 4612 and that contained the language that was objected to, so I think... I think it would be in everybody's best interest if we take this out and make sure what you're... you're proposing here has that language change, because according to our analysis this Bill is identical to the one that failed not the one that passed. And I don't think you'd want to represent this in a way that's not accurate and it would take us a few minutes."

Ford: "House... House Bill 1332 is the Bill that passed; 4612 is the Bill that failed."

Eddy: "Last year."

Ford: "It failed because Members on your side and Members on my side stated that it had... it was connected with veterans."

Eddy: "Representative, I understand what you're saying. You're saying that a different version of this same Bill with some agreed language passed. What I'm saying is, the Bill that's in front of us does not contain that change, that this Bill is identical to the one that failed. And I think it would be in everybody's interest that we make sure that the Bill that we're voting on is the one that you think you are, rather than the one that failed."

Ford: "What... what is it in the Bill that you notice about 4612?

4612 was seeking to do what?"

Eddy: "Representative, 4612 had the same application. It was attempting to state that for state employment an application could not contain questions as to whether the applicant was convicted or placed on supervision for a

nonviolent criminal offense. Now, what you're stating is that you brought back a different version of that Bill with a different Bill number that removed objection because it had to do with military preferences, et cetera. The problem is and I wish you would allow us to make sure that your statement is correct. I don't... I want you to have that opportunity. Our analysis shows that this version of the Bill is exactly the same as the one that fails and I think you think it's one that was agreed to."

Ford: "Well, agreed to by... whom are you saying it was agreed to by?"

Eddy: "The number of people that you claim voted on it to pass it. Whether or not the Bill has enough votes on it to pass is an issue up to public policy, that's fine. But your statement that this Bill is the same one that passed, I'm not sure that that's the case and I want us to make sure that that's the case before people vote on that."

Ford: "So, how long do you need to make sure of that?"

Eddy: "Well, if you would give us... you could bring it back in a little while."

Ford: "I can show you right now."

Eddy: "Well, we need to have the staff verify. This Bill according to our staff is identical to something that failed; you're saying it's not. If you pull it from the record, we could check that very quickly."

Ford: "So, I... I would love to do that."

Eddy: "Okay."

Ford: "All right. Thank you."

Eddy: "Thank you, Representative."

Ford: "All right."

Speaker Mautino: "The Bill will be taken out of the record at the request of the Sponsor. Mr. Clerk... Excuse me. For what reason is the Gentleman from Jasper, Representative Reis, seeking recognition? Out of the record. Mr. Clerk, on page 55 of the Calendar appears House Bill 710. Representative Zalewski. Out of the record. On page 53 of the Calendar, Mr. Clerk, House Bill 253. Representative Myers. Mr. Clerk, read the Bill."

Clerk Mahoney: "House Bill 253, a Bill for an Act concerning transportation. Third Reading of this House Bill."

Speaker Mautino: "Representative Myers."

Myers: "Thank you, Mr. Speaker, Members of the House. House Bill 253 really is a cleanup Bill for Senate Bill 533 of the 95th General Assembly that later became Public Act 95-377. This Bill... with this Bill, a person who is caught driving on a suspended driver's license when the underlying suspension was the result of a conviction of reckless homicide will now have... be eligible to have his or her vehicle forfeited or seized within a... after being caught driving on a suspended license. This was... this provision was in the Act before House... or Senate Bill 533, Public Act 95-377, but for some reason, when Hou... Senate Bill 533 was drafted and amended, it dropped out the forfeiture seizure part and we're just reinstating that and putting it back in."

Speaker Mautino: "No one seeking recognition, the question is, 'Shall this Bill pass?' All in favor vote 'yes'; opposed vote 'no'. And the voting is now open. Have all voted who

wish? Have all voted who wish? Have all voted who wish? Representative Lyons. Mr. Clerk, take the record. On House Bill 253, 111 voting 'yes', 0 voting 'no', 0 voting 'present'. This Bill shall be declared passed. Mr. Clerk, on page 52 of the Calendar appears House Bill 9. Representative Tracy. Mr. Clerk, read the Bill."

Clerk Mahoney: "House Bill 9, a Bill for an Act concerning health. Third Reading of this House Bill."

Speaker Mautino: "Representative Tracy."

Tracy: "Thank you, Mr. Speaker. This House Bill provides for the creation of the Reflex Sympathetic Dystrophy Syndrome Education Act. This syndrome is a very debilitating disease that is very hard to diagnose, but early treatment and early diagnosis are a key to the best treatment. So, what we are asking is that Public Health disseminate information about this syndrome and also use its Web site to make the public aware. Medical providers are very often not aware. And so, I would welcome any questions."

Speaker Mautino: "No one seeking recognition, the question is, 'Shall House Bill 9 pass?' All in favor vote 'yes'; opposed vote 'no'. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Mr. Clerk, take the record. House Bill 9, having received 111 voting 'yes', 0 voting 'no', 0 voting 'present', is declared passed. Mr. Clerk, on page 55 of the Calendar appears House Bill 799. Representative Wait. Mr. Clerk, read the Bill."

Clerk Mahoney: "House Bill 799, a Bill for an Act concerning criminal laws. Third Reading of this House Bill."

Speaker Mautino: "Representative Wait."

- Wait: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. Yeah. This is a Bill that we've had a number of years that comes out of here unanimous. It goes over to the Senate, unfortunately, it doesn't go too far. This just simply says that for minors it should be not only illegal to buy or sell tobacco but also illegal to possess. I'd be happy answer any questions."
- Speaker Mautino: "Seeing no one recogni... seeking recognition, House Bill 799, the question is, 'Shall this Bill pass?' All in favor vote 'aye'; opposed vote 'no'. And the voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Representative Verschoore. Mr. Clerk, take the record. House Bill 799, having received 111 'yes', 0 'no', 0 voting 'present', shall be declared passed. Mr. Clerk, on page 52 of the Calendar is House Bill 65. Representative Ford. Bill? Or Representative?"
- Ford: "Okay. I'm ready for the 'yes' votes. We've debated the Bill and the people of Illinois can now benefit from this legislation."
- Speaker Mautino: "Members seeking... seeking question, the Gentleman from Crawford, Representative Eddy."
- Eddy: "Thank you. First thing I want to do is thank the Gentleman for taking the Bill out of the record. Staff's had a chance to look at the two Bills and this version of the Bill is the version of the Bill that passed with 61 votes last Session. It did remove a couple of items that were objected to, had to do with military preference and

some of the crimes. However, if the Gentleman would yield, I do have some other questions for him."

Speaker Mautino: "Indicates he will."

Eddy: "Thank you. Representative, as it's written now, basically what happens is that anyone that applies for state employment... now that means any job that's a state employment position... would, on an application, there could not be a question as to whether or not the person was convicted of a nonviolent criminal offense. Is that right?"

Ford: "That's not true. If the State or Federal Law prohibits a person from holding a certain job, then the application can ask the question."

Eddy: "So, but that's limited to jobs like undercover officers or just really of the total number of jobs there are that are called state employment, those that are ruled by federal rules and laws are a small number. But for most state jobs, a large percentage, your intent here is to make the process such that on the application the question cannot be asked as to whether or not the person was convicted or placed on supervision for a nonviolent criminal offense, right?"

Ford: "Well, the question will be moved later in the process, so the question still will be asked."

Eddy: "Well, that... maybe or maybe not, we don't know that, but let me ask you this question just based on your answer. If the question's going to be asked, for the sake of transparency, why not just allow the application to ask like... like it does now. What... what's the difference? Mr.

Speaker, could there be just a little order. I'm not sure they can hear the Gentleman's response."

Ford: "I think... I think transparency is great..."

Speaker Mautino: "The Gentleman's asked for some order in the chamber."

Ford: "I truly agree with you to a certain degree. We need to have transparency, Representative. We also need to make sure that we reduce the number of prisoners that we have in our prison system. Representative Eddy, did you know that we spend one billion dollars a year to incarcerate people in Illinois and that's due to people recidivating back to the prison system because they are unable to obtain employment?"

Eddy: "Representative, I'm a little confused as to the direct connection between asking someone on an application process whether they've committed a nonviolent crime and whether they'll be removed from prison. I... I think you're building a bridge to nowhere..."

Ford: "Now, I understand you. Let me... let me really..."

Eddy: "...with that argument."

Ford: "...answer your question. The question asked... the answer to that question is that sometimes a person may be denied an interview process based on an application."

Eddy: "All right. Let me... let me get right to..."

Ford: "Yes."

Eddy: "...a couple of key questions. Would this... on an application for state employment, would this allow someone who's applying to not list a felony drug possession as... as one of the... the things that they have in their past that

you're trying to not allow state employment to have knowledge of?"

Ford: "If the job..."

Eddy: "Yes... yes or no. Does... does that application disallow the question regarding drug possession?"

Ford: "I mean, if it's a nonviolent offense then, it wouldn't be asked."

Eddy: "The answer is yes. In that situation, that question can't be asked. What about if the person had been convicted of embezzlement?"

Ford: "If the job disqualifies a person... if the offense disqualifies a person, then the question will be asked on application."

Eddy: "Representative, don't you think that if someone works for the Treasurer's Office, we ought to be able to ask questions of the state... as state employment as to whether or not they've been convicted of nonviolent crimes that include fraud or embezzlement?"

Ford: "The law... the Bill does not prohibit from doing criminal background checks."

Eddy: "Representative, that's not the point. The point is..."

Ford: "Wait, wait. That's what you said."

Eddy: "...whether or not... No, it's not what I said. I said on the application for that employment, your Bill, as it's written, would preclude the question regarding embezzlement, fraud, or other types of nonviolent crime."

Ford: "You know..."

Eddy: "All your concerned about is violent crime. We're concerned about other crimes and that's why when this Bill

was brought up a second time and it did receive 61 votes, there was still a lot of opposition to it because people are still concerned that when there is an application that someone has the duty to list what they have been involved in, that might include some nonviolent crimes."

Ford: "You know, this debate could go on forever because I believe some people believe that justice should be served in the State of Illinois and some people believe that justice shouldn't be served. I don't know what side you're on, but I know that everyone should have an opportunity to work. That's all. That's no disrespect to you, but I do believe that some people are shut out of the system called justice."

"Representative, I... I have no problem with someone being Eddy: employed that has committed a nonviolent crime if someone has paid their debt to society and they are filling out an application and they truthfully list those... those things in their past and can during an application process discuss those and talk about their past and obtain a job. You're absolutely wrong if you think I'm aga... I think that's great. What I have a problem with is that we are allowing through your legislation a very useful tool in employment in order to try and... and in the employment process settle questions. You're... you're just saying those questions can't be answered or asked. You're just saying they just I'11 can't be asked. tell you what, listen. Representative, I think this is dangerous legislation. think that the system should include allowing questions regarding embezzlement, felony drug possession and other

types of nonviolent crimes to be asked on an application. You don't think it should be. Okay. That's where we're at with this."

Ford: "Right."

Eddy: "Mr. Speaker, I would ask that there be a verification Roll Call if this Bill receives the requisite number."

Speaker Mautino: "Your request has been acknowledged."

Eddy: "Thank you."

Speaker Mautino: "It will be granted. The Gentleman from Jackson, Representative Bost."

Bost: "Thank you, Mr. Speaker. The previous speaker took care of one other thing that I was going to ask for, the verification, so as long as we've got that. Will the Sponsor yield?"

Speaker Mautino: "He indicates he will."

Bost: "Rep... Representative, do you... I have a concern going down the same line of questionings that Representative Eddy had. As we move forward and if no... drug... a drug offense is a nonviolent offense. Is that correct? A drug offense is a nonviolent offense?"

Ford: "Yes."

Bost: "Okay. And the question cannot be asked at a time when an ID... IDOT employee is trying to request driving a 10 thousand pound vehicle down the road and he may have plea bargained out on a few other offenses, but had never... but still got a drug offense and has a real drug problem. But there's nothing here that will allow him or force him to actually admit to that in the application now, right? Would that... that would be removed?"

Ford: "Well, you know, I think everything has been taken and blown out of proportion because if you, as an employer at the state, as an employer hires someone without doing a criminal background check, then that's the problem, not the fact that we have a question on the application."

Bost: "So... so, you believe that it is the responsibility of the state to make sure of that rather than also ask them straight out on an application where they can be honest and straightforward so that we can make sure that we have like a... a double check system. One, that the employee was honest in the first place in admitting that this... this offense had occurred and secondly, that then we do the background check, as well. I mean, I don't want to walk away from the obligation of the state, but I do believe that we have an obligation from the employee to be honest and straightforward or the person applying for the job. Do you know that if you lie on an application, we... it's automatic that you're not hired. So, now we're just saying, okay, fine, now we don't ... we're not even going to question you on that and that way you don't get in trouble the other way. Is that what we're trying to do here?"

Ford: "What I'm trying to do is get more people into an interview."

Bost: "If... if more people... if we get more people into situations where they... where it is a dangerous situation, driving up and down our highways with snowplows, with heavy equipment and those type things, that is a concern to me and I'm sure to my constituents, as a Legislator."

Ford: "How dangerous is an interview?"

Bost: "How dangerous is it that a person might have an opportun... might be... have a history..."

Ford: "You said the magic word, might. They might be considered for employment. They might be considered. That's what we want, the might."

Bost: "Okay. Well, might... make sure that we have every opportunity to see..."

Ford: "The best opportunity..."

Bost: "...if they... if they have violated those laws, it might make it dangerous for them to have that job and I think, in honesty, they should be straightforward in that application and the question should be asked. Now, let's go on to a different area. Let's talk about... and Roger Eddy brought this up as well... Representative Eddy brought this up... is... how about a county and someone has a white collar crime where they'd embezzled funds, maybe with a bank or they handled a... mishandled a management situation. So, do you not believe that maybe that's something that ought to be put on the application, as well?"

Ford: "First, they would have an interview and they would have a background check, but I'm glad you brought up white collar crimes because the state of our economy, federally and state, had nothing to do with the petty crimes that I'm talking about here. It has something to do with people that were not criminals."

Bost: "Thank... thank you."

Ford: "People that were not criminals."

Bost: "Mr. Speaker. Mr. Speaker, if I may."

Ford: "So, what we need to do is deal with what I'm dealing with here and it's a simple thing to ask that people in the State of Illinois not be denied their rights."

Bost: "Mr. Speaker."

Speaker Mautino: "Yes. The Gentleman..."

Bost: "Thank you. To the Bill."

Speaker Mautino: "To the Bill."

Bost: "I just... I had problems with the Bill since its first being presented and I... I... thank you for the opportunity to question."

Speaker Mautino: "Thank you. Representative Watson, for what reason do you rise?"

Watson: "Thank you, Mr. Speaker. I move the previous question."

Speaker Mautino: "The previous question has been moved.

Representative Ford to close."

Ford: "Well, thank you very much and I hope that this legislation will allow all of us an opportunity to... to vote for a piece of legislation that will put more people or at least give more people an opportunity to be interviewed for a job. This Bill is simple. We simply want people that may have been convicted of a crime when they were 18 years old, 19 years old and now they're 30 and they still can't get employment simply because they were... made a mistake in life."

Speaker Mautino: "Thank..."

Ford: "This Bill is simple. It simply asks that people have an opportunity to go for an interview and once again, it's not the question on an application that we have to worry about;

- it's the criminal background check that the state and employers should do to make sure that we hire the right person. So, with that, I ask for an 'aye' vote."
- Speaker Mautino: "Thank you. There has been a request for a verification on House Bill 65. And with that, the question is, 'Shall this Bill pass?' All in favor vote 'yes'; opposed vote 'no'. And the voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Mr. Clerk... Mr. Clerk, take the record. With 46 voting 'yes'... Excuse me. Of 43 voting 'yes', 68 voting 'no', 0 voting 'present', the Bill has failed. Representative Verschoore."
- Verschoore: "Thank you, Mr. Speaker. A notice of a reception tonight. The IBEW is having a reception from 5 to 9 at... or 5 'til whenever on the 29th floor of the Hilton. They wanted me to let everyone know they're... everyone's welcome and guests. Thank you."
- Speaker Mautino: "Representative Ford, for what reason are you requesting?"
- Ford: "Well, it's... I thought it was perfect, but it's an important Bill to come up on St. Patty's Day. I knew I would get all 'green' votes, but I just wanted to tell everyone that's Irish and everyone here, happy St. Patty's Day and what should I say, Irish forever. It is... Erin Go Bragh. Thank you very much."
- Speaker Mautino: "Thank you, Representative. It's now the… the Chair intends to move some Seconds to Thirds. Mr. Clerk, on page 47 of the Calendar appears House Bill 4047. What's the status of this Bill?"

This Bill, having received the Constitutional Majority, is hereby declared passed. Representative Jim Watson, for what purpose do you seek recognition, Representative?"
- Watson: "Yes, Mr. Speaker. Will you please excuse Representative Brady for the rest of the day?"
- Speaker Lyons: "The record will so reflect. Thank you,

 54 of the Calendar, you have House Bill 665. Read the

Speaker Lyons: "The Chair recognizes the Gentleman from Cook, Representative Marlow Colvin."

Colvin: "Thank you, Mr. Speaker, Ladies and Gentlemen of the I have for your consideration today House Bill 146. This Bill is an initiative of the Cook County Law Library System which is the second largest library system... law library system in the United States of America. But it's a Bill that impacts every law library in every court... Circuit Court system in the state. It simply allows county boards which is through permission of the county boards to raise the fees, the filing fees, that pay for the maintenance of county law libraries. The last time the fees were raised at the county law library in Cook was 1988. And it's an enormous burden on the county budget to fund those libraries in addition to everything else that they do. They primarily fund the county law libraries across the State of Illinois using these fees, these filing fees. testified in committee and the Bill is supported by the County Law Library Associations, Metro Counties, Illinois Association of County Board Members and Commissioners. There was no opposition in committee. I'd be happy to answer any questions."

Speaker Lyons: "Are there any questions? The Chair recognizes the Gentleman from Cook, Representative… from McHenry, Representative Jack Franks."

Franks: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Lyons: "Sponsor yields."

Franks: "Representative, we saw this Bill last year or something similar. What happened to it?"

- Colvin: "The Bill passed out of both... out of the House and the Senate. It went to the Governor where he vetoed the Bill. It actually and during the... the Bill wasn't called during the Veto Session as much... I think it was called in the Senate first where it originated last year. During one of the summer Veto, 'Veto' Sessions and then there was never a time that and I think a number of the individuals who voted for it was missing during that day, but you only get two more weeks to call it again and we didn't come back until November. So, the Bill eventually... it subsequently died."
- Franks: "You indicated that Cook County has the second largest law library in the nation. Do we know how many patrons use the law library? Do we have any figures?"
- Colvin: "I don't have them at my fingertips, but I understand that it is the most used, it's the second largest by volume, but it is the most used by virtue of the hours that it's open. I believe it's open from 9 a.m. to 9 p.m. and I think from 9 to 4 on Saturdays. But not only do lawyers use it as a free resource, but it's also an invaluable tool to law students who use the law library while they're matriculating through law school. And anyone who is... the library is open to the public, so anyone can come in and use any of its volumes at any time that the library is open."
- Franks: "Why... I know they have a good reputation and I know they do a lot of hours. I'm just wondering how many actual people really use it because if we pass this Bill, we'll be increasing the fees by almost 50 percent for the law

library, for these filing fees and it'll be over 50 percent by 2010."

Colvin: "Well, Representative Franks, I should point out that where you see the increases, the county... this just raises the threshold for them to raise the fees. This Bill, in no way does it stipulate that the fees will be set at these marks, that this is simply a ceiling in which they can raise the fees. So, in that regard, it is to say that they'll be raised by 50 percent is not true. I don't even think it's the... and I don't want to speak for the county... but and you can certainly speak to their lobbyist here, but I don't think it's their intention to raise the fees to these ceilings. What this does is create room for them to raise fees..."

Franks: "Let me ask you. Is Cook County at the ceiling, right now?"

Colvin: "They've been at the ceiling for more than 16 years."

Franks: "And we did this 20 years ago?"

Colvin: "That's about right."

Franks: "Okay. Do you know how many other counties are already at the ceiling?"

Colvin: "I do not know that but..."

Franks: "Inaudible."

Colvin: "...but given the testimony in committee when this Bill was heard, at least from the Metro Counties and the County Law Library Associations, I think all of them are suffering under the same pressure."

Franks: "Okay. To the Bill. And I appreciate what you're trying to do, Representative. Believe me, I know how

important it is to access to the courts and knowing what the... what the law is, whether you're an attorney or a layman. What I am concerned though about is the ability to raise these fees so high at a time when, quite frankly, a lot of folks aren't doing real well. And we had an unemployment rate now in the state is over 8 percent. know in Winnebago County it's over 12 percent. That scares me and I don't want to do anything that could impinge on access to our court system. And I think right now it's pretty expensive when you... when you file a lawsuit and then you have all these additional fees put on and it not only affects individuals, but also affects small businesses. So, as a result, I'm going to vote 'no' and I'm going to encourage people to study this to see if that's really the policy that we wish to have as a state is to increase these fees and potentially make it more difficult for people to access justice. So..."

Speaker Lyons: "The Chair recognizes the Gentleman from Crawford, Representative Roger Eddy."

Eddy: "Thank you, Mr. Speaker. Will the Sponsor yield for a question?"

Speaker Lyons: "Sponsor yields."

Eddy: "Representative, why can't Cook County on its own, without our vote and blessing on a fee increase for libraries, go ahead and increase the fee?"

Colvin: "Repeat that question again?"

Eddy: "Why... why can't Cook County, if they would like to increase the fee in a... in their library, the Cook County

Law Library, do that without the General Assembly acting at all?"

- Colvin: "I believe that this provision falls under the County Code and it requires... it specifically requires legislative approval to raise this specific fee. So, I believe that to be able to raise the ceiling for this, for the filing fees, is specifically part of the County Code which requires an Amendment in the County Code to do so."
- Eddy: "Is there not any type of a Home Rule provision that would allow them to do this without our action?"
- Colvin: "No, it would not. The Home Rule authority does not impact... would... does not give them the authority to arbitrarily raise this fee."
- Eddy: "Okay. So, this is... this is then necessary not to raise the fee, but to allow them to raise their own fee. Do you have any indication or have you had an indication from the county as to their intention to act on this flexibility?"
- Colvin: "In testimony in committee, the director of the county law library indicated the fact that these are ceilings and it is not the intention of the county and the other counties that were there that testified, it was not their intention to raise it to the ceiling, but to create some more breathing room in regards to the mounting pressures of running these law libraries. It's important to point out that we don't try to change it, I think, what the scope of these filing fees are. These are fees that are paid when lawyers file suit in different counties. It is, to raise the fees, what we're giving them is the authority to take a vote at the county board level to increase the fees. This

Bill, in and of itself, does not raise the filing fees of any county. If this Bill passes, county boards would then have them they would be given the authority to negotiate and discuss and vote on a potential fee increase for filing at... at the County Clerk's Office."

Eddy: "Representative, you're not saying, though, that this is only a fee increase on lawyers?"

Colvin: "I'm sorry?"

Eddy: "You're not saying that this is only a fee increase on lawyers?"

Colvin: "What I'm saying... No, that's not what I'm saying."

Eddy: "Okay, okay."

Colvin: "What I'm saying this is a filing fee at the current...

these are fees that are paid at the County Clerk's Office
in Circuit Court districts throughout the State of
Illinois."

Eddy: "Okay. So, the increase would be... well, it would be, if they choose to increase it, it could go from 13 dollars to as much as 18 dollars in '09. It could go up another dollar... the cap would go up another dollar in '010 to 19 and then up to 21 dollars in '011, but if they were to reach that cap, it would be only after they acted locally upon our authority to raise that cap."

Colvin: "That's exactly right."

Eddy: "All right. Well, thanks for the explanation on the Bill. I'm surprised they can't do this without us, but I'll take you at your word that they can't. Thank you."

Speaker Lyons: "The Gentleman from Lake, Representative Ed Sullivan."

Sullivan: "Thank you, Mr. Speaker. To the Bill. Ladies and Gentlemen, in the coming years it's going to be harder and harder for counties to provide basic necessity resources with the money that's going to be coming in. What we have before us is a user fee. People that will use the law library and filing these types of cases will be paying a fee. Now, we can choose to deny this Bill, thereby having less money for these services or the county could cut other services to pay for the law library. So, in my opinion, it's better for us to have the users fund these services than my property taxes funding these services or being taken from potentially a jail, the sheriffs, the roads, the human services. So, we have to make the hard choices and the hard choice... or the easy choice here is to have an increase of the user fee by which this Bill has been presented. I urge an 'aye' vote."

Speaker Lyons: "The Gentleman from Cook, Representative Lou Lang."

Lang: "Thank you, Mr. Speaker. I rise in support of the Gentleman's Bill. I have to say that I have been a person on the floor of this House that has been opposed to increases and costs at the courthouse. I think it has kept people out of the courthouse. I think it's been not good for litigants. I think it... anything that puts a burden on people that want to use our court facility is not a good program; however, the difference here is that the Gentleman isn't putting that burden on the court system, he's giving the county board the option of doing it themselves. Colvin: "They don't charge anything to use the law library unless you use one of the specific services like LexisNexus or... I'm not a lawyer, but I know there are several services like that."

Mulligan: "I thought you had to pay. I know if you go in at Old Orchard I thought there was a fee."

- Colvin: "That's incorrect information. If... anyone, any citizen can use the law library just as easy as you can use the law library... the regular library in your community."
- Mulligan: "Well, not every regular library has a law library.

 A few do, but not..."
- Colvin: "That's not what I said. I said they can use the regular public library as easy as they can use the county law library."
- Mulligan: "All right. But I don't know if that's true that the law libraries don't have a fee for you to use them. Are you sure?"

Colvin: "To enter into the law library?"

Mulligan: "Yes."

Colvin: "No, there is no fee."

Mulligan: "There's no fee. All right. So, it's only paid by plaintiffs."

- Colvin: "Those individuals who are filing suit in a particular county."
- Mulligan: "Can the county decide which plaintiffs' fees would be... say, you're filing a domestic violence complaint or something where the person that's filing it and is the plaintiff is not very wealthy. Could the county then decide which plaintiff fees would be charged as opposed to imposing it across the board on everybody?"
- Colvin: "Well, I can't speak for every county, but I do know in Cook County they have provisions for paupers, I believe that's the phrase they actually use. I couldn't tell... I don't have a list of what they charge for filing what types of lawsuits or what type of actions, but I do know that

part of that fee, just like another part of it is to maintain the courtrooms, part of that fee goes to maintaining those law libraries."

Mulligan: "All right. I'm just..."

Colvin: "But I can't give you a sheet with all the fees on it."

Mulligan: "Right. I have no problem because I think a good law library is important, but my problem is if plaintiffs who are poor and have a hard time filing a case were to be imposed. So, what I would like to see is that, if Cook County were to do this, they would be selective about leaving out people who were poor that were plaintiffs or..."

Colvin: "The county... the county... Cook County, which I can speak for specifically, already provides for pauper assistance when they are... as for specific types of suits that are filed in Cook County Circuit Court. I don't know what type of suits those are, but I know one for certain is the... for the lawsuits that are under a specific dollar amount, small claims court."

Mulligan: "All right. Thank you."

Speaker Lyons: "Representative Colvin to close."

Colvin: "And I should also point out, Representative Mulligan, that these are for civil cases. There will be no filing fee for an individual who is filing for an order of protection or what have you. Those require no filing fees at all. I would... All right."

Speaker Lyons: "Representative Colvin to close."

Colvin: "I do appreciate the comments. All of the comments on both sides of this discussion. I think Representative Franks, and to his point, I think tried to change literally

Every individual county this still does nothing more than give an individual county the authority to discuss, debate and determine what if any fee increases will be in their law libraries. Ι Sullivan Representative Lang hit the nail on the head in terms of what local control is and the proper application of a user These are fees that are paid in part, not the entire dollar amount, but in part, go to fund law libraries so that they maintain at least in Cook County, the second largest law library system in the country, to maintain the fact that anyone can use, lawyer or nonlawyer, can use the resources that those law libraries provide.
