Osterman: "Speaker Mad... or Speaker Miller, did I... Did I miss the pledge of allegiance today? Point of personal privilege. Most of the Democrats have a yellow piece of paper on their desk about a... a pension briefing today and my question is an inquiry of the Chair is that there were reports yesterday in Chicago media about a billion dollars that was earmarked for public transportation in northern region of Illinois. A billion dollars that we wanted and voted for many of us on this floor, because we expected it to start going for projects to fix transit now, not come November. So, my question, and maybe you know, is that, the individuals that are going to be there from the Governor's Office that are going to talk to us about pensions, are they going to talk to us about where the billion dollars is for public transportation? - Jefferson: "Thank you, Mr. Speaker. Point of personal privilege."

- Jefferson: "A follow up to what Representative Harris just said. Representative Collins is continuing to celebrate her birthday today. So, there is cake in the back office here for all who didn't participate yesterday, there's cake in the back today. Thank you."

- Cross: "Thank you, Mr. Speaker. On a procedural Motion and a hopefully I'll have an opportunity to makes some comments in support of my Motion, but under House Rule 18(g), I move for the discharge of: House Joint Resolution Constitutional Amendment #28, House Bill 4134, House Bill 3189, and Floor Amendment #1 to House Bill 3189 from the House Rules Committee. Under House Rule 54(a)(2), all Motions are assigned Standard Debate status, and I wish to debate my Motion. Upon the conclusion of this debate or the debate, I ask for a recorded vote on the Motion to Discharge. Under Rule 59... 49 any vote shall be by re... record vote whenever five Representatives shall so request, which they

Speaker Miller: "Representative Currie."

Currie: "Thank you, Speaker. I object to the Gentleman's Motion."

Speaker Miller: "The Gentleman from Kendall, Representative Cross."

Cross: "Well, Mr. Speaker, I guess that's not a shock. We have resigned ourselves to the fact that one person and one person only controls the State of Illinois's Government. One person on your side decides whether or not a Bill gets out of Rules. One person on your side of the aisle decides whether or not we can even have a vote on a Bill to discharge it from the Rules the Committee. In the age of lot of a discussion about reform, this particularly the Majority Party doesn't seem to get it. These items that are time... I'm talking about today deal with reform in the area of the budget and a lot has been going on in this state and a lot of discussion about how we're going to solve our 'budget problem'. I think everybody in this chamber knows that we have a budget problem because you and the Majority the last six years passed budgets that spent more money then we brought in. Almost \$6 billion of new spending with absolutely no regard to reform, absolutely no regard to streamlining, absolutely no regard to prioritizing and ultimately, we're here today with a huge problem. And so, we have three suggestions. That is a great idea. Thank you, Mr. Speaker.

entirely possible based on recent history you guys might even file these same Bills after we have a vote on them. Seems to be the thing that happened the other day on the pay raise Bill. But, Mr. Speaker, if we are going to have some real reform, and the Quinn Commission came out with some great ideas on ethics reform, these are some... these are some very good ideas on budget reform. One Bill we've filed is called PAYGO Mr. Speaker, and PAYGO is a concept. PAYGO relatively simple simply Representative or Senator, if you have a brand new idea that costs a dollar, we may like that idea and we may like the fact that it's going do some good things for the State of Illinois and we acknowledge it's going to cost a dollar, but if we pass that idea on, we need to take a dollar off the table somewhere else. I can... I can wait awhile, Mr. Speaker, I'm not going anywhere."

Speaker Miller: "Ladies and Gentleman, may we have a little order in the House here."

Cross: "Thank you. We think PAYGO deserves a hearing. If you want to vote it down, please do, if that's your choice, but at a minimum, it deserves to be heard in committee. The second idea, Mr. Speaker, says, very simply, let's form a sunshine commission. Auditor General Bill Holland came back to this chamber in 2007 and said at our request upon examination of all of the state agencies came back to this House with a report and said we would love to tell you what every state agency in Illinois does, but we can't. It's so convoluted, it's so layered, it's so complicated, it is impossible to tell you what our state agencies do. The

sunshine commission would put Republicans and Democrats, men and women, but most importantly, business people from around the state together to examine the budget to see where we can create better ways to do things, where we can eliminate duplication, where we can throw away agencies are obsolete, where we can take advantage of technology. So, sunshine commission, again, Mr. Speaker, makes a lot of sense in the world of budget reform. Joint Resolution or the Constitutional Amendment simply says, if you're going to pass a tax increase like the Governor has proposed and many of you have talked about, it's going to take three-fifths vote. If we're going to go to the taxpayers and take money from their pockets at a time of economic distress, when people are loosing jobs, when they can't make their mortgage payments, when gas is high, there ought to be three-fifths of the people of this chamber voting for a tax increase. It should not be a simple majority, it should be a difficult task. accordingly, we think the Constitution should be amended. So, Mr. Speaker, we think all three of these Bills or two Bills and one Constitutional Amendment need to be released from Rules. The idea, again, that one person in all of the State of Illinois can control whether or not a Bill gets heard is absolutely absurd. Even the Quinn Commission recognized that makes no sense, and if you haven't read the Commission's report, it said if there are 16 people that are Cosponsors on a Bill, it's got to be heard. novel concept, a Bill being heard. It's time to end one party or not I... or one party... one person telling the people

of the State of Illinois you can't have a concept heard. You can't even debate a Bill if one person in Illinois government, mainly the Speaker, says nope, not today, not if I say so. And accordingly, Mr. Speaker, I renew my Motion to Discharge the Bills. Thank you."

Speaker Miller: "The Gentleman's Motion fails. Leader Cross."

"If you are... first of all, are you going to give Cross: everybody an opportunity that wants to speak and debate the Motion? Mr. Speaker, at least... I know you're going to have one person kill the idea. We know you do that, but aren't you going to let the people speak on the Motion? Are we just going to eliminate debate now? People can't be heard? One person kills the Bill and now we can't even talk about And... I hope everybody's going to have a chance to talk, but if not... I'm going to... then we'll have problems if we don't get to talk. But I am going to move to appeal the ruling of the Chair. And after we have an opportunity to speak, I hope, Representative, or Mr. Speaker, you're going to allow us to talk. I think a few people out here have some opinions on whether or not these Bills ought to be heard. And I know, Mr. Speaker, you're familiar with Rule 54(a)(2) that allows debate. This seems pretty simple, either we get to talk about it or we don't. Are we going to be heard on this Motion, Mr. Speaker?"

Speaker Miller: "Leader Cross, your Motion has failed; however we will allow Representatives under the clock to discuss the issue. The Lady from DuPage, Representative Senger, seeks recognition. The Lady from Will, Representative

Tryon: "Mr. Speaker I would like to yield my time to Representative Black."

Speaker Miller: "The Gentleman from Vermilion, Representative Black seeks recognition."

"Mr. Speaker, in all due respect to you, this has not Black: been handled the way it's been handled for several years. I don't know what's going on here anymore. sickens me to see how you want to treat the Minority Party. If we did that to you, Sir, you would be outraged and justifiably so. And let me ask you another question. When Speaker Madigan comes out here and talks, the Chair makes certain that people are in their seat and that staff retires to the back of the chamber, and Speaker Madigan is given the respect that he is due as the Speaker of the When the House Republican Leader speaks, he House. deserves the same respect, and you didn't give him any. You didn't give him even the courtesy of telling staff to retire or telling your Members to sit down. It's an outrage how you treat us. I request a Republican Caucus immediately. Brady: "I'm sorry, Mr. Speaker, I... must have accidentally put my light on. I didn't ask to speak."

I understand you're going to, based on the Majority Leader's objection, that a I now... necessitate my need to a appeal the ruling of the Chair that you are denying the... based on her move, the denying discharge of those. So, I would appeal the ruling of the Chair that there's no recorded vote to discharge HJRCA28, HB4134, HB3189 and Floor Amendment #1 to HB3189 from the House Rules Committee. I don't think there was really any debate on the need to move those. I think we cut that short for, obviously, a variety of reasons, and I would hope that people would have an opportunity to speak on those, but at the appropriate time I would like a... the opportunity to vote on the a.m. the appeal of the Chair."

Thank you very much, Mr. Speaker and Ladies and Gentlemen of the House. I simply rise to support the House Republican Leader in his request. I believe in his original Motion to the Chair. He referenced House Rule 54, subsection (a)(2), that all such Motions would be assigned Standard Debate status and that he wished to debate that Now, he can, if he so desires, withdraw that Motion. Motion to debate, and I think he also asked upon conclusion of the debate he asked for a recorded vote on the Motion to Discharge. And pursuant to Rule 49, five Members on our side of the aisle have joined with him for that recorded vote on the Motion to Discharge and again, he can... he can waive that if he wants to, but he also asks for his rights under the House Rules, House Rule 57(a), if the Chair denies us as you indicated you had before we left you can go to your meeting and we to go to ours, then, obviously, Rule 57(a) would be the Motion that, a I believe, the House Republican Leader has made that we would appeal the ruling of the Chair if the House Republican Leader is not given the courtesy of ... of some debate and some action on his Motion. And I would hope that you not... you gave an indication before we left that you were not going to honor that request, and I... I hope that a... that decision has been discussed since all of us left the floor and then, in fact the House Republican Leader's Motion is in order. It has been done this way for a number of years. I trust that we will not change the way we do this at this particular time. So, I simply rise to support my Leader's request, which has been objected to under the Rules, and then he let you know

of what applicable rules we may or may not want to debate those Bills and, certainly, may ask for a Motion to over rule the Chair if that comes to that. So, I would simply rise to support Leader Cross's Motion. And, again, before we left, I would remind you we show Speaker Madigan full and complete and total respect when he's on this House Floor. We may ask him questions and we may not agree with an Amendment or a Bill, but we give him complete respect as is accorded his status as senior Member and is certainly accorded his status as the elected Speaker of the House. And I think we are not without some historical significance in the process to ask for the same courtesy anytime the House Republican Leader makes a Motion on this House Floor or chooses to speak on this House Floor."

Speaker Miller: "The Gentleman from Kane, Representative Schmitz, seeks recognition."

Schmitz: "Thank you, Speaker. Inquiry of the Chair."

Speaker Miller: "State your inquiry."

Schmitz: "Speaker, as you are well aware, these Bills are...
three Bills that were discussed earlier on the Motion are
currently in Rules. Do you know why they have not been
assigned out of Rules to a... a standing committee?"

Speaker Miller: "No, I don't. I do not know."

Schmitz: "Have you had the chance to become familiar with the three Bills that we're discussing here today, Mr. Speaker?"

Speaker Miller: "No, I have not."

Schmitz: "The reason I bring these points up, because these Bills aren't partisan, Speaker. They're in a committee right now that they couldn't be kicked out to another

committee, as far as I know, they could probably be copied into another Bill with a... with a Sponsor from the other side of the aisle tomorrow, and we would be debating these. But because we have a Republican Sponsor on these Bills, they will languish in Rules. The new day has come here in Illinois, the new dawn, all the sunshine, all the ethics, all the reforms; that was a lot of talk back in January, and I was actually hopeful that is was going to be more than talk, but as we stand here today in late April, getting ready for May and hopefully, adjourning at the end of the year, we have Bills languishing in committee that are as far from partisan as they can be. These are Bills that are going to bring sunshine to the process budgeting that every person in this chamber has talked about to their constituents. If you want to take our names off this Bill and put Democrat Sponsors on it, do it. let's get these Bills done, let's get them out of Rules, let's get them to a committee where we can debate it. if you want to take that a further step, think about all the time that we would save here on the House Floor if you would just look at the Bills on their merit and get them into a committee for a full debate. We wouldn't be playing these little games, should the Chair be sustained, should they not be sustained, do we have to worry about if this Bill is coming out Rules or not. Speaker, we know how to do this. We can get these Bills done, we can get them passed. These are good for the people that we represent, that's what we're sent here to do. I don't knock on doors every... every two years to get signatures to set on a ballot

These Bills that we're talking about are simple, they're no-brainers, they are a positive step to get us moving forward here in Illinois, Speaker. it's appalling that they're still sitting in Rulers... in I think it's appalling that we don't understand what's in these Bills when I ask what's in the Bills. don't know. Then let them out of Rules, let's get them into a committee, let's debate them. If they need Amendment, let's get them going. But let's stop this charade of double talk, holding out the press release and say, oh, we're for reform. We've got commissions on it, look at our commissions are meeting. We want sunshine in the budgeting an process. You know the sunshine that we're going to get in the budgeting process, I know how the sunshine's is going to be in the budgeting process, we're going to get that sun shiny, really smiley budget dropped on our desk at 10:00 at night, and we're going to vote on it at 11:30 at night. If anyone in here doubts it, let's lay the money down on the table right now and take a good bet. That's the sunshine that's been going on in this Capitol. I'm fed up with it. I've been here six terms. I take the same oath of office that every other Member in this chamber takes, I represent the same number of people. I want some

Let's get these Bills out now, let's debate them, get'em to committee. We'll... we'll waive the posting requirements, we'll get these things done. Speaker, these Bills are on your shoulders. These Bills don't move, nobody else in this chamber is to blame, Speaker. Have the courage. Let's talk about this, let's get them to committee, and for God's sakes, let's do the right thing."

Speaker Miller: "The Lady from Will, Representative Renée Kosel seeks recognition."

Kosel: "Yes, Mr. Speaker. Residents of this state have gone through some very, very hard times over the last year. They're dealing with mortgage crises, sky rocketing property tax, high prices for gasoline, groceries, and an unsteady economy that has caused many of them to lose their job, Mr. Speaker. At times, when things couldn't possibly get worse, we believe that the taxpayers are willing to make sacrifices over and make very difficult financial choices in their own homes. Republicans in this House have introduced several measures that are aimed at providing economic reforms, one of which is creating a sunset... shine commission as a tool to review State Government programs, eliminate waste and duplication. Before we turn to

taxpayers' pockets, we must reform and cut current programs and decide to make the hard choices within our own House as our constituents are doing everyday. I'm calling for this commonsense Bill, House Bill 4134, to be released from Rules. There is no reason why we can't start the process now, why we can't make the hard economic decisions now. Our constituents are making them every single day at the grocery store, at Penny's, at Sears. They are saying no, they are saying it's time to do the bare necessities. They don't care about this political maneuvering down here, they want their voices heard. They do not want one-man rule. I ask that these Bills be redo… reviewed… excuse me, released from Rules now."

Speaker Miller: "The Lady from Du Page, Representative Senger, seeks recognition."

"Thank you, Mr. Speaker. House Resolution 28 is Senger: basically asking for three-fifths supermajority on any tax increase. And think about that, think about that and what that means to everybody here in this room. Today, everyone knows our companies are concerned, they're concerned about what's going to happen to them and how they're going to compete. They're concerned about increases in taxes. Every single constituent in this state is concerned about what that's... what tax increases are going to mean from Springfield on them. They're not only concerned, but they're watching us, and they're watching us verv carefully. And don't think coming around the next election they're going be putting their two cents in regards to what we do here. This is a very basic simple policy already

initiated by 12 states, and all we're saying here is make a tax increase a nonpartisan issue where you got the supermajority now increasing it. I would think that everybody in this room would be comfortable with that and why we don't release this and get this out of committee to discuss it is way beyond me. I mean we cannot take raising taxes slightly and right now, the way we work here, that's exactly what we're doing, and if I was out there I would be watching this whole Body very closely in regards to what we're really truly doing in regard... to sunshining and exposing what Springfield is all about because we're going to get it with... without any say, whatsoever, if we're not careful. Thank you."

Speaker Miller: "The Gentleman from McHenry, Representative Try... Tryon, excuse me, seeks recognition."

Tryon: "Thank you, Mr. Speaker. You know in this package of Bills are several Bills that I think make good public policy for the state. House Bill 3189 for instance, the PAYGO Bill, simply involves COGFA in the budgeting prox... process, requires them to certify when we're expanding a program that there's revenue there to pay for it or there's a decrease in spending to pay for it. This deserves debate, especially at this time in our history, especially after what we've done in the last six years where we've expanded spending beyond our ability to pay. But because one person on the House Floor stands up and says they object to the fact that we can discharge this from Rules, that one voice outweighs the voice of 118 of us. And I ask you in the Majority to stand with the Minority and say, no more are we

going to empower one person over the whole chamber that we were sent here to represent. I think it's a travesty that we can't have open and honest discussion about a budgeting process and a change in public policy that would bring in the actual agency that we created to give us financial information. I think, at this point in time, it's a good idea to sit down together and look at where we're going when we expand the budget in the next four years. You see, because I think it's important to know, it isn't the under taxation in Illinois it's the over spending that created our problem when we looked to the east we looked to Indiana, they have a surplus. When we looked at Illinois, we're 11.6 billion in debt, because we didn't financially make decisions that were responsible that matched our So, when we look at House Bill 3189, all we're asking for is involve the people in the budgeting process that are giving the information to us to make decisions. We shouldn't throw that information in the trash barrel, we should use that information. We should have a vision for the State of Illinois's financial future for the next two or three years. We don't have anybody that has a vision, a strategic plan for where we need to be in 2012 and 2013. We just know we're \$11.6 billion in debt, and we're going to have to raise taxes to a... to balance the budget. the tax increase is on the table in front of us today in my district is \$1500 per household. And you know what, when you go home to your district and you ask your district if each of those households have another \$1500 to cough up and give to the State of Illinois for spending that we let run

out of control, they'll tell you no. So, if they tell you, no, we need a... a policy like House Bill 3189 that requires us to make cuts, set priorities, and look to the financial future and the security of Illinois's finances, because there's one thing I think Illinoians want and that's a financially sound State Government. I urge you to vote to override the Chair's ruling and move on to allowing us to debate good public policy when it comes to budgeting."

Speaker Miller: "The Gentleman from Vermilion, Representative Bill Black, seeks recognition."

"Thank you very much, Mr. Speaker and Ladies and Gentlemen of the House. I don't know when things began to change down here, I've got some idea's and I've... I've seen some changes that I haven't liked, tried to change those that I didn't like, I haven't been successful, successful in some, not in others. I... I would hope that all of us in this chamber would realize it's not important what we do here as individuals or even collectively, it's what we do individually and collectively in respecting the legislative process that makes this chamber work. When I came down here, this really was the people's chamber. We debated It was not almost every issue, sometimes for hours. unusual for those of you who have been here as long as I have, it was not unusual to come in here at 9:00 in the morning and adjourn at 3 or 4 or 5 in the morning the following day. But people had an opportunity to have their ideas debated the citizens that we represent had opportunity to have their grievances heard and... and it's a learning process, if you follow the legislative process.

I've brought legislation to this floor that I thought was well drafted and would do what I expected it to do and would help my district and help my constituents. After questions and debate, I often had to go back and amend the Bill, which didn't hurt my feelings, it made the Bill stronger. But we used to really be the people's chamber. Ideas were often debated here hour after hour after hour. Now, it seems all we want to do is to control the flow, control the time, and one Party will make basically all of the decisions. That be your wish, Majority rules, but that's not what this chamber is about, it's not what the people of the State of Illinois sent us here to do. would submit to you in January, I set on this House Floor and the Leader of the House, the Speaker, told all of us that all Bills would be assigned to substantive committee. Now, either he forgot that or he had no intention of keeping his word. And I've always found the Speaker to be a man of his word, but something went wrong. I read the Chicago Tribune the other day, and it said one of the things we must do to bring Illinois into the  $21^{ST}$  century is we must change the way we reapportion and redistrict the state. If... If memory serves me correctly, we're one of the only, if not the only, state in the country that draws something out of a hat. In other words, we use gambling and the winner, Republican or Democrat, takes all. they draw the map and the map isn't drawn based on communities of interest quite often or contiguous boundaries. It's... It's manipulated, both Parties have done it. I saw us do it in the early nineties, I've seen the

Democrats do it three times. The maps come out somewhat jerrymandered to where I had a district once where the middle of the street, one side of the street was in Mike Weaver's district, the other side of the street was in my district. There was an alley that divided this town, and I don't believe in 10 years former Representative Weaver and I knew for sure who... whose district the residences along that alley belonged to. The districts are drawn on a... according to political subdivisions. I filed a simple Amendment that would've addressed the Tribune's concern. It brings us in to what most states do, the Parties get x number of days, if they can't reach a map it goes to a nonpartisan committee, the census data is put into a computer, the computer draws the maps, that's it, that's the end of it. No drawing numbers from a crystal bowl, no from Abraham drawing numbers Lincoln's hat. That Constitutional Amendment was never assigned to substantive committee, never. That's in direct violation of what we were told. And I have other Constitutional Amendments and other legislation that have never been assigned to substantive committee. What recourse do I have or the constituents who send me down here have, except to ask me to discharge..."

Speaker Miller: "Representative, please bring your remarks to a close."

Black: "Well, I will I didn't realize we were on the timer, I...

I apologize, I will. I... I think it's already been said and

Representative Tryon said it. When we're told that all

something is wrong with this process. You should be as upset about that as I am. Because when you abuse the process, that knife cuts both ways. I've seen some of you incensed on your side of the aisle, because you couldn't get a Bill called, late in the session. I... I don't know what it's going to take, Mr. Speaker, and I apologize for going over my time, to get back to the legislative process that used to go on here and that I think all of us down deep think should go on here. We'll never get there if we continue this charade of all Bills will have a hearing, but that's not true. And so, the only recourse you give the Minority Party, and sometimes people on your side of the aisle as well, is to file a Motion to Discharge. It's not a gimmick, it's a cry in the wilderness, if you will, that we have an idea that we think is worthy of debate. If it isn't worthy of debate, it will get defeated in committee or it will get defeated on the House Floor. That's the way this process is supposed to work, not by having one person get up and say no, I don't know what your idea is, but I know I don't like, it and we're not going to hear it. That's wrong. That is not the principle on which this state was founded, it's not the principle on which this country was founded, and it's not the principle on which any of us run for election. God help you if you run on that principle, I will make the decisions. The least government is the best government, according to some people. And what is the least government? One person rule. It's not worked very well in the history of this world, it is not working well in this chamber, and I hope

for once we can just say, what damage does it do to hear an idea? And if the idea is well founded and well drafted and well presented, it might pass. And if it isn't, it may be defeated. That's the way this process, the thing that I hold most dear, the legislative process, that's the way it is supposed to work, and one of these days I hope you will let it work that way."

Speaker Miller: "The Lady from Cook, Representative Currie, seeks recognition."

"Thank you, Speaker and Members of the House. Currie: happy to report to the Members of this chamber that it does work. If you took a moment and checked your laptop, you would discover that House Bill 4134 was assigned to the House Executive Committee as per House Rules. If you check your laptop you will discover that House Bill 3189, also the subject of the Leader's Motion, not only was assigned to the Executive Committee, in fact, that Bill went as far as Second Reading. The Constitutional Amendment was not reported to a substantive committee, nothing in the House Rules require that it be. So, set your minds at rest, set yourselves at ease, the rules we adopted in January are working, they are effective. These Bills have gone back to the Rules Committee because all Bills do when we finish the deadline for House Bills in House Committee and House Bills on Third Reading. So, today, it's to late for these Bills, but why don't we proceed to the Motion on whether or not the Chair should be sustained. Thank you, Speaker and thank you Members."

- Cross: "Okay. The Bill we referred to as the sunshine committee... sunshine commission, 4134, that was, I'm told, assigned to a committee, Mr. Clerk. Can you tell us when it was posted for hearing and where it stands today?"

- Clerk Mahoney: "That Bill was assigned to the House Executive Committee on March 4."

Mr. Clerk, am I wrong on any of my characterizations of the status of these bills?"

- Cross: "Okay. So, they're all in Rules. So... someone on your side of the aisle just got up and told us these had been assigned to committee, but neglected to tell us they hadn't been posted and neglected to tell us they are back in Rules. The reality is, when you say you follow rules you really don't, you make up new rules as we go along and so... so nothing, absolutely nothing, gets filed rule wise around here when you don't want it to, and what we have in State Government now in the State of Illinois is one person, one person deciding whether or not a concept, an idea, a piece of legislation can get heard. It might die, it might not get the votes, it might not even get a Motion. That's

okay, that's the way life works, but to not let a Bill even get heard, a simple Bill, a Bill that says, let's do the budget a little different than the way we've done it. anybody in here thinks the way we've been doing the budget makes sense, you got a problem. We have a hole, we have about a 9, 10, 11 billion dollar hole because you have spent too much money. We've come up with a small suggestion, actually a pretty big suggestion, to do things a little differently, and you won't even let it get heard. And then you have the audacity, the audacity to try to spin this and outright basically lie, that this Bill got out. I guess it got out, but there was no chance it could get heard because it never got posted. How do you explain this to anybody in this state that you're not going to let a Bill be heard? This place is starting to be run no different than the Senate used to be run under the former President. It's the same way. And we used to criticize the State Senate for being run in a dictorial way. no difference right now. It is the exact same process. Mr. Speaker, I... I remove my... I renew my move to appeal the ruling of the Chair. I don't know if anybody else wants to talk on our side, but for anybody to stand up on your side of the aisle and suggest that these Bills had a... a fair hearing is just not... not telling the truth. This is not the first time that this has gone on. House Bill 2503 had a similar life. House Bill 3948 didn't have a chance to be heard on, and House Bill 365 didn't have a shot. HB 6733 didn't have a shot, HB 4438 didn't have a shot, and now, a series of Bills on a simple way to balance the budget

didn't have a shot. So, it is a... a sad way to run government, it's a sad day to mislead the people of the State of Illinois and tell them one thing when, in reality it didn't happen and then to not even let us have a vote on a Bill. Speaker Miller: "The Gentleman from Bond, Representative Stephens, seeks recognition."

Stephens: "Well, Mr. Speaker, we've got all sorts of topics going here, but I... I would be remiss if I didn't respond to the Lady from Cook, having a great deal of fun at hope... that I think her hope was that that was at our expense, those of us on this side of the aisle. One Arlen Specter, who was about to be thrown on the trash heap of the Republican Party because we were sick of him, sick of him. He was going to be defeated in a primary, and now you can have him. You know, you've taken some of our other trash, you can have Arlen Specter, too."

Speaker Miller: "The Gentleman from Winnebago, Representative Sacia, seeks recognition."

Sacia: "Thank you, Mr. Speaker. The previous Gentleman spoke to an issue that I had wished to speak to as well, but we got on a different subject. The good Senator came to Chicago a short week ago as a Republican, and solicited and received large sums of money from Republicans, obviously not all real... You just have to ask yourself what the man was thinking. How disingenuous can you be, from getting money from one party and then jumping ship? That is about

Just... just a measure of order. tell you why things used to be different down here. used to be dozens and dozens of news bureaus newspapers all around the state. The newspaper business isn't what it used to be, and that's no longer the case. There used to be a dozen radio stations and four or five television stations, that's no longer the case. couldn't get away with some of the stuff back then that you get away with today, but to stand on this House Floor and say that Bills get a fair hearing, I hope there's no electric lightening in the air, because somebody's going to get hit by lightening if there is. I go to committee as a senior Member of this House, and I am told by a Democrat staff person, your Bill will not be called. Why? Because that's my orders. Your Bill will not be called. Is there something I can do to get my Bill called? No. So, don't tell me about Bills that get called. We go to committee all the time, and we're told, your Bill cannot and will not be called. And I... in all due respect to those of you on your side of the aisle and those on my side of the aisle, what in the good grief difference does it make who changes Parties? I was here when a Member of your Party came over to my side of the aisle. Whoop de do. He had his reasons.

He served in the White House as the chairman of Bill Clinton's Committee on Human Relations for six years. was the reason... one of the reasons we did this Resolution 103rd anniversary of today is celebrating the fraternity where Doctor John Hope Franklin was initiated in 1933 at Alpha Chi Chapter at Fisk University in Tennessee. His works will last long beyond his 91 years on God's I thank for his insight how he expanded discussion on race in our country and he'll always be remembered as an individual who has helped us heal, moving forward into the 21<sup>st</sup> century. Thank you, Mr. Speaker. And at the appropriate time, I move for the adoption of the Resolution."

So, he, as all of our Alpha Phi Alpha brothers do when they pass away, enter an Omega Chapter on March 25, of a last month and thank you for your time and your recognition of this great American."

Davis, Monique: "Thank you, Mr. Chairman. Doctor John Hope Franklin was a historian loved and admired by many Americans both black, white or Latino. People recognized that the history of America cannot be told unless you include the history of the African Americans in America and prior to their coming. Doctor John Hope Franklin has left a legacy that requires and requests that Black History

Resolution would allow that waiver for the four school districts, Rock Island School District 41, Reavis Township High School District 220, Lyons Township School District... High School, district 204 and Moline School District 40 for one year only, and, again, we're hoping that the Secretary of State's Office will come to an agreement on this issue regarding driver simulators for drivers ed. And then in addition, this Resolution approves the driver education fee increase for Waukegan Community Unit School District 60 at \$350. And with that, Mr. Speaker, I believe those are the... the main details of this Resolution. I'd be happy to a try to answer any questions."

Speaker Miller: "The Gentleman from Jackson, for what...

Representative Bost, for what purpose do you seek recognition?"

Bost: "Thank you, Mr. Speaker. Just a inqui... inquiry... well will the Sponsor yield?"

- Smith: "Yes, but if you would vote 'no', then essentially you would be allowing a bunch of driver education fee increases."

Franks: "Wow."

Smith: "Twenty-nine of them in total."

Franks: "This reminds me of the scene in <u>The Princess Bride</u>.

Remember that, when they... when they were having the battle

of wits and determine which one had the poison and which one he had to drink, but the one guy had immunity to the poison, so they both... he put poison in both. That's how I think this Bill is written. So, I know it's not your fault, but I hope we can change this..."

Smith: "It's not a perfect process, in my opinion. It's a flawed precess. The one thing that is... has been approved this year is that we we're able to come to an agreement with the Senate and at least deny those that we felt were the most egregious."

Franks: "All right. Thanks."

Speaker Miller: "The Gentleman from Crawford, Representative Eddy, for what purpose do you seek recognition?"

Eddy: "Thank you, Speaker. I wanted to just make sure that there was... there was a statement made about a 20 percent increase, that was an administrative cost cap increase that Representative Franks was referring to.
