Speaker Mautino: "Representative Franks on Floor Amendment #2 to House Bill 2516."

Franks: "I believe this was a minor technical matter that was popped right to the floor. I'd be happy to answer the questions, but I don't... I think it was just technical."

Speaker Mautino: "The Gentleman has moved adoption of Floor Amendment #2 to House Bill 2516. And on that, the Gentleman from Vermilion, Representative Black."

Black: "Thank you, Mr. Speaker. The Sponsor yield?"

Speaker Mautino: "Indicates that he will."

Black: "Representative, I didn't hear you. I thought you said this was a technical Amendment and in fact, Floor Amendment #2 is a rewrite."

Franks: "Yeah. I just found..."

Black: "It becomes the Bill, correct?"

Franks: "Correct. I think what we did we just changed one thing. Even though it's a gut and replace, it was a minor technical change on what we were doing. It was clarifying some language."

Black: "What... How is this Bill limited? Is it any county or specified counties be able to opt out of a mass transit district?"

Franks: "Well, it's not opting out of the mass transit district. What this would do is a county may opt out only of the portion of the RTA. So, it'd just be those counties that deal with RTA. Just the additional tax increase that we did last year that's for projects specifically within the county. And the genesis is oftentimes we don't have mechanisms for government to stop levying when they no

longer need the funds or don't want the funds. And one example we could use would be like if we had a TB sanitarium that wouldn't be necessary to continue to tax for that. So, if a county ever, in its wisdom, wants to stop levying additional taxes on its citizens, it would have a mechanism to do so. It just... and then it would... would only be for things within the county what that tax was used for. I just wanted to... We always seem here in Springfield to find ways to tax counties, but we never give them an opportunity to stop if they so choose."

Black: "All right. I assume if they were able to... Well, I know, I'm not going to assume anything. How do you... how do they opt out of... of the..."

Franks: "Well, this..."

Black: "...from the portion of the tax?"

Franks: "Well, this one was..."

Black: "By resolution of the county board or by referenda.

How... how... who makes that decision?"

Franks: "It would be... it would be by the county board. And this... and the reason this Bill came... And this is the first time that I know and maybe you have more institutional memory on this, but this is the first time that I'm aware that a county ever had a tax imposed on them without any say. This is one where additional sales tax are done with the county and at least, my county never even asked for it. So, I presume they want those funds because I think they're using them, but that may change sometime and that's why I just want them to have that ability, if they ever choose to in..."

Black: "Okay."

Franks: "...in the future to get out and they would be able to do so by a resolution of the county board."

Black: "Then I would assume that if you opt out of a portion of a tax for mass transit, you could not reasonably then expect to get enhanced service, could you?"

Franks: "No. This would just be for additional projects, because what we did I think when we raised the taxes... we raised the sales tax... and they were able to use..."

Black: "Additional projects, for example, if it's rail..."

Franks: "No..."

Black: "...the rail line wouldn't go through or..."

Franks: "No, not at all. We're talking about additional projects, 'cause they'd have extra money. So, let's, for instance, they bought, I don't know, some piece of equipment or something. Black: "It's... it's my understanding from staff, correct me if I'm wrong, that you had an agreement with the City of Chicago to further amend the Bill."

Black: "It should be Floor Amendment #3. I think the city wanted you to clarify that the Bill will not apply to any other tax than the mass transit portion."
