This breach of rules should be corrected immediately with a Roll Call vote on my Motion to Discharge. As we know, once every 10 years following the census our legislative boundaries must be redrawn. have said, we've even taken action 2 years ago to recognize the system is flawed and that it allows the law... lawmakers to draw their own boundary lines. In work that's been done in testimony that's subsequently, been given hearings, there's been a lot of points been brought up. The Fair Map Amendment which is embodied in HJRCA 56 would take that act of drawing the lines out of the hands of the Legislature. This is a timely Motion because the deadline for doing a Constitutional Amendment is barely two and half weeks away. We know what the number of readings and the committee hearings that would need to be have, this Bill needs to get a hearing. I also understand the Senate Democrats have put forward a Bill that has been sent over to this chamber; it's already gone through First Reading. And while there are some positive aspects to that plan, like the transparency procedures certainly well worth looking into, I have to say that that takes us a step backward 'cause it would give the Legislature not one, but two shots at drawing those boundaries. That's a step backwards from where we are which has the Legislature have one shot at it before it moves to a commission process. The Fair Map Amendment, on the other hand, provides for

public input from the outset throughout the process. It's been crafted by a lot of good government groups, Illinois League of Women Voters and the Illinois Reform Commission just to name a couple. And I agree with the Daily Herald, that if we don't act on a Fair Amendment, this is going to be another missed opportunity for reform that this state desperately needs. Mr. Speaker, would you please allow this proposed Amendment HJRCA 56 out of Rules so that when return home to our districts we can tell constituents that we have done real and honest reform. Speaker, under House Rule 57(a) I move to appeal the ruling of the Chair that there be no recorded vote to discharge HJRCA 56 from the House Rules Committee."

Speaker Lang: "The Gentleman moves to appeal the ruling of the Chair. The question will be, 'Shall the Chair be sustained?' And on that question, the Chair recognizes Representative Black."

"I... I appreciate this opportunity to call on my Tryon: colleagues in this chamber to support the releasing this Bill from Rules. There's no process in the next two years that were going to find ourselves in that isn't anymore important than reapportionment. And it's important that we do it the right way, we do it a fair way, we do it an open way. And since we've had this in our Constitution, it has been done in controversial ways. And the problem that we have now is the process that we use, let's call it what it is, it's an incumbent protection plan. And now we have a citizens group that's out engaged seeking for placing a question on the ballot to amend our Constitution. have a process called the Fair Map Amendment that brings citizens to the table. They'll be able to reapportion our districts based upon demographics and census information in a... in a fair nonpartisan way. And now we got the Senate Democrats. They engage and they have a plan called the citizens first plan and they want to do it by taking our process now and unnesting our Senate and House districts in and actually making it even more of an incumbent protection plan. So, now we have what the process we have now regular incumbent protection plan and their citizen first is really more of a incumbent protection plan on steroids. It really is something that I think we need a full debate on. And we should be able to do that in this chamber. And we... and we should look at all the groups that are calling for reforms on our... on our reapportionment process and we should take to heart what they want to see done. We can do this right. We can't stand here and vote for half a loaf on things like

campaign finance reform that empowers political bosses and caucus Leaders and then come back and not look at what citizens want to do in the process for reapportionment. I urge you to support releasing this from the Rules Committee, have a fair debate on it. What's wrong with having a debate on something as important as reapportionment of our legislative districts. Speaker Lang: "Mr. Tryon, your time has expired."

Tryon: "...support me and vote to override the ruling... override the Speaker and discharge this from the Rules Committee."

Speaker Lang: "Mr. Rose."

"Thank you, Mr. Speaker. First of all, can I get a little order in the chamber? To the Motion, Mr. Speaker. This week you read the editorials around the state. Daily Herald said of the plan that passed the Senate drawn by the Senate Democrats, 'People aren't stupid', direct quote. My own local paper that I share with Representative Jakobsson, Representative Cultra, Representative Black The News Gazette said 'the politicians in Springfield are trying to pull another fast one', 'the Amendment is a deliberate sham.' That's actually two quotes to be completely clear. The Amendment is a deliberate, sham. Why? Why's it a sham? Because there's only one Bill out there, only one Constitutional Amendment out there, that actually removes the ability to draw districts, takes it out of our hands and puts it back in the hands of the people of the State of Illinois. There's only one Amendment, it's the Fair Map Amendment. It's not the one

- Speaker Lang: "The Gentleman makes a Motion. And the question will be. 'Shall the Chair be sustained?' And on that question, we'll hear from Mr. Eddy."
- Eddy: "Thank you, Mr. Speaker. House Bill 5008 is a tremendously important Bill to the… the people of the State of Illinois in that last year we left some very serious unfinished business when campaign finance reform was a passed in this chamber. In fact, if you remember, the… the good government groups at that time said that the measure was inadequate and that they would be ready to revisit

that. We are ready at this time to revisit that. On Monday the Chicago Sun-Times was correct when they editorialized about the need for us to finish the job on campaign finance You know, it's time now with the sun shining outside and a fresh start spring to roll up our sleeves and get to the task at hand and give the taxpayers of this state what they want, campaign finance reform that goes all Everyone knows that what we did last year regarding campaign finance reform was nothing more than a Let's be honest, limitl... limitless cash small step. supplies to individuals who control the legislation, that combination of power to control the flow of legil... legislation along with the capability of taking from special interest groups unlimited amounts of cash, creates at least the perception in the public that Illinois is bought and paid for and pay-to-play is still alive. people of this state want a clean break from the Rod Blagojevich era and we do not have that clean break as long as individuals in positions of power are able to take unlimited campaign contributions. Ladies and Gentlemen of the House, please vote with me to override the Chair and debate this important Bill immediately."

Speaker Lang: "Mr. Sullivan for two minutes."

Sullivan: "Thank you, Mr. Speaker. Ladies and Gentlemen. We have a lack of trust with the people in this chamber and they're starting to get it a little bit. They're starting to not see their paychecks, they're starting to see their services not arrive that they've been entitled to. And they're starting to see where it's... where... where the

problem lies. Your side of the aisle, at some point, needs to wake up. You need to wake up and not follow your Leader blindlessly into the abyss. We started campaign finance reform last year and some of it was very good and some of it was terribly bad. We have a Bill before us that we can bring out to fix the problems of last year by empowering your Leadership, empowering our Leadership where shouldn't have the power we should have the power in our hands and in the people's hands, not in our Leaderships hands. I don't know where the ... where the problem lies. Maybe it's in the Rules Committee. But at some point you need to wake up and you need to not follow your Leader. We need to pass this Bill or a Bill that Karen May has that basically does the same thing. Please vote to override the Chair."

Speaker Lang: "Representative Tracy for two minutes."

Tracy: "Thank you, Mr. Speaker. I, too, rise in support of hearing House Bill 5008 that goes a bit further than our prior campaign reform measurement that we passed. been asked why would this Bill that we passed pertain only Leadership contributions to campaigns during Primaries? Perhaps it was an omission that we did not include the general campaigns as part of that financing reform. And Ι would suggest that this Bill Representative May's Bill it doesn't matter to the House Republicans which Bill gets brought forward, but it does matter to us that this very important issue to the State of Illinois and our constituents and the people who are counting on us to work towards real reform this year, that

we hear a Bill that goes further, that puts caps on Leader contributions in the general campaigns so that every Illinoisan has a fair chance to run for membership in this chamber. So, again, I would ask that this motion be put forth. Thank you."

Speaker Lang: "Mr. Eddy to close."

Eddy: "Thank you, Speaker. Ladies and Gentlemen of the House, I want to go back to what the Motion is before you. Motion before you is not necessarily a vote on campaign finance reform, it is a Motion to debate a Bill that includes campaign contribution limits on Leaders. Motion would simply allow you the opportunity and many of you are cosponsors of measures that actually do exactly what this Bill does. You're cosponsors of the Bill. wouldn't you vote in favor of getting the Bill out of Rules Committee so that you can actually vote on a Bill that you cosponsor? Are you for the Bill? If you're for the Bill, you better vote to override the Chair so you can vote on a Bill that you supposedly support. Do you support the Bill? If you support the concept and you support the Bill of campaign contributions limits for Leaders, vote to override the Chair. Vote for an opportunity to vote for something that you sponsor."

Speaker Lang: "The question is, 'Shall the Chair be sustained?'

Those in favor vote 'yes'; those opposed vote 'no'. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Representative Mell.

Mr. Clerk, please take the record. On this question, there

are 64 voting 'yes' and 48 voting 'no'. And the Chair is sustained. The Chair recognizes Representative Black."

Black: "Thank you very much, Mr. Speaker. I have filed the requisite Motion in Writing and it is in the well. I rise to a point of order. Under House Rule 18(g) I move the discharge of House Bill 6200 from the House Rules Committee. Under the applicable House Rule 54(a), Section 2 all Motions will be assigned Standard Debate status. I do wish to debate my Motion. Upon the conclusion of the debate, I ask for a recorded vote on the Motion to Discharge. Under rule 49 Article IV, Section 8(c) of the Illinois Constitution any vote shall be by a record vote whenever 5 Representatives shall so request. I'm joined by at least 5 Members on my side of the aisle that wish for a recorded vote on the Motion to Discharge House Bill 6200 from the House Rules Committee."

Speaker Lang: "The Chair recognizes Representative Currie."

Currie: "Thank you very much. I appreciate the opportunity once again to object to the Motion."

Speaker Lang: "The Lady objects to the motion. Under the House Rules, it requires unanimous consent. With the Lady's objection, the Motion is defeated. Mr. Black."

Black: "Thank... thank you very much, Mr... Mr. Speaker. This continued breach of the House Rules can be corrected immediately with a Roll Call on my Motion to Discharge. However, you have denied that by the imposition of one person objecting on behalf of 118 Members in this chamber. Mr. Speaker, under House Rule 57(a) I move to appeal the ruling of the Chair that there be no recorded vote to

discharge House Bill 6200 from the House Rules Committee. And desire to debate my Motion to appeal the ruling of the Chair."

Speaker Lang: "The Gentleman moves to appeal the ruling of the Chair. The question will be, 'Shall the Chair be sustained?' On this question, the Chair recognizes Minority Leader Cross for two minutes."

"Thank you, Mr. Speaker. I... it's kind of a fascinating Cross: We actually decided that maybe our Bills weren't gett... getting called because they're Republicans Bills. We found a Bill sponsored by a Democrat, Representative May, a Bill that does not everything we would like in the area of campaign finance, but goes to really the essence of what we've been talking about the fact that we've regulated everybody else in this state, businesses, labor, individual citizens, except the one entity we have not regulated and not controlled the flow of money as to the Legislative Leaders. A Democrat sponsored Bill to clean up, provide a whole loaf, if you will, on campaign finance reform. A Democrat sponsored Bill and you will not even let a Democrat sponsored Bill be heard in committee. Wow. one thing to shut us up, but to say to your own Member who, I would think if she cared about campaign finance and actually believes in the Bill, would stand up and support us in this Motion. If she truly believes what she says in filing a Bill on campaign finance would get up and say, you know what, the Speaker's wrong. The Speaker's wrong to worry about only preserving power, centralizing power, not regulating ourselves and I am going to stand up and fight

for the Bill I filed. I don't see that happening. I don't see... I don't see those of you on your side of the aisle whether it was on recall, redistricting, campaign finance, Primary dates saying, I'm with you. Because I would bet you that everyone of you whether you're answering a survey, talking..."

Speaker Lang: "Mr. Cross, please bring your comments to a close, Sir."

"...talking to the media, talking to a friend at church, Cross: talking to a constituent at the door, that place Springfield's out of control. I know embarrassment, I know we're on late night talk shows, I know people around the country, if not the world, think we're a disgrace. And I'm going to do something about it. I am tired of what's going on in the State of Illinois and I'm going to file Bills and vote for changing Illinois government. Here's your opportunity. Here's your opportunity. One guy controls all of Illinois government, it's the Speaker of the House, let's not kid ourselves. One man, one man says it ain't going to happen. One man who's been here for 40 years says, I don't like that so I'm not even going to let you vote on it. I'm not even going to let a Democrat have her vote on a Bill. Now, you tell everybody that you're for this stuff. I'm looking at the Daily Herald today, you apparently all filled out a survey, said you were for changing the way we were doing redistricting, said you were for changing in the way we do it where legislative Members draw their own boundaries. Wow, a novel concept, taking it out of the hands of

Legislators. You said, I'm for changing that. A few minutes ago you all voted in the exact opposite way. Representative Franks, you're of the most vocal proponents of changing the way we do business in Springfield, but yet the opportunity presented itself today on campaign finance and on redistricting and you failed the people of your district in this state by voting with the one man who controls Illinois government. If you really don't believe what you tell newspapers or your constituents or your friends or your families, then you oughta quit saying it. We are a disgrace. We have a financial picture that is as worse as it could be. And we have an ethics issue in this state that is as bad as it can be and we are not willing to break from the past. We're going to continue the status quo, we are going to do nothing to better our image, we are going to let one man control what goes on in this state. That's unacceptable. And you guys on your side of the aisle need to start being honest with your constituents and with the people of this state and vote with them, not with the one person that controls everything that happens politically and governmentally in the State of Illinois. Stand up and do what's right. The person whose Bill we're talking about today should at least have the courage to vote with us and stand up and say, I'm for campaign finance, the whole loaf, nothing but the whole loaf and I'm going to do that by standing up today and fighting for my Bill. Thank you, Mr. Speaker."

Speaker Lang: "Mr. Black to close. The timer is on, Mr. Black, please close."

Black: "Thank you, Mr. Speaker. Did you take the time off of the applause from my time?"

Speaker Lang: "I'm sorry. I did not, Sir, please proceed."

Black: "Thank you very much. Ladies and Gentlemen of the House, I don't know how many of you stayed in your districts over spring break, I did. My wife and I went out last Sunday and passed petitions from the Vermilion County Farm Bureau for the redistricting, the Fair Map Amendment. The easiest petition I've ever circulated. Thirty sheets in a very short period of time. You better pay attention to what's going on out there in the real world. There's an Amendment being circulated by John Bambenek called the Put-Back Amendment there are other Amendments out there..."

Speaker Lang: "Mr. Black, please take an additional minute to complete your remarks."

Black: "Thank you, Sir. You may think that you can do this and they'll be no price to pay. I can tell you the citizenry of this state are as upset as I've ever seen them and thank goodness for that. They're demanding change. If you won't do it, they're going to do it. You know Karen May's Bill, 6200, just takes... just look at what it does. The Legislative Leader Caucus or political Party no limits, no limits on the General Election: a million, ten million, a billion. She puts down reasonable limits higher than... than our Bill: three hundred thousand for statewide candidate, a hundred and seventy-five thousand for a Senate candidate, a hundred and twenty-five thousand dollars for a House and others, eighty-five thousand dollars for certain other county wide offices. It's still a lot of money, but to go

from no limit to reasonable limits, it's time. You better get out your Bob Dylan song book and you better go over the lyrics to The Times They Are A-Changin'..."

Speaker Lang: "The question is, 'Shall the Chair be sustained?'

Those in favor vote 'yes'; those opposed 'no'. The voting is open. Have all voted who wish? Have all voted who wish? Mr. Clerk, please take the record. On this question, there are 65 voting 'yes', 47 voting 'no'. And the Chair is sustained. Mr. Clerk, the Adjournment Resolution."

Clerk Mahoney: "Senate Joint Resolution 123.

RESOLVED, BY THE SENATE OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that when the two Houses adjourn on Thursday, April 15, 2010, the Senate stands adjourned until Tuesday, April 20, 2010 at 12:00 noon, or until the call of the President; and the House of Representatives stands adjourned until Tuesday, April 20, 2010 at 12:30 p.m., or until the call of the Speaker."

Speaker Lang: "Before... before we proceed, the Chair recognizes Representative Turner for an announcement."

Turner: "Thank you, Mr. Speaker and Ladies and Gentlemen of the House. On Wednesday of next week the House... the annual House-Senate softball game will take place. And I'd like to remind the Members that are interested in playing in the game that they should bring down their gear. We'll have practice on Tuesday night of next week. So, the annual game is Wednesday, practice will be next Tuesday for anyone that wants to play. Thank you."

Speaker Lang: "Representative Currie now moves for the adoption of the Adjournment Resolution. Those in favor say 'yes'; those opposed 'no'. In the opinion of the Chair, the 'ayes' have it. And the Adjournment Resolution is adopted. The Chair recognizes Representative Burns."

Burns: "Thank you very much, Mr. Speaker. I rise on a point of personal privilege."

Speaker Lang: "Please state your point."

Burns: "With us in the gallery today is the noble network of charter schools, Michael Milkey who is a CEO and the staff and students are here visiting Springfield, if they could stand and be welcomed to Springfield."

Speaker Lang: "The Chair recognizes Representative McAuliffe."

McAuliffe: "Point of personal privilege."

Speaker Lang: "Please state your point."

McAuliffe: "Today we'd like to wish Ron Wait a happy birthday.

I think there was a cake, but I think somebody ate it all already. Thank you. Happy birthday to Ron Wait."

Speaker Lang: "The Chair recognizes Representative Black."

Black: "Thank you very much, Mr. Speaker. I rise to a point of personal privilege and the challenge if I might to all of the Members of the House. This Session today was a complete waste of time and money to the taxpayers of Illinois. Now, I know we're not getting paid per diem anyway and you may never get paid, which is fine with me, but, I assume at some point they'll try to make up the days... the per diem days that we haven't been paid. And we sure earned our money today. I hate this beard. I'll shave half of it off, if you just let us... Mr. Speaker, if

you just let us discuss the budget on the House Floor for a half an hour I'll shave half of it off. If you let us discuss the budget crisis for one hour, which we could do this afternoon, to see where we... if we could agree on cuts, if we could agree on what needs to be restored. Be put together in somebody's backroom, thrown on your desk on May the 7th given an hour to vote on it, nobody will know what's in it, probably a six month budget, maybe a nine month budget. My state's attorney hasn't been paid in two months, my public defender hasn't been paid in two months, the probation officers in Vermilion County haven't been paid in two months. How much longer do you think the criminal justice system will work in your counties as well They'll start to shut down on your as mine? It won't. Maybe next week we can talk about the budget a watch. little bit, Mr. Speaker. I know you'd love to do that, so would I. What a waste of time. We ought to be in embarrassed. And since this is live on the Internet, maybe we will eventually be embarrassed at what little we do for how much the taxpayers pay us."

Speaker Lang: "And now the Adjournment Resolution having been adopted, allowing perfunctory time for the Clerk, the House do stand adjourned until Tuesday, April 20 at 12:30 p.m.. The House stands adjourned."
