After boot camp, he was assigned to the heavy cruiser the USS Houston. Shortly after arrived on the ship, Houston was operating in the Pacific Ocean, engaged in several battles with the Japanese Imperial Navy. On February 28, 1942, the Battle of Sundra Strait began. In the early hours of March the first, Houston was struck three times by torpedoes, rolled over and sank. Of 1,061 soldiers and Marines aboard, 693 were lost. Ingram and 368 sailors abandoned the ship into the Pacific Ocean. And spending a day in the water, the Japanese patrol picked up... picked him up. Once they found out he didn't

have any information, interrogated him, they threw him back in the water. The next day, 24 hours later, a fishing boat picked up our... our friend and not sure where to go, they took him to land and they seen... seen a Red Cross flag. They received medical attention, clothing, and then during the night, the Japs come in and took them as prisoners of war. For the next three years, he was a... he and his fellow POWs were forced to work in construction on the Tai-Burma railroad. After the World War II ended, they were still working on that railroad for the three years. After the war, he remained in the Navy and was promoted to rank of Chief Petty Officer. He remained in the Navy and retired in 1961, after retiring to Jacksonville, Florida, where he lives today. So, Ladies and Gentlemen of the House, on June 13 of this year, Mr. Ingram will be celebrating his 90th birthday. Please join me in thanking him for his service to the country and for a happy birthday."
