As I traveled out of Selma, Alabama, on my way

home with my family, I stopped at the gravesite of a young woman named Viola Liuzzo. And if you don't know her name, I hope that you will take the moment and look her up. And at the conclusion of Dr. King's monumental speech in Montgomery, Alabama, she began to transport people, the marchers, back to Selma and along that route between Selma and Montgomery, a member of the Ku Klux Klan shot and killed Viola Liuzzo. And Viola, I... may peace and blessings be upon her. Viola and her children, of course, gave us great sacrifice for this country and her memorial stands as a sign for all of us to remember the sacrifices that were given and the lives that were lost, so that people could participate in this country's most fundamental right, and that is the right to vote. What we did years ago is extend the statute of limitations for a sexual assault crimes if DNA evidence were discovered lately... or later after the 3-year statute of limitations; it was extended to 10. This Bill simply allows prosecution for serious crimes that are committed after the statute of limitation expires that are committed in conjunction with a sexual assault. Those crimes include aggravated kidnapping, armed robbery, home invasion, or kidnapping. I'll be happy to answer any questions."

Speaker Lang: "Mr. Sandack on the Motion."

Sandack: "On the Motion? I'm sorry. I thought we were on Third Reading on the Bill."

Speaker Lang: "Yes. She made a Motion to pass her Bill, Sir."

Sandack: "Ah. Will the Sponsor yield?"

Sandack: "Thank you, Mr. Speaker. Representative, I support the Bill. I voted on it in committee and... but I just want to make sure the record's clear. Apart from The Department of Corrections, and they are opposing almost any Bill that potentially could increase incarceration anyone else opposing your Bill?"

Williams: "My analysis indicates the Cook County Public Defender's opposed, but they have not spoken to me. It's my understanding, they oppose any increase in statutes of limitation."

Sandack: "Okay. So, it's kind of a standing opposition."

Williams: "I believe so."

Sandack: "All right. And in committee we walk... we walked through a little bit of what would really happen in reality. I... I don't believe that you think, and I think you made the case, that it really wouldn't increase incarceration because we're talking about concurrent sentencing for other crimes."

Williams: "Well, what we're dealing with are situations of serious crimes that are conducted alongside a sexual assault crime. And keep in mind, this only deals with sexual assault crimes and where DNA evidence is relevant, so there's not going to be an issues of mistaken identity or something. This is DNA crime. The... the perpetrator, just by nature of the fact that they are going back in to make the identification, has committed more than one sexual assault."

Sandack: "Thank you, Representative."
