Ammons: "Thank you, Leader Lang. Just a point of personal privilege, please."

Speaker Lang: "Proceed."

Ammons: "Thank you. I just want to share a quick announcement and I think all of it is exactly part of what we're talking about at any rate, but today Chancellor Emeritus joined Mayor Rahm Emmanuel, President Tim Colleen and City Colleges Chancellor Sheryl Heiman to announce a new USCT Scholar Award Program. There is a news announcement about this and the reason why I made the announcement about that program is because they're trying to help people have pathways to bachelor's degrees which we know will change the outcome of the lives of families in our state. Currie: "Thank you very much, Speaker. I'm offering Amendment 1 to House Bill 4149. We heard very interesting testimony from local municipal officials, people who are concerned that their ability to stock up on the salt they need to keep the roads clear in the coming win... winter months will be impaired

unless the state sends them their share of the Motor Fuel Tax money, which traditionally we have done. They're concerned that they won't be able to fix the potholes that are already out there. Some of them testified that pothole filing comes from proceeds from the Motor Fuel Tax, not from other sources. So Amendment 1 would say that the one-third basically, about a third... three months worth of the amount that would be available we believe was available last year to municipalities from the Motor Fuel Tax would be appropriated now to the tune of \$145,625,100. Let me remind th... the group that this is not General Revenue money, this is Motor Fuel Tax money. And in the Governor's proposed budget as well as in the budget that we sent the Governor but he vetoed, this allocation looks identical to what I'm offering in Amendment 1. You heard the testimony. All of you have mayors, all of you have managers. All of you understand the importance of giving the roads the fix they need to get through not only the summer, but the winter months ahead. I'd be happy to answer your questions. And I surely would appreciate your 'aye' vote on this Amendment."

Speaker Lang: "Mr. Sandack."

Sandack: "Thank you, Mr. Speaker. Will the Lady yield?"

Speaker Lang: "Lady yields."

Sandack: "Leader Currie, would you explain the mechanisms and I guess the mechanical functioning of how this fund works?"

Currie: "Yeah. So, what happens is, as I understand it, that of the... the MFT that's collected there are some off the top allocations and then the remainder is split. So the state gets 45.6 percent and 54.4 percent goes to local governments."

The local government money is then further divided, so to municipalities, to Cook County, to other counties, to townships. And this is a formula that has been set in statute."

Sandack: "Would.. would you characterize this fund as revenue sharing?"

Currie: "It's been the traditional way we have treated the Motor Fuel Tax. The Department of Revenue collects it and then this sharing arrangement has been traditionally the way we have done business."

Sandack: "And right. So each month, Motor Fuel revenue is collected and then the next month it is shared with the municipalities and other units of government pursuant to statute. Is that..."

Currie: "And of course, it's the locals that have responsibility for those roads within their jurisdiction that are not governed by the state."

Sandack: "Right."

Currie: "So..."

Sandack: "And I'm.. I'm just talking about how money goes.. how it's collected and then how it's sent to the municipalities. So it's collected in month one and it's sent over for month two, correct?"

Currie: "I believe that's right."

Sandack: "All right. So, the proposal or the Amendment that's on the board right now, is it for three months or is it only for two months?"

Currie: "We intended it to be approximately three months' worth of the local government share of the veterate... Motor Fuel Tax allocation."

Sandack: "I think that is the intention, but as I see this proposal it's only going to... 'cause you collect it in one month and give it the next month, I think this only actually works for distributions or revenue sharing for two months."

Currie: "Well, I'm not sure you're right, but I... I guess I would just say, we based the numbers on the allocations that traditionally have gone during this first three-month period..."

Sandack: "Well, that might be."

Currie: "...of the fiscal year. So looking at prior fiscal years, what did we allocate in July, August and September? That's how we figured these numbers."

Sandack: "Okay. So, you didn't ask IDOT what was collected in July of this year. Is that what I'm hearing?"

Currie: "What I'm saying is, we looked at past years and we said what was spent in this program..."

Sandack: "So, the answer would be..."

Currie: "...through this program..."

Sandack: "...is that you didn't ask IDOT what was actually in the account now?"

Currie: "Let me check if we... if we did."

Sandack: "Thank you."

Currie: "But I don't think that it would..."

Sandack: "It wouldn't matter what's in the account now?"

Currie: "No, we based it on exactly how we spent money in previous fiscal years."

Sandack: "All right. Wouldn't... I heard you say that three times, thank you. Isn't it better to actually ask IDOT, hey, what's in the account? What was collected for July?"

Currie: "Well, I... I think that the... remember, that if there isn't enough money and under any circumstances it doesn't have to be spent."

Sandack: "Okay."

Currie: "So I don't think I would worry if we were a few pennies off, I think it is unlikely that we would be more than a few pennies off. And I think our... our analytics, the strategy that we use to arrive at this number is certainly sound."

Sandack: "Well, one of the reasons I asked about whether there was a communication with IDOT, in addition to the actual, hey, what's in the account, what was collected in July, there's also a requirement under the Act as to what's been incurred so that they can allocate dollars appropriately. I understand, because you've told me three times, that what you're proposing is based on last years or previous allocations and it's kind of a snapshot of history. I think best practices would be to actually know what's been collected and what is supposed to be distributed so that the number on the board actually correlates to reality rather than a historical snapshot."

Currie: "I guess... I guess, I don't quite get why you're concerned with pennies? I think the important point..."

Sandack: "I don't think these are pennies..."

Currie: "...is that..."

Sandack: "...Leader."

Currie: "...we would like to make sure local governments can buy the salt, fix the potholes and get on with road maintenance. That's their job. The state never has taken that responsibility from them. These are not state roads."

Sandack: "Leader, this program is for costs previously incurred not for prospective expenses. Ergo, my question about where the money's going? So, if the City of Chicago hasn't bought their... you know, their provisions for fighting this coming snowstorm or the winter, they should. And then they get reimbursed."

Currie: "But that isn't the way we generally do it. We generally take the... the proceeds from the Department of Revenue's collection and then we allocate. Now if we're wrong by some dollars, we've got... this is only... only a three-month funding. There's plenty more money coming down the road."

Sandack: "Well, I think it's two months. I think it's intended for three, but we could... irrespective of that, I... I know exactly what you're trying to do but I think you're going about it the wrong way with all due respect."

Currie: "So, are you saying... are you saying that people haven't been paying the Motor Fuel Tax or the department hasn't been collecting it?"

Sandack: "I'm talking about the Bill..."

Currie: "Or the Department of Transportation has spent it on something else? What happened to that months' worth of funding?"

Sandack: "Ma'am, I'm not saying any of that. I'm saying what you..."

Currie: "Well, you... you..."

Sandack: "...are proposing right now..."

Currie: "...you've raised some... you've raised some."

Sandack: "...I..."

Currie: "...suspicions over on my side..."

Sandack: "No suspicions."

Currie: "...of the aisle."

Sandack: "I'm questioning what you're doing and how you're going to accomplish what you intend to do and I... I think there's a gap. And that's the point of my question. I asked you about the mechanics of how this tax is collected and how it's paid. It's collected in month one; it's paid in month two. So a three-month provision... and I asked if you'd talked to anyone about what's in the account and... and you haven't. And then I also asked, hey, aren't we supposed to match allocations with actual distributions. And you think it's prospective that it can just pay for things that they want to pay for down the line. That's not what this law does. It's not what the Bill's supposed to do. To the... to the Amendment, Mr. Speaker. The mechanics of this matter, what IDOT's supposed to do and how they go about their business matters. And a good prudent practice would have been to engage the department and actually have them come in, talk to them and decide how this could work. This is a snapshot of a previous year or years. It isn't correlating to reality and it's not pennies, folks. We're talking about millions. To my friends that are here, I'd say this is more just shotty practices with respect to budgeting and it's a waste of time. Vote 'present'."

Speaker Lang: "Leader Currie to close."

Currie: "Thank... thank you, Speaker and Members of the House. I think we've just been thrown a bit of... a bunch of red

herrings. This program traditionally is a program where we pay the money up front to the municipalities, the counties and the townships. We do it on a population basis; we do it by formula. There are audits later to make sure that the money was spent appropriately. But it is not a program wherein they spend and then we reimburse. The people who spoke to us today made it clear that they need the money now if they're going to be able to fix the summer potholes and if they're going to be able to buy the salt they need to keep the roads clear in the coming winter months. This is not General Revenue money; it is Motor Fuel Tax money, nothing to do with the overall general funds budget. It would be, I think, churlish, inappropriate and unfair to the needs of our local communities if we do not vote to support Amendment 1 to House Bill 4149. I urge your 'aye' vote."

Speaker Lang: "Those in favor of the Lady's Motion will vote 'yes'; opposed 'no'. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Please record yourselves, Members. Have all voted who wish? Mr. Clerk, please take the record. On this question, there are 58 voting 'yes' and 16 voting 'present'. And the Amendment is adopted. panel that the cuts that the Governor has proposed to this program will mean leaving 90 percent of the people who were eligible on June 30, ineligible during the coming fiscal year. I think it is a good idea to support programs that keep Illinois people on the job, that keep our workers working and keep our small businesses able to keep their doors open, their workers afloat. I don't think we need more people coming along and cluttering up the Unemployment Compensation Fund, the parents who can't work because there is no child care as well as the daycare workers who no longer have jobs because their programs have shut up shop. So this Amendment would provide comparable to what we spent last year, three months' worth of funding so that there is the possibility that should the Governor rescind the rules or should we require him to, that we can continue providing adequate services to the peop... the people in Illinois who today are at work and are able to be sure that their children are safe and secure, they're not on the streets. You don't have 8-year-olds minding the 3-year-old crowd, but you are keeping people on the job. I would appreciate your support. I'm happy to answer your questions."
