Thank you for your continuous support of the Illinois Mathematics and Science Academy. The message serves as an update of our financial challenges that threaten our continued operation which impacts our ability to serve our 650 students on campus and thousands of students and educators around Illinois. Can you please ask people to tone it down, Speaker?"

Speaker Lang: "Ladies and Gentlemen, could we keep it down, please. Thank you very much."

Chapa LaVia: "Thank you, Speaker. At this time when the state seeks to strengthen its STEM talent development pipeline and retain the best and the brightest, IMSA's budget lapse jeopardizing the state's ability to build our next generation of leaders that will drive the 21st century knowledge economy, star... strengthen our senior class as looking for... to graduate, attend college and make a difference. IMSA's operations are 80 percent state-funded and we do not... have not been... we've been without a budget since the beginning of the fiscal year. Unlike universities, IMSA does not charge tuition, room or board. As a state agency, we cannot issue bonds or utilize other mechanisms that school districts would. Thanks... thanks to the General Assembly's action through Senate Bill 2039, on December 2015 we are now able to utilize our academicgenerated IMSA Income Fund which consists of revenues. The Illinois Mathematics and Science Academy is able to bring in through modest residential student and outreach program fees. While the appropriation level, Senate

Bill 2039 was up to 3.... 3,050,000 we can only spend the revenue we generate. With this encumbrance funding made available through the Income Fund, we are currently projected that our locally held funds will be fully committed in the near future, and the latest March of 2016. We have remained open thus far. The Comptroller continues to pay salaries, and we have been unable to support operations by accumulated unpaid invoices. As of January 28, 2016, IMSA owes 2,197,895 in unpaid invoices. Of these, 1,494,700 are 60 days over and which 1,223,600 are 90 days overdue, a figure we are now forced to track. These invoices include \$701,200 for food service and feed our students and 914,500 for facilities operations. The crux of the letter is that they are going out of business. They owe money on their bills and they're asking us to come up with a solution. These 650 children are not just residents of Aroura. They're residents of your community and you should care about them. Please tell me what we need to do to make sure we get the bil... the funds available. Thank you."

Their cars would not be able to move without the connectors invented by Andrew Beard or the valves for the steam engines invented by Frank J. Ferrell in the 1890s. Every day we wake up, whether we recognize it or not, we are immersed in black culture. The few inventors who I've mentioned to date don't

even begin to scratch the surface of the whole contribution of African-Americans. African American culture is very significant to this nation. And although we celebrate this culture on the shortest month of the year, nothing about Black History falls short of greatness. We celebrate because Black History is American History. Thank you very much."

BE IT RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend the Illinois Constitution in Article III by adding Section 9 as follows:

ARTICLE III

SUFFRAGE AND ELECTIONS

SECTION 9. TERM LIMITS.

(a) No person shall be elected to the Senate for more than three consecutive terms. For the purposes of implementation, this subsection (a) applies to Legislative Districts 1, 4, 7, 10, 13, 16, 19, 22, 25, 28, 31, 34, 37, 40, 43, 46, 49, 52, 55, and 58 beginning in the term that begins after the

election in 2020; to Legislative Districts 2, 5, 8, 11, 14, 17, 20, 23, 26, 29, 32, 35, 38, 41, 44, 47, 50, 53, 56, and 59 beginning in the term that begins after the election in 2018; and to Legislative Districts 3, 6, 9, 12, 15, 18, 21, 24, 27, 30, 33, 36, 39, 42, 45, 48, 51, 54, and 57 beginning in the term that begins after the election in 2022.

- (b) No person shall be elected to the House of Representatives for more than five consecutive terms. In addition, the recall of any member of the General Assembly may be proposed by a petition signed by a number of electors equal in number to at

least 10% of the total votes cast for that office in the member's Legislative District or Representative District, as applicable, in the general election in which the member was last elected. A petition shall have been signed by the petitioning electors not more than 150 days after an affidavit has been filed with the State Board of Elections providing notice of intent to circulate a petition to recall the Executive Branch officer or member of the General Assembly. The affidavit may be filed no sooner than 6 months after the beginning of the officer's or member's term of office.

(b) The form of the petition, circulation, and procedure for determining the validity and sufficiency of a petition shall be as provided by law. If the petition is valid and sufficient, the State Board of Elections shall certify the petition not more than 100 days after the date the petition was filed, and the question "Shall (name) be recalled from the office of (office)?" must be submitted to the electors at a special election called by the State Board of Elections, to occur not more than 100 days after certification of the petition. A recall petition certified by the State Board of Elections may not be withdrawn and another recall petition may not be initiated against the same officer or member during the remainder of his or her current term of office. In the case of an Executive Branch officer, any recall petition or recall election pending on the date of the next general election at which a candidate for that office is elected is moot. In the case of a member of the General Assembly, any recall petition or recall election pending on the date of the

The form of a successor election petition, circulation, and procedure for determining the validity and sufficiency of a petition shall be as provided by law. If the successor election petition is valid and sufficient, the State Board of Elections shall certify the petition not more than 100 days after the date the recall petition was filed. Names of candidates for nomination to serve as the candidate of an established political party must be submitted to the electors at a special primary election, if necessary, called by the State Board of Elections to be held at the same time as the special election on the question of recall established under subsection (b). Names of candidates for the successor election must be submitted to the electors at a special successor election called by the State Board of Elections, to occur not more than 60 days after the date of the special primary election or on a date established by law.
- (d) The Executive Branch officer or member of the General Assembly is immediately removed upon certification of the

- (a) Electors may petition for the recall of an executive branch officer as identified in Section 1 of Article V, a member of the General Assembly, or an individual holding a local elected office, including, but not limited to, mayors, village presidents, council members, school board members, community college officials, and county officials. If the recall petition is valid, on a separate ballot the question "Shall (officer) be recalled from the office of (office)" must be submitted to the electors, along with the names of any candidates certified for the successor election, at a special election called by the State Board of Elections or at a regularly scheduled election to occur not more than 100 days after the date of certification of the recall petition. The officer or member subject to recall may be a candidate in the successor election. Because the Governor and Lieutenant Governor are elected jointly under Section 4 of Article V, a petition to recall either must include both.
- (b) An executive branch officer as identified in Section 1 of Article V, a member of the General Assembly, or an individual holding a local elected office, including, but not limited to, mayors, village presidents, council members, school board members, community college officials, and county officials, is immediately removed upon certification of the recall election results if a majority of the electors voting on the

question vote to recall the officer, member, or individual. In an election to recall the Governor and Lieutenant Governor, one vote shall be cast jointly for or against recall of both. If an officer, member, or individual is recalled, the candidate who receives the highest number of votes in the successor election is elected successor for the balance of the term. Once a recall election petition is certified, the petition may not be withdrawn and another recall petition may not be initiated against that officer or member during the remainder of his or her current term of office.

- (c) Any elector of the State, the applicable Legislative or Representative District, or the applicable election unit may file an affidavit with the State Board of Elections providing notice of intent to circulate a petition to recall an officer, member, or individual no sooner than 6 months after the beginning of the current term of office of the officer, member, or individual. The affidavit must identify the name of the officer, member, or individual and the office to be recalled, the name and address of the proponents of the recall petition, and the date of filing with the State Board of Elections. A recall petition shall not be circulated prior to filing the affidavit, and a recall petition must be filed with the State Board of Elections no later than 160 days after filing the affidavit.
- (d) A petition to recall an executive branch officer must include signatures of electors of the State equal to at least 12% of the total votes cast for the office in the election at which the officer was elected, with signatures equal to at least 1% of the vote for the office from at least 5 separate

counties. A petition to recall a member of the General Assembly must be signed by electors of the respective Legislative District or Representative District equal to at least 20% of the total votes cast for the office in the election at which the member was elected. A petition to recall an individual holding a local elected office, including, but not limited to, mayors, village presidents, council members, school board members, community college officials, and county officials, must be signed by electors of the applicable election unit equal to at least 20% of the total votes cast for the office in the election at which the member was elected. The form, circulation, and manner of filing a recall petition shall comply with the requirements provided by law for a statewide advisory public question, except for the deadlines set forth in this Section.

- (e) A recall petition is valid unless an objection is made within 45 days after the date the petition is filed, and an objection to the recall petition may be made in the same manner as to a candidate for the office subject to recall. The State Board of Elections shall certify the recall petition not more than 105 days after the date the recall petition is filed. Any recall petition or election pending on the date of the next general election at which a candidate for the office subject to recall is elected is moot.
- (f) If a recall election is initiated, the name of no successor candidate may appear on the ballot unless a nominating petition has been filed with the State Board of Elections no more than 40 days after filing of the recall petition. The nominating petition of an established party

candidate must contain the same number of signatures and be circulated in the same manner as an established party candidate for nomination to the office subject to recall, except the petition must be circulated no more than 40 days prior to the last day for filing nomination petitions. A nominating petition may be objected to in the same manner as a candidate for the office subject to recall, unless otherwise provided by law. The State Board of Elections shall certify a valid nominating petition not more than 105 days after the date the recall petition is filed.

- (g) An election to determine whether to recall an executive branch officer as identified in Section 1 of Article V, a member of the General Assembly, or an individual holding a local elected office, including, but not limited to, mayors, village presidents, council members, school board members, community college officials, and county officials, and to elect a successor shall be proclaimed by the State Board of Elections and held not less than 60 days and no more than 100 days after the date of certification of the recall petition.
- (h) The provisions of this Section are self-executing and judicially enforceable.
