Everyone here is well aware of the Aq in the Classroom program that reaches over 500 thousand... 500 thousand yeah, students each year on the importance of agriculture and the fact that their food comes from a farmer, not from Meijer grocery, or Dominick's, or whatever. And they also have a very, very successful ag... Adopt a Legislator program that we're all members of; either we
