Section 1. This Act may be referred to as the Daniel
Capuano Memorial Act.

6 Section 5. The Criminal Code of 2012 is amended by adding 7 Section 12-5.1b as follows:

9 <u>Sec. 12-5.1b. First responder endangerment.</u>

10 (a) As used in this Section:

11 <u>"Commercial property" means developed real property</u> 12 <u>used exclusively for business purposes, including</u> 13 <u>non-residential spaces in mixed-use property, and does not</u> 14 <u>include residential or multi-family real property.</u>

"Dangerous condition" means a patently obvious 15 16 condition of a life-threatening nature that results from structural or architectural work <u>done without first</u> 17 18 submitting for a permit, or from a building code violation 19 of which the person received actual notice from the code 20 compliance official and failed to take corrective action 21 within the time period specified by the code compliance 22 official. "Dangerous condition" does not include actions

<u>undertaken without a permit to address or remediate a</u>
 <u>situation or condition that presents a clear and present</u>
 threat to safety or to the integrity of the building.

4 <u>"First responder" means emergency medical services</u>
5 personnel as defined in Section 3.5 of the Emergency
6 <u>Medical Services (EMS) Systems Act, a law enforcement</u>
7 <u>officer, or firefighter.</u>

8 "Management or operational control" means the lawful 9 ownership of or direct contractual relationship with the 10 lawful owner for the person to manage the commercial 11 property. "Management or operational control" does not 12 include engineering, security, elevator operating, or dock or janitorial services performed by any person who is 13 14 retained exclusively to provide the services and who does not have overall management or operational control of the 15 16 building.

17 <u>"Person" means a natural person, and only includes an</u> 18 <u>individual who had personal or professional management or</u> 19 <u>operational control of commercial real estate and who</u> 20 <u>directly exercised final decision-making authority to</u> 21 <u>create and conceal the dangerous condition causing death or</u> 22 <u>serious bodily injury.</u>

23 <u>"Serious bodily injury" means bodily injury that</u> 24 <u>results in a permanent disfigurement or permanent loss or</u> 25 <u>impairment of a bodily function, limb, or organ.</u>

26 (b) A person commits first responder endangerment when he

1	or she (1) knowingly creates a dangerous condition and (2)
2	intentionally conceals the dangerous condition in a commercial
3	property under his or her management or operational control and
4	the dangerous condition is the primary cause of the death or
5	serious bodily injury of a first responder in the course of his
6	or her official duties.
7	<u>(c) Sentence. First responder endangerment is a Class 4</u>

8 <u>felony.</u>
