8	(a) "Railroad passenger service" means any railroad
9	passenger service within the State of Illinois, including the
10	equipment and facilities used in connection therewith, with the
11	exception of the basic system operated by the National Railroad
12	Passenger Corporation pursuant to Title II and Section 403(a)
13	of the Federal Rail Passenger Service Act of 1970.
14	(b) "Federal Railroad Corporation" means the National
15	Railroad Passenger Corporation established pursuant to an Act
16	of Congress known as the "Rail Passenger Service Act of 1970."

1 (c) "Transportation system" means any and all modes of 2 public transportation within the State, including, but not 3 limited to, transportation of persons or property by rapid 4 transit, rail, bus, and aircraft, and all equipment, facilities 5 and property, real and personal, used in connection therewith.

6 (d) "Carrier" means any corporation, authority, 7 partnership, association, person or district authorized to 8 maintain a transportation system within the State with the 9 exception of the Federal Railroad Corporation.

10 (e) "Units of local government" means cities, villages, 11 incorporated towns, counties, municipalities, townships, and special districts, including any district created pursuant to 12 13 the "Local Mass Transit District Act", approved July 21, 1959, 14 as amended; any Authority created pursuant to the "Metropolitan 15 Transit Authority Act", approved April 12, 1945, as amended; 16 and, any authority, commission or other entity which by virtue of an interstate compact approved by Congress is authorized to 17 18 provide mass transportation.

(f) "Universities" means all public institutions of higher education as defined in an "Act creating a Board of Higher Education, defining its powers and duties, making an appropriation therefor, and repealing an Act herein named", approved August 22, 1961, as amended, and all private institutions of higher education as defined in the Illinois Finance Authority Act.

(j) "Governing authorities" means (1) the city council or 9 10 similar legislative body of a city; (2) the board of trustees 11 or similar body of a village or incorporated town; (3) the council of a municipality under the commission form of 12 13 municipal government; (4) the board of trustees in a township; (5) the Board of Trustees of the University of Illinois, the 14 15 Board of Trustees of Southern Illinois University at 16 Carbondale, the Board of Trustees of Southern Illinois University at Edwardsville, the Board of Trustees of Chicago 17 State University, the Board of Trustees of Eastern Illinois 18 Trustees of Governors 19 University, the Board of State 20 University, the Board of Trustees of Illinois State University, the Board of Trustees of Northeastern Illinois University, the 21 22 Board of Trustees of Northern Illinois University, the Board of 23 Trustees of Western Illinois University, and the Illinois 24 Community College Board; (6) the county board of a county; and 25 (7) the trustees, commissioners, board members, or directors of 26 a university, special district, authority or similar agency.

5 Sec. 14.3. All departments, boards, bureaus, commissions, 6 authorities, or other units of State government, except the Board of Trustees of Chicago State University, the Board of 7 8 Trustees of Eastern Illinois University, the Board of Trustees 9 of Governors State University, the Board of Trustees of University, the Board of 10 Illinois State Trustees of 11 Northeastern Illinois University, the Board of Trustees of 12 Northern Illinois University, the Board of Trustees of Western 13 Illinois University, the Board of Trustees of the University of 14 Illinois, and the Board of Trustees of Southern Illinois University at Carbondale, and the Board of Trustees of Southern 15 Illinois University at Edwardsville, that bond officers or 16 employees who are not required by law to obtain bonds to 17 18 qualify for office or employment, shall effect such bonding through the Department of Central Management Services by 19 inclusion in the blanket bond or bonds or self-insurance 20 21 program provided for in Sections 14.1 and 14.2 of this Act.

Section 15. The Voluntary Payroll Deductions Act of 1983 is

2 (5 ILCS 340/4) (from Ch. 15, par. 504)

3 Sec. 4. Employee withholding. An employee may authorize 4 the withholding of a portion of his or her salary or wages for 5 contribution to a maximum number of 4 organizations described in paragraphs (b) and (c) of Section 3 of this Act. A 6 department, board, body, agency or commission may direct the 7 8 State Comptroller to deduct, and the University of Illinois, 9 Southern Illinois University at Carbondale, Southern Illinois 10 University at Edwardsville, Chicago State University, Eastern Illinois University, Governors State University, Illinois 11 12 State University, Northeastern Illinois University, Northern 13 Illinois University, and Western Illinois University may 14 deduct, upon written request of a State employee, for each 15 regular payroll period, from the salary or wages of the employee the amount specified in the written request for 16 payment to the organization designated by the employee. The 17 moneys so deducted shall be paid over promptly to 18 the 19 organizations designated by the employee by means of warrants 20 drawn by the State Comptroller, the University of Illinois, 21 Southern Illinois University at Carbondale, Southern Illinois University at Edwardsville, Chicago State University, Eastern 22 23 Illinois University, Governors State University, Illinois 24 State University, Northeastern Illinois University, Northern 25 Illinois University, and Western Illinois University, against

the appropriation for personal services of the department, board, body, agency or commission by which such employee is employed.

Such deductions may be made notwithstanding that the compensation paid in cash to such employee is thereby reduced below the minimum prescribed by law. Payment to such employee of compensation less such deduction shall constitute a full and complete discharge and acquittance of all claims and demands whatsoever for the services rendered by such employee during the period covered by such payment.

11 Such request for deduction may be withdrawn at any time by filing a written notification of withdrawal 12 with the 13 department, board, body, agency or commission, the University 14 of Illinois, Southern Illinois University at Carbondale, 15 Southern Illinois University at Edwardsville, Chicago State 16 University, Eastern Illinois University, Governors State University, Illinois State University, Northeastern Illinois 17 University, Northern Illinois University, or Western Illinois 18 University, by which such employee is employed. 19

The report 10 shall be filed with the Advisory Committee no later than March 11 15. The report shall be available for inspection.

(d) "Minority" means a person who is any of the following:

14 (1) American Indian or Alaska Native (a person having

17 tribal affiliation or community attachment).

(2) Asian (a person having origins in any of the

(3) Black or African American (a person having origins

 Puerto Rican, South or Central American, or other Spanish
 culture or origin, regardless of race).

All employees shall be paid at least semi-monthly, except that employees of 2 the University of Illinois, Chicago State University, Eastern 3 4 Illinois University, Governors State University, Illinois 5 State University, Northeastern Illinois University, Northern 6 Illinois University, Western Illinois University, and Southern Illinois University at Carbondale, and Southern Illinois 7 University at Edwardsville who are not subject to the State 8 9 Universities Civil Service System shall be paid at least once 10 each month. No payment shall be made before the completion of 11 the period for which the compensation is being paid, except that employees leaving the service of the State may be paid at 12 13 the termination of their period of employment.

14 Such schedule shall be prepared showing such dates of 15 payment so as to provide as far as is practical, an even flow 16 of work for issuance of warrants in payment of personal 17 services.

In making payments for a fractional part of a pay period, 18 that part of the regular compensation for the period shall be 19 20 paid represented by a fraction, the numerator being the number 21 of days worked and the denominator being the number of work 22 days in the period. However, in making payments for a 23 fractional part of a pay period for positions subject to the 24 jurisdiction of the Department of Central Management Services, 25 that part of the regular compensation shall be paid by deducting an amount determined by multiplying the number of 26

work days without pay by the applicable daily rate as defined
 within the Department of Central Management Services Pay Plan.

In employments of a teaching or professional nature in connection with the educational, charitable, penal or reformatory institutions, where the compensation of an employee is based upon an annual salary, a teaching or professional year may be substituted for a calendar year in determining the pay schedule.

(3) As of the date on which this amendatory Act of 1999
becomes law, an electric utility providing service to more
than 1,000,000 customers in this State has proposed to sell
or transfer to a single buyer 5 or more generating plants

3 (4) Such electric utility anticipates receiving a sale

except for the requirements set forth in Section 2 of this Act: 1 1. A corporation sole or other religious corporation, 2 3 trust or organization incorporated or established for religious purposes, nor to any agency or organization 4 5 incorporated or established for charitable, hospital or educational purposes and engaged in effectuating one or 6 7 more of such purposes, that is affiliated with, operated 8 by, or supervised or controlled by a corporation sole or 9 other religious corporation, trust or organization

10 incorporated or established for religious purposes, nor to 11 other religious agencies or organizations which serve 12 religion by the preservation of religious rights and 13 freedom from persecution or prejudice or by fostering 14 religion, including the moral and ethical aspects of a 15 particular religious faith.

16 2. Any charitable organization which does not intend to 17 solicit and receive and does not actually receive 18 contributions in excess of \$15,000 during any 12 month 19 period ending December 31 of any year. However, if the 20 contributions received by such charitable qross 21 organization during any 12 month period ending December 31 22 of any year shall be in excess of \$15,000, it shall file 23 reports as required under this Act and the provisions of 24 this Act shall apply.

(b) The following persons shall not be required to registerwith the Attorney General:

1. The University of Illinois, Southern Illinois 1 University at Carbondale, Southern Illinois University at 2 3 Edwardsville, Eastern Illinois University, Illinois State Normal University, Northern Illinois University, Western 4 5 Illinois University, all educational institutions that are recognized by the State Board of Education or that are 6 7 accredited by a regional accrediting association or by an 8 organization affiliated with the National Commission on 9 Accrediting, any foundation having an established identity 10 with any of the aforementioned educational institutions, 11 educational institution confining anv other its 12 solicitation of contributions to its student body, alumni, 13 faculty and trustees, and their families, or a library 14 established under the laws of this State, provided that the 15 annual financial report of such institution or library 16 shall be filed with the State Board of Education, Governor, Illinois State Library, County Library Board or County 17 Board, as provided by law. 18

2. Fraternal, patriotic, social, educational, alumni 19 20 organizations and historical societies when solicitation of contributions is confined to their membership. This 21 22 exemption shall be extended to any subsidiary of a parent 23 or superior organization exempted by Sub-paragraph 2 of 24 Paragraph (b) of Section 3 of this Act where such 25 solicitation is confined to the membership of the 26 subsidiary, parent or superior organization.

3. Persons requesting any contributions for the relief 1 or benefit of any individual, specified by name at the time 2 of the solicitation, if the contributions collected are 3 turned over to the named beneficiary, first deducting 4 reasonable expenses for costs of banquets, or social 5 gatherings, if any, provided all fund raising functions are 6 carried on by persons who are unpaid, directly or 7 8 indirectly, for such services.

9 4. Any bona fide union, bona fide political 10 organization or bona fide political action committee, 11 which does not solicit funds for a charitable purpose.

5. Any charitable organization receiving an allocation 12 13 from an incorporated community chest or united fund, 14 provided such chest or fund is complying with the 15 provisions of this Act relating to registration and filing of annual reports with the Attorney General, and provided 16 such organization does not actually receive, in addition to 17 such allocation, contributions in excess of \$4,000 during 18 19 any 12 month period ending June 30th of any year, and 20 provided further that all the fund raising functions of 21 such organization are carried on by persons who are unpaid 22 for such services. However, if the gross contributions 23 other than such allocation received by such charitable 24 organization during any 12 month period ending June 30th of 25 any year shall be in excess of \$4,000, it shall within 30 26 days after the date it shall have received such contributions in excess of \$4,000 register with the
 Attorney General as required by Section 2.

3 6. A bona fide organization of volunteer firemen, or a bona fide auxiliary or affiliate of such organization, 4 5 provided all its fund raising activities are carried on by members of such an organization or an affiliate thereof and 6 7 such members receive no compensation, directly or indirectly, therefor. 8

9 7. Any charitable organization operating a nursery for 10 infants awaiting adoption providing that all its fund 11 raising activities are carried on by members of such an 12 organization or an affiliate thereof and such members 13 receive no compensation, directly or indirectly therefor.

14 8. Any corporation established by the Federal Congress 15 that is required by federal law to submit annual reports of 16 its activities to Congress containing itemized accounts of 17 all receipts and expenditures after being duly audited.

9. Any boys' club which is affiliated with the Boys' Club of America, a corporation chartered by Congress; provided, however, that such an affiliate properly files the reports required by the Boys' Club of America and that the Boys' Club of America files with the Government of the United States the reports required by its federal charter.

24 10. Any veterans organization chartered or 25 incorporated under federal law and any veterans 26 organization which is affiliated with, and recognized in 1 the bylaws of, a congressionally chartered or incorporated organization; provided, however, 2 veterans that the 3 affiliate properly files the reports required by the 4 congressionally chartered or incorporated veterans 5 organization, that the congressionally chartered or incorporated veterans organization files 6 with the 7 government of the United States the reports required by its 8 federal charter, and that copies of such federally required 9 reports are filed with the Attorney General.
