Amends the Election Code. Provides for the election of the Chicago Board of Education starting with the 2019 consolidated election. Makes related changes. Amends the Chicago School District Article of the School Code. Provides that a person shall be a U.S. citizen and registered voter and shall have been a resident of the city and the electoral district for at least one year immediately preceding his or her election. Sets forth provisions concerning nominating petitions and ballots. Sets forth provisions providing that the City of Chicago shall be subdivided into 20 electoral districts by the General Assembly for seats on the Chicago Board of Education. Sets forth provisions providing that in the year following each decennial census, the General Assembly shall redistrict the electoral districts to reflect the results of each decennial census. Makes other changes. Effective immediately.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

Section 5. The Election Code is amended by changing
Sections 2A-1.2 and 2A-48 as follows:

7 (10) Trustee of the Metropolitan Sanitary District of Chicago, and elected Trustee of other Sanitary Districts; 8

(11) Special District elected officers, not otherwise 10 designated in this Section, where the statute creating or 11 authorizing the creation of the district requires an annual 12 election and permits or requires election of candidates of 13 political parties.

14 (b) At the general primary election:

15 (1) in each even-numbered year candidates of political 16 parties shall be nominated for those offices to be filled at the general election in that year, except where pursuant 17 to law nomination of candidates of political parties is 18 19 made by caucus.

20 (2)in the appropriate even-numbered years the 21 political party offices of State central committeeman, 22 township committeeman, ward committeeman, and precinct 23 committeeman shall be filled and delegates and alternate 24 delegates to the National nominating conventions shall be 25 elected as may be required pursuant to this Code. In the 26 even-numbered years in which a Presidential election is to 1 2 be held, candidates in the Presidential preference primary shall also be on the ballot.

3 (3) in each even-numbered year, where the municipality has provided for annual elections to elect municipal 4 5 officers pursuant to Section 6(f) or Section 7 of Article 6 VII of the Constitution, pursuant to the Illinois Municipal 7 Code or pursuant to the municipal charter, the offices of 8 such municipal officers shall be filled at an election held 9 on the date of the general primary election, provided that 10 the municipal election shall be a nonpartisan election 11 where required by the Illinois Municipal Code. For partisan 12 municipal elections in even-numbered years, a primary to nominate candidates for municipal office to be elected at 13 14 the general primary election shall be held on the Tuesday 6 15 weeks preceding that election.

16 (4) in each school district which has adopted the 17 provisions of Article 33 of the School Code, successors to 18 the members of the board of education whose terms expire in 19 the year in which the general primary is held shall be 20 elected.

21 (c) At the consolidated election in the appropriate 22 odd-numbered years, the following offices shall be filled:

(1) Municipal officers, provided that in municipalities in which candidates for alderman or other municipal office are not permitted by law to be candidates of political parties, the runoff election where required by

law, or the nonpartisan election where required by law, 1 2 shall be held on the date of the consolidated election; and 3 provided further, in the case of municipal officers provided for by an ordinance providing the form of 4 5 government of the municipality pursuant to Section 7 of Article VII of the Constitution, such offices shall be 6 7 filled by election or by runoff election as may be provided 8 by such ordinance;

(d) At the consolidated primary election in each odd-numbered year, candidates of political parties shall be nominated for those offices to be filled at the consolidated election in that year, except where pursuant to law nomination 1 of candidates of political parties is made by caucus, and 2 except those offices listed in paragraphs (12) through (17) of 3 subsection (c).

At the consolidated primary election in the appropriate 4 5 odd-numbered years, the mayor, clerk, treasurer, and aldermen shall be elected in municipalities in which candidates for 6 mayor, clerk, treasurer, or alderman are not permitted by law 7 8 to be candidates of political parties, subject to runoff 9 elections to be held at the consolidated election as may be 10 required by law, and municipal officers shall be nominated in a 11 nonpartisan election in municipalities in which pursuant to law 12 candidates for such office are not permitted to be candidates 13 of political parties.

At the consolidated primary election in the appropriate odd-numbered years, municipal officers shall be nominated or elected, or elected subject to a runoff, as may be provided by an ordinance providing a form of government of the municipality pursuant to Section 7 of Article VII of the Constitution.

(f) At any election established in Section 2A-1.1, public questions may be submitted to voters pursuant to this Code and any special election otherwise required or authorized by law or by court order may be conducted pursuant to this Code.

Notwithstanding the regular dates for election of officers established in this Article, whenever a referendum is held for the establishment of a political subdivision whose officers are

to be elected, the initial officers shall be elected at the election at which such referendum is held if otherwise so provided by law. In such cases, the election of the initial officers shall be subject to the referendum.

5 Notwithstanding the regular dates for election of officials established in this Article, any community college 6 7 district which becomes effective by operation of law pursuant 8 to Section 6-6.1 of the Public Community College Act, as now or 9 hereafter amended, shall elect the initial district board 10 members at the next regularly scheduled election following the 11 effective date of the new district.

12 (g) At any election established in Section 2A-1.1, if in 13 any precinct there are no offices or public questions required 14 to be on the ballot under this Code then no election shall be 15 held in the precinct on that date.

(h) There may be conducted a referendum in accordance with
the provisions of Division 6-4 of the Counties Code.

9 Each member shall be elected for a term of 4 years, 10 commencing on the second Tuesday in May of the year in which the member is elected, and until the member's successor is 11 12 elected and has qualified. For purposes of elections conducted 13 pursuant to this subsection (b-5), the City of Chicago shall be 14 subdivided into 20 electoral districts by the General Assembly 15 for seats on the Chicago Board of Education, as provided under 16 Section 34-21.9 of this Code. Each district shall be 17 represented by a member, and one member shall be elected at large and serve as the president of the board. 18

Within 28 days after each board enters office, the board shall organize by electing its vice president and fixing a time and place for the regular meetings. No less than a majority of the board's regular meetings shall take place after regular business hours in order to maximize community participation. Upon organizing itself as provided in this subsection (b-5), the board shall enter upon the discharge of its duties.

(ii) the vice president shall perform the duties of the president if that office is vacant or the president is absent or unable to act. The secretary of the <u>board</u> Board shall be selected by the <u>board</u> Board and shall be an employee of the <u>board</u> Board rather than a member of the <u>board</u> Board, notwithstanding subsection (d) of Section 34-3.3. The duties of the secretary shall be imposed by the rules of the <u>board</u> Board.

No 10 former officer, member, or employee of the board shall, within 11 a period of one year immediately after termination of service 12 on the board, knowingly accept employment or receive 13 compensation or fees for services from a person or entity if 14 the officer, member, or employee, during the year immediately preceding termination of service on the board, participated 15 16 personally and substantially in the award of contracts with the 17 board or the school district, or the issuance of contract change orders with the board or the school district, with a 18 19 cumulative value of \$25,000 or more to the person or entity, or 20 its parent or subsidiary.

(c) The board may appoint a student to the board to serve in an advisory capacity. The student member shall serve for a term as determined by the board. The board may not grant the student member any voting privileges, but shall consider the student member as an advisor. (a) To be eligible for <u>election</u> appointment to the board, a 4 5 person shall be a citizen of the United States, shall be a registered voter as provided in the Election Code, shall have 6 7 been a resident of the city and the electoral district for at 8 least one year 3 years immediately preceding his or her 9 election appointment, and shall not be a child sex offender as 10 defined in Section 11-9.3 of the Criminal Code of 2012. A 11 person is ineligible for election or appointment to the board 12 if that person is an employee of the school district. All 13 persons eligible for election to the board shall be nominated by a petition signed by no less than 250 voters residing within 14 15 the electoral district on a petition in order to be placed on 16 the ballot, except that persons eligible for election to the board at large shall be nominated by a petition signed by no 17 18 less than 2,500 voters residing within the city.

Permanent removal from the city by any member of the board during his <u>or her</u> term of office constitutes a resignation therefrom and creates a vacancy in the board. <u>Board</u> Except for the President of the Chicago School Reform Board of Trustees who may be paid compensation for his or her services as chief executive officer as determined by the Mayor as provided in subsection (a) of Section 34 3, board members shall serve

without any compensation; provided, that board members shall be 1 2 reimbursed for expenses incurred while in the performance of 3 their duties upon submission of proper receipts or upon submission of a signed voucher in the case of an expense 4 5 allowance evidencing the amount of such reimbursement or allowance to the president of the board for verification and 6 7 approval. Board members The board of education may continue to 8 provide health care insurance coverage, employer pension 9 contributions, employee pension contributions, and life 10 insurance premium payments for an employee required to resign 11 from an administrative, teaching, or career service position in 12 order to qualify as a member of the board of education. They 13 shall not hold other public office under the Federal, State or 14 any local government other than that of Director of the Regional Transportation Authority, member of the economic 15 16 development commission of a city having a population exceeding 17 500,000, notary public or member of the National Guard, and by accepting any such office while members of the board, or by not 18 resigning any such office held at the time of being elected 19 20 appointed to the board within 30 days after such election 21 appointment, shall be deemed to have vacated their membership 22 in the board.

16 (a) The Inspector General and his office in existence on 17 the effective date of this amendatory Act of 1995 shall be transferred to the jurisdiction of the board upon appointment 18 19 of the Chicago School Reform Board of Trustees. The Inspector 20 General shall have the authority to conduct investigations into 21 allegations of or incidents of waste, fraud, and financial 22 mismanagement in public education within the jurisdiction of 23 the board by a local school council member or an employee, 24 contractor, or member of the board or involving school projects 25 managed or handled by the Public Building Commission. The

Inspector General shall make recommendations to the board about 1 2 the investigations. The Inspector General in office on the 3 effective date of this amendatory Act of 1996 shall serve for a term expiring on June 30, 1998. His or her successors in office 4 5 shall each be appointed by the Mayor, without the consent or approval of the City Council, for 4 year terms expiring on June 6 7 30th of an even numbered year; however, beginning on May 14, 2019, successors shall be appointed by the board instead of the 8 9 Mayor. If the Inspector General leaves office or if a vacancy 10 in that office otherwise occurs, the Mayor shall appoint, 11 without the consent or approval of the City Council, a 12 successor to serve under this Section for the remainder of the 13 unexpired term; however, beginning on May 14, 2019, successors shall be appointed by the board instead of the Mayor. 14 The 15 Inspector General shall be independent of the operations of the 16 board and the School Finance Authority, and shall perform other 17 duties requested by the board.

The Inspector General shall have access 18 (b) to all information and personnel necessary to perform the duties of 19 20 the office. If the Inspector General determines that a possible 21 criminal act has been committed or that special expertise is 22 required in the investigation, he or she shall immediately 23 notify the Chicago Police Department and the Cook County 24 State's Attorney. All investigations conducted by the 25 Inspector General shall be conducted in a manner that ensures 26 the preservation of evidence for use in criminal prosecutions.

1 (c) At all times the Inspector General shall be granted 2 access to any building or facility that is owned, operated, or 3 leased by the board, the Public Building Commission, or the 4 city in trust and for the use and benefit of the schools of the 5 district.

6 (d) The Inspector General shall have the power to subpoena 7 witnesses and compel the production of books and papers 8 pertinent to an investigation authorized by this Code. Any 9 person who (1) fails to appear in response to a subpoena; (2) 10 fails to answer any question; (3) fails to produce any books or 11 papers pertinent to an investigation under this Code; or (4) 12 knowingly gives false testimony during an investigation under 13 this Code, is guilty of a Class A misdemeanor.

(e) The Inspector General shall provide to the board and 14 15 the Illinois General Assembly a summary of reports and 16 investigations made under this Section for the previous fiscal 17 year no later than January 1 of each year, except that the Inspector General shall provide the summary of reports and 18 investigations made under this Section for the period 19 20 commencing July 1, 1998 and ending April 30, 1999 no later than May 1, 1999. The summaries shall detail the final disposition 21 22 of those recommendations. The summaries shall not contain any 23 confidential or identifying information concerning the subjects of the reports and investigations. The summaries shall 24 25 also include detailed recommended administrative actions and 26 matters for consideration by the General Assembly.
