AMENDMENT NO. _____. Amend House Bill 1798, by deleting everything after the enacting clause and inserting the following:

5 "Section 1. The appropriations contained in this Act are 6 intended for the purpose of continuing the existing process of 7 administering payments that were previously authorized pursuant 8 to the order of the Circuit Court of the 20th Judicial Circuit 9 in St. Clair County (Case # 15-CH-475). The appropriations 10 contained in this Act are intended to provide for the 11 unobligated amounts for payments remaining for fiscal year 12 2017.
