1 AMENDMENT TO HOUSE BILL 2771

2 AMENDMENT NO. \_\_\_\_\_. Amend House Bill 2771, AS AMENDED, in  
3 Section 10 of the bill, by replacing the definition of  
4 "Employee" with the following:

5 ""Employee" means any person who performs services for an  
6 employer for wage, remuneration, or other compensation. This  
7 includes persons working any number of hours, including a  
8 full-time or part-time status. "Employee" does not include any  
9 employee of an employer subject to the provisions of Title II  
10 of the Railway Labor Act (45 U.S.C. 181 et seq.) or to an  
11 employer or employee as defined in either the federal Railroad  
12 Unemployment Insurance Act (45 U.S.C. 351 et seq.) or the  
13 Federal Employers' Liability Act, United States Code, Title 45,  
14 Sections 51 through 60, or other comparable federal law.  
15 Nothing in this Section shall hinder or prohibit the ability of  
16 an exempted employee from taking non-compensated time off due  
17 to an illness."; and

1 in Section 10 of the bill by replacing the definition of  
2 "Healthcare provider" with the following:

3 "Healthcare provider" means a person who is: (i) licensed  
4 to practice medicine in all of its branches in Illinois and  
5 possesses the degree of doctor of medicine; (ii) licensed to  
6 practice medicine in all of its branches in Illinois and  
7 possesses the degree of doctor of osteopathy or osteopathic  
8 medicine; (iii) licensed to practice medicine in all of its  
9 branches or as an osteopathic physician in another state or  
10 jurisdiction; (iv) a chiropractic physician licensed under the  
11 Medical Practice Act of 1987; or (v) any other person as  
12 determined by the final rule under the Family and Medical Leave  
13 Act of 1993 in effect as of the effective date of this Act."
