SYNOPSIS AS INTRODUCED:

430 ILCS 66/60

Amends the Firearm Concealed Carry Act. Provides that a licensee requesting a new license shall submit: (1) \$25 to replace a lost license, of which \$15 shall be apportioned to the State Police Firearm Services Fund, \$5 shall be apportioned to the Mental Health Reporting Fund, and \$5 shall be apportioned to the State Crime Laboratory Fund; and (2) \$30 for a changed address, of which \$20 shall be apportioned to the State Police Firearm Services Fund, \$5 shall be apportioned to the Mental Health Reporting Fund, and \$5 shall be apportioned to the State Crime Laboratory Fund (rather than \$75, of which \$60 shall be apportioned to the State Police Firearm Services Fund, \$5 shall be apportioned to the Mental Health Reporting Fund, and \$10 shall be apportioned to the State Crime Laboratory Fund). Effective immediately.

A BILL FOR

1 AN ACT concerning safety.

2 **Be it enacted by the People of the State of Illinois,**
3 **represented in the General Assembly:**

4 Section 5. The Firearm Concealed Carry Act is amended by
5 changing Section 60 as follows:

6 (430 ILCS 66/60)

7 Sec. 60. Fees.

8 (a) All fees collected under this Act shall be deposited as
9 provided in this Section. Application, renewal, and
10 replacement fees shall be non-refundable.

11 (b) An applicant for a new license or a renewal shall
12 submit \$150 with the application, of which \$120 shall be
13 apportioned to the State Police Firearm Services Fund, \$20
14 shall be apportioned to the Mental Health Reporting Fund, and
15 \$10 shall be apportioned to the State Crime Laboratory Fund.

16 (c) A non-resident applicant for a new license or renewal
17 shall submit \$300 with the application, of which \$250 shall be
18 apportioned to the State Police Firearm Services Fund, \$40
19 shall be apportioned to the Mental Health Reporting Fund, and
20 \$10 shall be apportioned to the State Crime Laboratory Fund.

21 (d) A licensee requesting a new license in accordance with
22 Section 55 shall submit:

23 (1) \$25 to replace a lost license, of which \$15 shall

1 be apportioned to the State Police Firearm Services Fund,
2 \$5 shall be apportioned to the Mental Health Reporting
3 Fund, and \$5 shall be apportioned to the State Crime
4 Laboratory Fund.

5 (2) \$30 for a changed address ~~\$75~~, of which \$20 ~~\$60~~
6 shall be apportioned to the State Police Firearm Services
7 Fund, \$5 shall be apportioned to the Mental Health
8 Reporting Fund, and \$5 ~~\$10~~ shall be apportioned to the
9 State Crime Laboratory Fund.
