SYNOPSIS AS INTRODUCED:

Makes appropriations for the ordinary and contingent expenses of the Office of the State Appellate Defender. Makes further appropriations for: expenses related to federally assisted programs to work on systemic sentencing issues appeals cases; expenses related to providing public defenders in rural counties the resources needed to adequately investigate and defend indigent clients; the ordinary and contingent expenses of the Expungement Program; statewide training to Public Defenders; and developing a Juvenile Defender Resource Center. Effective July 1, 2017.

Be it enacted by the People of the State of Illinois, represented 2 in the General Assembly: 3

Section 5. The following named amounts, or so much of those 4 5 amounts as may be necessary, respectively, for the objects and purposes named, are appropriated from the General Revenue Fund 6 to meet the ordinary and contingent expenses of the Office of 7 8 the State Appellate Defender:

20 Section 10. The amount of \$200,000, or so much thereof as 21 may be necessary, is appropriated from the State Appellate 22 Defender Federal Trust Fund to the Office of the State Appellate

Defender for expenses related to federally assisted programs to work on systemic sentencing issues appeals cases to which the agency is appointed and provide public defenders in rural counties the resources needed to adequately investigate and defend indigent clients.

6 Section 15. The amount of \$60,000, or so much thereof as 7 may be necessary, is appropriated from the General Revenue Fund 8 to the Office of the State Appellate Defender for expenses 9 related to providing public defenders in rural counties the 10 resources needed to adequately investigate and defend indigent 11 clients.

Section 20. The amount of \$125,000, or so much thereof as may be necessary, is appropriated from the General Revenue Fund to the Office of the State Appellate Defender for the ordinary and contingent expenses of the Expungement Program.

Section 25. The amount \$63,000, or so much thereof as may be necessary, is appropriated from the General Revenue Fund to the Office of the State Appellate Defender to provide statewide training to Public Defenders under the Public Defender Training Program.
