SYNOPSIS AS INTRODUCED:

105 ILCS 5/2-3.173 new 105 ILCS 5/21B-20

Amends the School Code. Requires the State Board of Education to establish and maintain the Growing Future Educators Program to train high school graduates who at one time have been identified as English learners and who are enrolled in an approved educator preparation program, among other qualifications, to become secondary language educators. Provides that each school district that chooses to participate in the Program shall partner with one public, regionally accredited institution of higher education in this State that offers a pre-approved educator preparation program and each qualified high school graduate participating in the program through the district must be enrolled at that institution in its educator preparation program. Provides that for each semester that a qualified high school graduate is participating in the program, the State Board shall issue the person a paraprofessional educator endorsement on an Educator License with Stipulations and the person must be employed as a part-time employee by the participating district as a paraprofessional working under the supervision of a district employee with a Professional Educator License. Sets forth provisions concerning funding, submitting program data, reporting to the General Assembly, and rulemaking. Effective immediately.

AN ACT concerning education.

Be it enacted by the People of the State of Illinois, 2 represented in the General Assembly: 3

4 Section 1. Legislative intent. The General Assembly 5 understands there is a current teacher shortage throughout this State and the United States, especially a shortage of bilingual 6 and secondary language teachers. The General Assembly also 7 understands that higher education is becoming more and more 8 9 expensive each year. In response, the General Assembly has taken action to ensure that Illinois schools have access to 10 quality educators at both the elementary and secondary level. 11 12 The General Assembly believes it is appropriate to offer assistance to quality high school graduates so they can receive 13 a college degree while in the midst of helping school-aged 14 15 children learn the basics of a foreign language.

16 Section 5. The School Code is amended by adding Section 2-3.173 and by changing Section 21B-20 as follows: 17

If a gualified high school 9 graduate fails to enroll in enough credit hours to qualify for 10 at least part-time status in any given semester, the qualified 11 high school graduate may not be issued the paraprofessional 12 educator endorsement for that semester but may participate in the Program in subsequent semesters in which the qualified high 13 14 school graduate is enrolled in enough credit hours to qualify for at least part-time status. A qualified high school graduate 15 16 shall no longer qualify for the Program if at any time the 17 participating school district determines that the qualified high school graduate is no longer making substantial progress 18 19 towards a degree in an approved educator preparation program. 20 (e) Throughout each semester of participation in the

21 Program, the qualified high school graduate must be employed as 22 a part-time employee by the participating school district as a 23 paraprofessional working under the supervision of a school 24 district employee with a Professional Educator License. The 25 gualified high school graduate shall work under the supervision 26 of a school district employee with a Professional Educator

Sec. 21B-20. Types of licenses. Before July 1, 2013, the 1 State Board of Education shall implement a system of educator 2 3 licensure, whereby individuals employed in school districts who are required to be licensed must have one of the following 4 5 licenses: (i) a professional educator license; (ii) a 6 professional educator license with stipulations; or (iii) a 7 substitute teaching license. References in law regarding 8 individuals certified or certificated or required to be 9 certified or certificated under Article 21 of this Code shall 10 also include individuals licensed or required to be licensed 11 under this Article. The first year of all licenses ends on June 12 30 following one full year of the license being issued.

13 The State Board of Education, in consultation with the 14 State Educator Preparation and Licensure Board, may adopt such 15 rules as may be necessary to govern the requirements for 16 licenses and endorsements under this Section.

17 (1) Professional Educator License. Persons who (i) successfully completed 18 have an approved educator preparation program and are recommended for licensure by 19 20 the Illinois institution offering the educator preparation program, (ii) have successfully completed the required 21 22 testing under Section 21B-30 of this Code, (iii) have 23 successfully completed coursework on the psychology of, the identification of, and the methods of instruction for 24 25 exceptional child, including without the limitation 26 children with learning disabilities, (iv) have

1 successfully completed coursework in methods of reading 2 and reading in the content area, and (v) have met all other criteria established by rule of the State Board of 3 Education shall be issued a Professional Educator License. 4 5 All Professional Educator Licenses are valid until June 30 immediately following 5 years of the license being issued. 6 7 The Professional Educator License shall be endorsed with 8 specific areas and grade levels in which the individual is 9 eligible to practice.

10 Individuals can receive subsequent endorsements on the 11 Professional Educator License. Subsequent endorsements 12 shall require a minimum of 24 semester hours of coursework 13 in the endorsement area, unless otherwise specified by 14 rule, and passage of the applicable content area test.

15 (2) Educator License with Stipulations. An Educator
16 License with Stipulations shall be issued an endorsement
17 that limits the license holder to one particular position
18 or does not require completion of an approved educator
19 program or both.

20 An individual with an Educator License with 21 Stipulations must not be employed by a school district or 22 any other entity to replace any presently employed teacher 23 who otherwise would not be replaced for any reason.

24 An Educator License with Stipulations may be issued 25 with the following endorsements:

26

(A) Provisional educator. A provisional educator

endorsement in a specific content area or areas on an 1 2 Educator License with Stipulations may be issued to an 3 applicant who holds an educator license from another state, U.S. territory, or foreign country and who, at 4 5 the time of applying for an Illinois license, does not meet the minimum requirements under Section 21B-35 of 6 7 this Code, but does, at a minimum, meet the following requirements: 8

9 (i) Holds the equivalent of a minimum of a 10 bachelor's degree, unless a master's degree is 11 required for the endorsement, from a regionally 12 accredited college university or or, for 13 individuals educated in a country other than the 14 United States, the equivalent of a minimum of a 15 bachelor's degree issued in the United States, 16 unless a master's degree is required for the 17 endorsement.

(ii) Has passed or passes a test of basic 18 19 skills and content area test prior to or within one 20 year after issuance of the provisional educator 21 endorsement on the Educator License with 22 Stipulations. If an individual who holds an 23 Educator License with Stipulations endorsed for 24 provisional educator has not passed a test of basic 25 skills and applicable content area test or tests 26 within one year after issuance of the endorsement,

1 the endorsement shall expire on June 30 following 2 one full year of the endorsement being issued. If 3 such an individual has passed the test of basic skills and applicable content area test or tests 4 5 either prior to issuance of the endorsement or 6 within one year after issuance of the endorsement, 7 the endorsement is valid until June 30 immediately 8 following 2 years of the license being issued, 9 time all during which any and coursework 10 deficiencies must be met and any and all additional 11 testing deficiencies must be met.

12 In addition, a provisional educator endorsement 13 for principals or superintendents may be issued if the 14 individual meets the requirements set forth in 15 subdivisions (1) and (3) of subsection (b-5) of Section 16 21B-35 of this Code. Applicants who have not been 17 entitled by an Illinois-approved educator preparation program at an Illinois institution of higher education 18 19 shall not receive a provisional educator endorsement 20 if the person completed an alternative licensure 21 program in another state, unless the program has been 22 determined to be equivalent to Illinois program 23 requirements.

24 Notwithstanding any other requirements of this 25 Section, a service member or spouse of a service member 26 may obtain a Professional Educator License with

1 Stipulations, and a provisional educator endorsement 2 in a specific content area or areas, if he or she holds 3 a valid teaching certificate or license in good standing from another state, meets the qualifications 4 5 of educators outlined in Section 21B-15 of this Code, and has not engaged in any misconduct that would 6 7 individual from obtaining a license prohibit an pursuant to Illinois law, including without limitation 8 9 any administrative rules of the State Board of 10 Education.

11 In this Section, "service member" means any person 12 who, at the time of application under this Section, is 13 an active duty member of the United States Armed Forces 14 or any reserve component of the United States Armed 15 Forces or the National Guard of any state, 16 commonwealth, or territory of the United States or the 17 District of Columbia.

A provisional educator endorsement is valid until 18 19 June 30 immediately following 2 years of the license 20 being issued, provided that any remaining testing and coursework deficiencies are met as set forth in this 21 22 Section. Failure to satisfy all stated deficiencies 23 shall mean the individual, including any service 24 member or spouse who has obtained a Professional 25 Educator License with Stipulations and a provisional 26 educator endorsement in a specific content area or

1areas, is ineligible to receive a Professional2Educator License at that time. An Educator License with3Stipulations endorsed for provisional educator shall4not be renewed for individuals who hold an Educator5License with Stipulations and who have held a position6in a public school or non-public school recognized by7the State Board of Education.

8 (B) Alternative provisional educator. An 9 alternative provisional educator endorsement on an 10 Educator License with Stipulations may be issued to an 11 applicant who, at the time of applying for the 12 endorsement, has done all of the following:

(i) Graduated from a regionally accredited
college or university with a minimum of a
bachelor's degree.

16 (ii) Successfully completed the first phase of
17 the Alternative Educator Licensure Program for
18 Teachers, as described in Section 21B-50 of this
19 Code.

20 (iii) Passed a test of basic skills and content
21 area test, as required under Section 21B-30 of this
22 Code.

The alternative provisional educator endorsement is valid for 2 years of teaching and may be renewed for a third year by an individual meeting the requirements set forth in Section 21B-50 of this Code.

(C) Alternative provisional superintendent. An 1 alternative provisional superintendent endorsement on 2 3 an Educator License with Stipulations entitles the holder to serve only as a superintendent or assistant 4 5 superintendent in a school district's central office. This endorsement may only be issued to an applicant 6 7 who, at the time of applying for the endorsement, has done all of the following: 8 9 (i) Graduated from a regionally accredited 10 college or university with a minimum of a master's 11 degree in a management field other than education. 12 (ii) Been employed for a period of at least 5 13 years in a management level position in a field other than education. 14 15 (iii) Successfully completed the first phase 16 of an alternative route to superintendent 17 endorsement program, as provided in Section 21B-55 of this Code. 18 (iv) Passed a test of basic skills and content 19 20 area tests required under Section 21B-30 of this Code. 21 22 The endorsement may be registered for 2 fiscal 23 years in order to complete one full year of serving as 24 a superintendent or assistant superintendent. 25 Resident teacher endorsement. A resident (D) 26 teacher endorsement on an Educator License with

Stipulations may be issued to an applicant who, at the time of applying for the endorsement, has done all of the following:

4 (i) Graduated from a regionally accredited 5 institution of higher education with a minimum of a 6 bachelor's degree.

7 (ii) Enrolled in an approved Illinois educator8 preparation program.

9 (iii) Passed a test of basic skills and content 10 area test, as required under Section 21B-30 of this 11 Code.

12 The resident teacher endorsement on an Educator 13 License with Stipulations is valid for 4 years of 14 teaching and shall not be renewed.

A resident teacher may teach only under the direction of a licensed teacher, who shall act as the resident mentor teacher, and may not teach in place of a licensed teacher. A resident teacher endorsement on an Educator License with Stipulations shall no longer be valid after June 30, 2017.

(E) Career and technical educator. A career and technical educator endorsement on an Educator License with Stipulations may be issued to an applicant who has a minimum of 60 semester hours of coursework from a regionally accredited institution of higher education or an accredited trade and technical institution and

has a minimum of 2,000 hours of experience outside of education in each area to be taught.

The career and technical educator endorsement on 3 an Educator License with Stipulations is valid until 4 5 June 30 immediately following 5 years of the 6 endorsement being issued and may be renewed. For individuals who were issued the career and technical 7 educator endorsement on an Educator License with 8 9 Stipulations on or after January 1, 2015, the license 10 may be renewed if the individual passes a test of basic 11 skills or test of work proficiency, as required under 12 Section 21B-30 of this Code.

An individual who holds a valid career and technical educator endorsement on an Educator License with Stipulations but does not hold a bachelor's degree may substitute teach in career and technical education classrooms.

(F) Part-time provisional career and technical 18 19 educator or provisional career and technical educator. 20 A part-time provisional career and technical educator endorsement or a provisional career and technical 21 22 educator endorsement on an Educator License with 23 Stipulations may be issued to an applicant who has a 24 minimum of 8,000 hours of work experience in the skill 25 for which the applicant is seeking the endorsement. It 26 is the responsibility of each employing school board

office of 1 regional education to and provide verification, in writing, to the State Superintendent 2 3 of Education at the time the application is submitted that no qualified teacher holding a Professional 4 5 Educator License or an Educator License with 6 Stipulations with a career and technical educator 7 endorsement is available and that actual circumstances require such issuance. 8

9 The provisional career and technical educator 10 endorsement on an Educator License with Stipulations 11 is valid until June 30 immediately following 5 years of 12 the endorsement being issued and may be renewed for 5 13 years. For individuals who were issued the provisional 14 career and technical educator endorsement on an 15 Educator License with Stipulations on or after January 16 1, 2015, the license may be renewed if the individual passes a test of basic skills or test of work 17 proficiency, as required under Section 21B-30 of this 18 19 Code.

20 A part-time provisional career and technical educator endorsement on an Educator License with 21 22 Stipulations may be issued for teaching no more than 2 23 courses of study for grades 6 through 12. The part-time 24 provisional career and technical educator endorsement 25 on an Educator License with Stipulations is valid until 26 June 30 immediately following 5 years of the

endorsement being issued and may be renewed for 5 years if the individual makes application for renewal.

An individual who holds a provisional or part-time provisional career and technical educator endorsement on an Educator License with Stipulations but does not hold a bachelor's degree may substitute teach in career and technical education classrooms.

8 (G) Transitional bilingual educator. А 9 transitional bilingual educator endorsement on an 10 Educator License with Stipulations may be issued for 11 the purpose of providing instruction in accordance 12 with Article 14C of this Code to an applicant who 13 provides satisfactory evidence that he or she meets all 14 of the following requirements:

(i) Possesses adequate speaking, reading, and
writing ability in the language other than English
in which transitional bilingual education is
offered.

19(ii) Has the ability to successfully20communicate in English.

21 (iii) Either possessed, within 5 years 22 previous to his or her applying for a transitional 23 bilingual educator endorsement, а valid and comparable 24 comparable teaching certificate or 25 authorization issued by a foreign country or holds 26 a degree from an institution of higher learning in

a foreign country that the State Educator Preparation and Licensure Board determines to be the equivalent of a bachelor's degree from a regionally accredited institution of higher learning in the United States.

A transitional bilingual educator endorsement shall be valid for prekindergarten through grade 12, is valid until June 30 immediately following 5 years of the endorsement being issued, and shall not be renewed.

10 Persons holding a transitional bilingual educator 11 endorsement shall not be employed to replace any 12 presently employed teacher who otherwise would not be 13 replaced for any reason.

14 Language endorsement. Tn an effort. (H) to 15 alleviate the shortage of teachers speaking a language 16 other than English in the public schools, an individual 17 who holds an Educator License with Stipulations may 18 also apply for a language endorsement, provided that 19 the applicant provides satisfactory evidence that he 20 or she meets all of the following requirements:

21 (i) Holds a transitional bilingual22 endorsement.

(ii) Has demonstrated proficiency in the
language for which the endorsement is to be issued
by passing the applicable language content test
required by the State Board of Education.

(iii) Holds a bachelor's degree or higher from 1 2 a regionally accredited institution of higher education or, for individuals educated in 3 а country other than the United States, holds a 4 5 degree from an institution of higher learning in a 6 foreign country that the State Educator 7 Preparation and Licensure Board determines to be 8 the equivalent of a bachelor's degree from a 9 regionally accredited institution of higher 10 learning in the United States.

(iv) Has passed a test of basic skills, as
 required under Section 21B-30 of this Code.

13 A language endorsement on an Educator License with 14 Stipulations is valid for prekindergarten through 15 grade 12 for the same validity period as the 16 individual's transitional bilingual educator 17 endorsement on the Educator License with Stipulations and shall not be renewed. 18

19 (I) Visiting international educator. A visiting 20 international educator endorsement on an Educator 21 License with Stipulations may be issued to an 22 individual who is being recruited by a particular 23 school district that conducts formal recruitment programs outside of the United States to secure the 24 25 services of qualified teachers and who meets all of the 26 following requirements:

(i) Holds the equivalent of a minimum of a 1 2 bachelor's degree issued in the United States. 3 (ii) Has been prepared as a teacher at the grade level for which he or she will be employed. 4 5 (iii) Has adequate content knowledge in the 6 subject to be taught. 7 (iv) Has an adequate command of the English 8 language. 9 A holder of a visiting international educator 10 endorsement on an Educator License with Stipulations 11 shall be permitted to teach in bilingual education 12 programs in the language that was the medium of 13 instruction in his or her teacher preparation program, 14 provided that he or she passes the English Language 15 Proficiency Examination or another test of writing 16 skills in English identified by the State Board of

17Education, in consultation with the State Educator18Preparation and Licensure Board.

19A visiting international educator endorsement on20an Educator License with Stipulations is valid for 321years and shall not be renewed.

(J) Paraprofessional educator. A paraprofessional
 educator endorsement on an Educator License with
 Stipulations may be issued to an applicant who holds a
 high school diploma or its recognized equivalent and
 either holds an associate's degree or, except as

otherwise provided in Section 2-3.173 of this Code, a 1 2 minimum of 60 semester hours of credit from a 3 regionally accredited institution of higher education or has passed a test of basic skills required under 4 5 Section 21B-30 of this Code. Except as otherwise provided in Section 2-3.173 of this Code, the The 6 7 paraprofessional educator endorsement is valid until 8 June 30 immediately following 5 years of the 9 endorsement being issued and may be renewed through 10 application and payment of the appropriate fee, as 11 required under Section 21B-40 of this Code. An 12 individual who holds only a paraprofessional educator 13 endorsement is not subject to additional requirements 14 in order to renew the endorsement.

15Notwithstanding any other provision of this16paragraph (J), a paraprofessional educator endorsement17on an Educator License with Stipulations may be issued18to a qualified high school graduate under Section192-3.173 of this Code for each semester that the person20is participating in the Growing Future Educators21Program.

(K) Chief school business official. A chief school
business official endorsement on an Educator License
with Stipulations may be issued to an applicant who
qualifies by having a master's degree or higher, 2
years of full-time administrative experience in school

business management or 2 years of university-approved 1 2 practical experience, and a minimum of 24 semester 3 hours of graduate credit in a program approved by the State Board of Education for the preparation of school 4 administrators and by passage of 5 business the applicable State tests, including a test of basic 6 7 skills and applicable content area test.

8 The chief school business official endorsement may 9 also be affixed to the Educator License with 10 Stipulations of any holder who qualifies by having a 11 master's degree in business administration, finance, 12 accounting, or public administration and who completes 13 an additional 6 semester hours of internship in school 14 business management from a regionally accredited 15 institution of higher education and passes the 16 applicable State tests, including a test of basic 17 applicable content area test. skills and This endorsement shall be required for any individual 18 19 employed as a chief school business official.

The chief school business official endorsement on 20 21 an Educator License with Stipulations is valid until years of 22 June 30 immediately following 5 the 23 endorsement being issued and may be renewed if the 24 license holder completes renewal requirements as 25 required for individuals who hold a Professional 26 Educator License endorsed for chief school business

The State Board of Education shall adopt any rules necessary to implement <u>Public Act 100-288</u> this amendatory Act of the 100th General Assembly.

7 (L) Provisional in-state educator. A provisional in-state educator endorsement on an Educator License 8 9 with Stipulations may be issued to a candidate who has 10 completed an Illinois-approved educator preparation 11 program at an Illinois institution of higher education 12 and who successfully completed has not an 13 evidence-based assessment of teacher effectiveness but 14 who meets all of the following requirements:

(i) Holds at least a bachelor's degree.

(ii) Has completed an approved educator preparation program at an Illinois institution.

18 (iii) Has passed a test of basic skills and
19 applicable content area test, as required by
20 Section 21B-30 of this Code.

(iv) Has attempted an evidence-based
assessment of teacher effectiveness and received a
minimum score on that assessment, as established
by the State Board of Education in consultation
with the State Educator Preparation and Licensure
Board.

A provisional in-state educator endorsement on an Educator License with Stipulations is valid for one full fiscal year after the date of issuance and may not be renewed.

5 (3) Substitute Teaching License. A Substitute Teaching 6 License may be issued to qualified applicants for 7 substitute teaching in all grades of the public schools, 8 prekindergarten through grade 12. Substitute Teaching 9 Licenses are not eligible for endorsements. Applicants for 10 a Substitute Teaching License must hold a bachelor's degree 11 or higher from a regionally accredited institution of 12 higher education.

Substitute Teaching Licenses are valid for 5 years.

14 Substitute Teaching Licenses are valid for substitute 15 teaching in every county of this State. If an individual 16 has had his or her Professional Educator License or 17 Educator License with Stipulations suspended or revoked or 18 has not met the renewal requirements for licensure, then 19 that individual is not eligible to obtain a Substitute 20 Teaching License.

A substitute teacher may only teach in the place of a licensed teacher who is under contract with the employing board. If, however, there is no licensed teacher under contract because of an emergency situation, then a district may employ a substitute teacher for no longer than 30 calendar days per each vacant position in the district if

1 the district notifies the appropriate regional office of education within 5 business days after the employment of 2 3 the substitute teacher in the emergency situation. An emergency situation is one in which an unforeseen vacancy 4 5 has occurred and (i) a teacher is unable to fulfill his or her contractual duties or (ii) teacher capacity needs of 6 7 the district exceed previous indications, and the district 8 is actively engaged in advertising to hire a fully licensed 9 teacher for the vacant position.

10 There is no limit on the number of days that a 11 substitute teacher may teach in a single school district, 12 provided that no substitute teacher may teach for longer than 90 school days for any one licensed teacher under 13 14 contract in the same school year. A substitute teacher who 15 holds a Professional Educator License or Educator License 16 with Stipulations shall not teach for more than 120 school 17 days for any one licensed teacher under contract in the 18 same school year. The limitations in this paragraph (3) on 19 the number of days a substitute teacher may be employed do 20 not apply to any school district operating under Article 34 of this Code. 21
