The studying of this material shall constitute an 18 19 affirmation by students of their commitment to respect the 20 dignity of all races and peoples and to forever eschew every 21 form of discrimination in their lives and careers.
- The State Superintendent of Education may prepare and make available to all school boards instructional materials,

- 1 including those established by the Amistad Commission, which
- 2 may be used as guidelines for development of a unit of
- 3 instruction under this Section; provided, however, that each
- 4 school board shall itself determine the minimum amount of
- 5 instruction time which shall qualify as a unit of instruction
- 6 satisfying the requirements of this Section.

A community college may meet the requirements of this Section by offering an online course.
