AN ACT concerning State government.

## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

Section 5. The Department of Commerce and Economic
Opportunity Law of the Civil Administrative Code of Illinois is
amended by changing Section 605-705 as follows:

8 Sec. 605-705. Grants to local tourism and convention 9 bureaus.

(a) To establish a grant program for local tourism and 10 11 convention bureaus. The Department will develop and implement a program for the use of funds, as authorized under this Act, by 12 13 local tourism and convention bureaus. For the purposes of this 14 Act, bureaus eligible to receive funds are those local tourism and convention bureaus that are (i) either units of local 15 16 government or incorporated as not-for-profit organizations; (ii) in legal existence for a minimum of 2 years before July 1, 17 2001; (iii) operating with a paid, full-time staff whose sole 18 19 purpose is to promote tourism in the designated service area; 20 and (iv) affiliated with one or more municipalities or counties 21 that support the bureau with local hotel-motel taxes. After 22 July 1, 2001, bureaus requesting certification in order to receive funds for the first time must be local tourism and 23

1 convention bureaus that are (i) either units of local 2 government or incorporated as not-for-profit organizations; (ii) in legal existence for a minimum of 2 years before the 3 request for certification; (iii) operating with a paid, 4 5 full-time staff whose sole purpose is to promote tourism in the 6 designated service area; and (iv) affiliated with multiple municipalities or counties that support the bureau with local 7 8 hotel-motel taxes. Each bureau receiving funds under this Act 9 will be certified by the Department as the designated recipient 10 to serve an area of the State. Notwithstanding the criteria set 11 forth in this subsection (a), or any rule adopted under this 12 subsection (a), the Director of the Department may provide for 13 the award of grant funds to one or more entities if in the Department's judgment that action is necessary in order to 14 15 prevent a loss of funding critical to promoting tourism in a 16 designated geographic area of the State.

17 (b) To distribute grants to local tourism and convention bureaus from appropriations made from the Local Tourism Fund 18 19 for that purpose. Of the amounts appropriated annually to the 20 Department for expenditure under this Section prior to July 1, 2011, one-third of those monies shall be used for grants to 21 22 convention and tourism bureaus in cities with a population 23 greater than 500,000. The remaining two-thirds of the annual appropriation prior to July 1, 2011 shall be used for grants to 24 25 convention and tourism bureaus in the remainder of the State, 26 in accordance with a formula based upon the population served.

Of the amounts appropriated annually to the Department for 1 2 expenditure under this Section beginning July 1, 2011, 18% of 3 such moneys shall be used for grants to convention and tourism bureaus in cities with a population greater than 500,000. Of 4 5 the amounts appropriated annually to the Department for expenditure under this Section beginning July 1, 2011, 82% of 6 7 such moneys shall be used for grants to convention bureaus in 8 the remainder of the State, in accordance with a formula based 9 upon the population served. The Department may reserve up to 3% 10% of total local tourism funds available for costs of 10 11 administering the program to conduct audits of grants, to 12 provide incentive funds to those bureaus that will conduct 13 promotional activities designed to further the Department's 14 statewide advertising campaign, to fund special statewide 15 promotional activities, and to fund promotional activities 16 that support an increased use of the State's parks or historic 17 sites. The Department shall require that any convention and tourism bureau receiving a grant under this Section that 18 19 requires matching funds shall provide matching funds equal to 20 no less than 50% of the grant amount. During fiscal year 2013, the Department shall reserve \$2,000,000 of the available local 21 22 tourism funds for appropriation to the Historic Preservation 23 Agency for the operation of the Abraham Lincoln Presidential Library and Museum and State historic sites. 24
