#### SYNOPSIS AS INTRODUCED:

305 ILCS 5/5-36 new

Amends the Medical Assistance Article of the Illinois Public Aid Code. Provides that beginning no later than October 1, 2018, and for each State fiscal year thereafter, the monthly personal needs allowance required under Title XIX of the Social Security Act for any person residing in a facility licensed under the Community-Integrated Living Arrangements Licensure and Certification Act who is determined to be eligible for medical assistance under the Code and who is enrolled in the State's Home and Community-Based Services Waiver Program for adults with developmental disabilities shall be no less than 15% of the individual's monthly Supplemental Security Income benefits or Social Security Disability Insurance benefits, or both, for the previous calendar year. Establishes a similar personal needs allowance amount for any person residing in a facility licensed under the ID/DD Community Care Act who is determined to be eligible for medical assistance under the Code beginning no later than October 1, 2018 and for each State fiscal year thereafter. Effective immediately.

2 **Be it enacted by the People of the State of Illinois,**  
3 **represented in the General Assembly:**

4 Section 5. The Illinois Public Aid Code is amended by  
5 adding Section 5-36 as follows:

6 (305 ILCS 5/5-36 new)

7 Sec. 5-36. Personal needs allowance; Community-Integrated  
8 Living Arrangements; ID/DD facilities.

9 (a) Beginning no later than October 1, 2018, and for each  
10 State fiscal year thereafter, the monthly personal needs  
11 allowance required under Section 1902(q) of Title XIX of the  
12 Social Security Act (42 U.S.C. 1396a(q)) for any person  
13 residing in a facility licensed under the Community-Integrated  
14 Living Arrangements Licensure and Certification Act who is  
15 determined to be eligible for medical assistance under this  
16 Code and who is enrolled in the State's Home and  
17 Community-Based Services Waiver Program for adults with  
18 developmental disabilities shall be no less than 15% of the  
19 individual's monthly Supplemental Security Income benefits or  
20 Social Security Disability Insurance benefits, or both, for the  
21 previous calendar year.

22 (b) Beginning no later than October 1, 2018, and for each  
23 State fiscal year thereafter, the monthly personal needs

7 Section 99. Effective date. This Act takes effect upon  
8 becoming law.
