1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**

5 1, 2018. Notwithstanding anything in this Act to the contrary,
6 appropriations authorized in this Act shall be used for all
7 costs incurred prior to July 1, 2019.
