- 7 1979; in 2009, he was given the Reagan Trail Days Legacy Award;
- 8 in 2012 and 2016, he was gifted awards from the Inland Press
- 9 Association and in 2017, he was honored with a Distinguished
- 10 Service Award by the Illinois Press Association; and
- 11 WHEREAS, Tom Shaw is a true family man; he is happily
- 12 married to his wife, Tammy; they have six children, J. Tom,
- Ben, Peter, Kate, Mary, and Kylie; nine grandchildren; and 20
- 14 foster children; therefore, be it
