- 13 associations; he was a regent at the NRPA Maintenance
- 14 Management School, president of the Midwest Institute of Park
- 15 Executives, director of the IPRA Parks Section, and president

- 18 Illinois Association of Park Districts and a member of the NRPA

- 21 a Certified Park and Recreation Executive designation in 2011;
