2           WHEREAS, The Illinois Plumbing, Heating, Cooling  
3 Contractors Association is observing its 125th anniversary of  
4 service to the plumbing, heating, and cooling industry in the  
5 State of Illinois; and

6           WHEREAS, The Illinois Plumbing, Heating, Cooling  
7 Contractors Association has, during this significantly long  
8 period of service, continually promoted and encouraged higher  
9 standards and ethical practices in order to provide better  
10 service to the public; it has encouraged and aided the passage  
11 and enforcement of modern scientific and practical ordinances
