2	AMENDMENT NO Amend Senate Bill 267 by replacing
3	everything after the enacting clause with the following:
4	"Section 5. The Illinois Vehicle Code is amended by
5	changing Section 3-698 as follows:
6	(625 ILCS 5/3-698)
7	Sec. 3-698. U.S. Air Force License Plates.
8	(a) The Secretary, upon receipt of all applicable fees and
9	applications made in the form prescribed by the Secretary of
10	State, may issue special registration plates designated as U.S.
11	Air Force license plates to residents of Illinois who meet
12	eligibility requirements prescribed by the Secretary of State.
13	The special plate issued under this Section shall be affixed
14	only to passenger vehicles of the first division, motor
15	vehicles of the second division weighing not more than 8,000
16	pounds, and recreational vehicles as defined by Section 1-169

of this Code. Plates issued under this Section shall expire according to the multi-year procedure established by Section 3 3-414.1 of this Code.

4 (b) The design, color, and format of the plates shall be 5 wholly within the discretion of the Secretary of State, except that the U.S. Air Force emblem shall appear on the plates. The 6 Secretary may, in his or her discretion, allow the plates to be 7 8 issued as vanity or personalized plates in accordance with Section 3-405.1 of this Code. The plates are not required to 9 10 designate "Land Of Lincoln", as prescribed in subsection (b) of 11 Section 3-412 of this Code. The Secretary shall prescribe the eligibility requirements and, in his or her discretion, shall 12 13 approve and prescribe stickers or decals as provided under Section 3-412. 14

15 (c) An applicant shall be charged a \$20 fee for original 16 issuance in addition to the applicable registration fee. Of this additional fee, \$15 shall be deposited into the Secretary 17 of State Special License Plate Fund and \$5 shall be deposited 18 19 into the Octave Chanute Aerospace Heritage Fund. For each 20 registration renewal period, a \$20 fee, in addition to the appropriate registration fee, shall be charged. Of this 21 22 additional fee, \$2 shall be deposited into the Secretary of 23 State Special License Plate Fund and \$18 shall be deposited 24 into the Octave Chanute Aerospace Heritage Fund.

25 (d) The Octave Chanute Aerospace Heritage Fund is created26 as a special fund in the State treasury. All moneys in the

1	Octave Chanute Aerospace Heritage Fund shall be paid, subject
2	to appropriation by the General Assembly and approval by the
3	Secretary, as grants to the <u>Rantoul Historical Society and</u>
4	Museum, or any other charitable foundation responsible for the
5	former exhibits and collections of the Chanute Air Museum,
6	Octave Chanute Aerospace Heritage Foundation of Illinois for
7	operational and program expenses of the Chanute Air Museum and
8	any other structure housing exhibits and collections of the
9	Chanute Air Museum.
