1 AMENDMENT TO SENATE BILL 515

2 AMENDMENT NO. _____. Amend Senate Bill 515 by replacing
3 everything after the enacting clause with the following:

4 "Section 1. Short Title. This Act may be cited as the
5 Statewide Relocation Towing Licensure Commission Act of 2018.

6 Section 5. The Statewide Relocation Towing Licensure
7 Commission.

8 (a) The Statewide Relocation Towing Licensure Commission
9 is created.

10 (b) Within 60 days after the effective date of this Act,
11 the members of the Commission shall be appointed with the
12 following members:

13 (1) one member of the General Assembly, appointed by
14 the President of the Senate;

15 (2) one member of the General Assembly, appointed by
16 the Minority Leader of the Senate;

1 (3) one member of the General Assembly, appointed by
2 the Speaker of the House of Representatives;

3 (4) one member of the General Assembly, appointed by
4 the Minority Leader of the House of Representatives;

5 (5) the Mayor of the City of Chicago, or his or her
6 designee;

7 (6) the Secretary of Transportation, or his or her
8 designee;

9 (7) the Director of State Police, or his or her
10 designee;

11 (8) two members of the public who represent the towing
12 industry, appointed by the President of the Professional
13 Towing and Recovery Operators of Illinois;

14 (9) two members of the public who represent the
15 property casualty insurance industry, appointed by the
16 Executive Director of the Illinois Insurance Association;

17 (10) the President of the Illinois Municipal League, or
18 his or her designee;

19 (11) the President of the Illinois Sheriffs'
20 Association, or his or her designee;

21 (12) the Cook County State's Attorney, or his or her
22 designee;

23 (13) the Chairman of the Illinois Commerce Commission,
24 or his or her designee;

25 (14) the President of the Northwest Municipal
26 Conference, or his or her designee; and

1 (15) a member knowledgeable in auto financing, and
2 holds a valid license under the Consumer Installment Loan
3 Act, appointed by the Secretary of Financial and
4 Professional Regulation.

5 (c) The members of the Commission shall receive no
6 compensation for serving as members of the Commission.

7 (d) The Illinois Commerce Commission shall provide
8 administrative and other support to the Commission.

9 Section 10. Meetings.

10 (a) Each member of the Commission shall have voting rights
11 and all actions and recommendations shall be approved by a
12 simple majority vote of the members.

13 (b) The Commission shall meet no less than 3 times before
14 the report described in Section 15 is filed.

15 (c) At the initial meeting, the Commission shall elect one
16 member as a Chairperson, through a simple majority vote, who
17 shall thereafter call any subsequent meetings.

18 Section 15. Reporting.

19 (a) No later than December 31, 2019, the Commission shall
20 submit a report to the Governor and to the General Assembly,
21 which shall include, but is not limited to:

22 (1) an evaluation of the current towing laws in this
23 State;

24 (2) a recommendation for an appropriate towing

1 licensure program for this State;

2 (3) a review of all potential litigation costs for an
3 owner of an impounded vehicle, a towing company, and a
4 county or municipality; and

5 (4) any other matters the Commission deems necessary.

6 (b) The report to the General Assembly shall be filed with
7 the Clerk of the House of Representatives and the Secretary of
8 the Senate in electronic form only, in the manner that the
9 Clerk and the Secretary shall direct.

10 Section 20. Repealer. This Act is repealed on January 1,
11 2020.

12 Section 999. Effective date. This Act takes effect upon
13 becoming law.".
