SYNOPSIS AS INTRODUCED:

110 ILCS 49/15

Amends the Higher Education Veterans Service Act. Provides that a required survey and guidebook shall be made available on the homepage of a campus website or a veteran Internet link (instead of just the survey being made available on the homepage of the campus Internet link). Requires the survey to be sent to the Lieutenant Governor, Secretary of State, State Treasurer, and State Comptroller. Requires each public college and university to make its best efforts to hire a veteran of the armed services as the Coordinator of Veterans and Military Personnel Student Services.

AN ACT concerning education.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

4 Section 5. The Higher Education Veterans Service Act is 5 amended by changing Section 15 as follows:

6 (110 ILCS 49/15)

Sec. 15. Survey; coordinator; best practices report; best
efforts.

9 (a) All public colleges and universities shall, within 60 days after the effective date of this Act, conduct a survey of 10 the services and programs that are provided for veterans, 11 12 active duty military personnel, and their families, at each of 13 their respective campuses. This survey shall enumerate and 14 fully describe the service or program that is available, the number of veterans or active duty personnel using the service 15 16 or program, an estimated range for potential use within a 17 5-year and 10-year period, information on the location of the service or program, and how its administrators may be 18 19 contacted. The survey shall indicate the manner or manners in 20 which a student veteran may avail himself or herself of the 21 program's services. This survey must be made available to all 22 veterans matriculating at the college or university in the form of an orientation-related guidebook. 23

Each public college and university shall make the survey and guidebook available on the homepage of <u>the</u> all campus website or veteran Internet links as soon as practical after the completion of the survey. <u>Each</u> As soon as possible after the completion of the survey, each public college and university shall provide a copy of its survey to the following:

(1) the Board of Higher Education;

(2) the Department of Veterans' Affairs;

9 (3) the President and Minority Leader of the Senate and 10 the Speaker and Minority Leader of the House of 11 Representatives; and

12 (4) the Governor, Lieutenant Governor, Secretary of
 13 <u>State, State Treasurer, and State Comptroller</u>.

14 (b) Each public college and university shall, at its 15 discretion, (i) appoint, within 6 months after the effective 16 date of this Act, an existing employee or (ii) hire a new 17 employee to serve as a Coordinator of Veterans and Military Personnel Student Services on each campus of the college or 18 19 university that has an onsite, daily, full-time student 20 headcount above 1,000 students. Each public college and 21 university shall make its best efforts to hire a veteran of the 22 armed services as the Coordinator of Veterans and Military 23 Personnel Student Services.

The Coordinator of Veterans and Military Personnel Student Services shall be an ombudsperson serving the specific needs of student veterans and military personnel and their families and

shall serve as an advocate before the administration of the 1 2 college or university for the needs of student veterans. The college or university shall enable the Coordinator of Veterans 3 Military Personnel Student Services to communicate 4 and 5 directly with the senior executive administration of the college or university periodically. The college or university 6 7 shall retain unfettered discretion to determine the 8 organizational management structure of its institution.

9 In addition to any responsibilities the college or 10 university may assign, the Coordinator of Veterans and Military 11 Personnel Student Services shall make its best efforts to 12 create a centralized source for student veterans and military 13 personnel to learn how to receive all benefit programs and 14 services for which they are eligible.

15 Each college and university campus that is required to have 16 a Coordinator of Veterans and Military Personnel Student 17 Services shall regularly and conspicuously advertise the office location, phone number, and Internet access to the 18 19 Coordinator of Veterans and Military Personnel Student 20 Services, along with a brief summary of the manner in which he or she can assist student veterans. The advertisement shall 21 22 include, but is not necessarily limited to, the following:

Services shall facilitate other campus offices with the
 promotion of programs and services that are available.

3 (c) Upon receipt of all of the surveys under subsection (a) of this Section, the Board of Higher Education and the 4 5 Department of Veterans' Affairs shall conduct a joint review of the surveys and post, on any Internet home page they may 6 7 operate, a link to each survey as posted on the Internet 8 website for the college or university. Upon receipt of all of 9 the surveys, the Office of the Governor, through its military 10 affairs advisors, shall similarly conduct a review of the 11 surveys and post the surveys on its Internet website. Following 12 its review of the surveys, the Office of the Governor shall 13 submit an evaluation report to each college and university offering suggestions and insight on the conduct of student 14 15 veteran-related policies and programs.

(d) The Board of Higher Education and the Department of Veterans' Affairs may issue a best practices report to highlight those programs and services that are most beneficial to veterans and active duty military personnel. The report shall contain a fiscal needs assessment in conjunction with any program recommendations.

(e) Each college and university campus that is required to have a Coordinator of Veterans and Military Personnel Student Services under subsection (b) of this Section shall make its best efforts to create academic and social programs and services for veterans and active duty military personnel that

1 will provide reasonable opportunities for academic performance 2 and success.

3 Each public college and university shall make its best efforts to determine how its online educational curricula can 4 5 be expanded or altered to serve the needs of student veterans 6 and currently-deployed military, including a determination of 7 whether and to what extent the public colleges and universities can share existing technologies to improve the online curricula 8 9 of peer institutions, provided such efforts are both 10 practically and economically feasible.
