

## 100TH GENERAL ASSEMBLY State of Illinois 2017 and 2018 SB1364

Introduced 2/9/2017, by Sen. Napoleon Harris, III

## SYNOPSIS AS INTRODUCED:

225 ILCS 650/3 from Ch. 56 1/2, par. 303 225 ILCS 650/11 from Ch. 56 1/2, par. 311

Amends the Meat and Poultry Inspection Act. Provides that, beginning July 1, 2018, licenses issued to Type I and Type II establishments (meat and poultry processing and slaughtering) shall not expire if the licensee remains in compliance with the provisions of the Act. Provides that if the management at a Type I establishment desires to work under conditions which will require the services of a Department of Agriculture inspector on any Saturday, Sunday, or holiday, or for more than an approved work day on any other day shall request the Department representative (currently, Regional Administrator) to furnish inspection service during those times. Effective immediately.

- Section 5. The Meat and Poultry Inspection Act is amended by changing Sections 3 and 11 as follows:

- 8 (a) No person shall operate an establishment as defined in 9 Section 2 or act as a broker as defined in Section 2 without
- 10 first securing a license from the Department except as
- otherwise exempted. <u>Beginning July 1, 2018, licenses issued to</u>

5	Application for licenses shall be made to the Department in
6	writing on forms prescribed by the Department.

- (c) The license issued shall be in such form as the Department prescribes, shall be under the seal of the Department and shall contain the name of the licensee, the location for which the license is issued, the type of operation, the period of the license, and such other information as the Department requires. The original license or a certified copy of it shall be conspicuously displayed by the licensee in the establishment.
- (d) Failure to meet all of the conditions to retain a license may result in a denial of a renewal of a license. The licensee may request an administrative hearing to dispute the denial of renewal, after which the Director shall enter an order either renewing or refusing to renew the license.
- (e) A penalty of \$50 shall be assessed if renewal license applications are not received by July 1 of each year and establishment operations shall be discontinued until payment is received in full.

1 Sec. 11. Time of operation. The Director shall require 2 operations at Type I licensed establishments to be conducted 3 under inspection and during approved hours of operation. The 4 management of an official establishment desiring to work under 5 conditions which will require the services of an inspector of 6 the Department on any Saturday, Sunday, or holiday, or for more 7 than an approved work day on any other day shall, sufficiently 8 in advance of the period of overtime, request the Department 9 <u>representative</u> Regional Administrator to furnish inspection 10 service during such overtime period, and, if approved, shall be 11 allowed inspection on an overtime basis. 12 (Source: P.A. 91-170, eff. 1-1-00.)
