1 AN ACT concerning appropriations.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

4 ARTICLE 1 Section 1. The sum of \$1,395,400, or so much thereof as 5 6 may be necessary, is appropriated from the General Revenue Fund 7 to the Illinois Arts Council for operational expenses for the fiscal year ending June 30, 2018. 8 9 Section 5. The following named sums, or so much thereof 10 as may be necessary, respectively, for the objects and purposes hereinafter named, are appropriated to the Illinois Arts 11 12 Council to enhance the cultural environment in Illinois: 13 Payable from General Revenue Fund: 14 For Grants and Financial Assistance for 15 Creative Sector (Arts Organizations and Individual Artists)4,124,800 16 17 For Grants and Financial Assistance for 18 For Grants and Financial Assistance for 19 20

- 5 Section 10. The sum of \$1,000,000, or so much thereof as
- 6 may be necessary, is appropriated from the General Revenue Fund
- 7 to the Illinois Arts Council for the purpose of funding
- 8 administrative and grant expenses associated with programs
- 9 supporting the visual arts, performing arts, languages and
- 10 related activities.
- 11 Section 15. The amount of \$2,012,000, or so much thereof
- 12 as may be necessary, is appropriated from the General Revenue
- 13 Fund to the Illinois Arts Council for grants to certain public
- 14 radio and television stations and related administrative
- 15 expenses, pursuant to the Public Radio and Television Grant
- 16 Act.
- 17 Section 20. In addition to other amounts appropriated for
- 18 this purpose, the following named sum, or so much thereof as
- 19 may be necessary, respectively, for the object and purpose
- 20 hereinafter named, is appropriated to the Illinois Arts Council
- 21 to enhance the cultural environment in Illinois:

- 5 Section 25. The sum of \$417,000, for so much thereof as
- 6 may be necessary, is appropriated for a grant from the Illinois
- 7 Arts Council to the Illinois Humanities Council.
- 8 Section 99. Effective Date. This Act takes effect July
- 9 1, 2017, if and only if Senate Bill 2063 of the 100th General
- 10 Assembly (the Unbalanced Budget Response Act), as introduced
- in the Illinois Senate, becomes law.
