SYNOPSIS AS INTRODUCED:

Appropriates specified amounts to the Board of Trustees of the University of Illinois from various funds. Effective July 1, 2018.

A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 Section 5. The following named amounts, or so much thereof
5 as may be necessary, respectively, for the objects and purposes
6 hereinafter named, are appropriated to the Board of Trustees
7 of the University of Illinois to meet its ordinary and
8 contingent expenses:

9 For personal services, including, but not limited to,
10 payment to the University for personal services costs incurred
11 during the fiscal year and salaries accrued but unpaid to
12 academic personnel for personal services rendered during the
13 2018-2019 school year532,177,900

14 For State contributions to social security for Medicare
15 costs8,766,200

16 For group insurance 21,899,800

17 For contractual services 44,759,000

18 For costs associated with the School of Labor and
19 Employment Relations:

20 For degree programs 641,600

21 For certificate programs752,700

22 For distributive purposes:

23 Awards and grants 15,329,100

1 Total \$624,326,300

2 Section 10. The sum of \$14,803,100, or so much thereof as
3 may be necessary, is appropriated from the General Revenue Fund
4 to the Board of Trustees of the University of Illinois for the
5 costs and expenses related to or in support of the Prairie
6 Research Institute, in accordance with Public Act 95-0728.

7 Section 15. The sum of \$39,588,800, or so much thereof as
8 may be necessary, is appropriated from the General Revenue Fund
9 to the Board of Trustees of the University of Illinois for
10 operating costs and expenses related to or in support of the
11 University of Illinois Hospital.

12 Section 20. The sum of \$660,600, or so much thereof as may
13 be necessary, is appropriated from the Education Assistance
14 Fund to the Board of Trustees of the University of Illinois for
15 costs associated with the Hispanic Center of Excellence at the
16 Chicago campus.

17 Section 25. The sum of \$271,200, or so much thereof as may
18 be necessary, is appropriated from the Education Assistance
19 Fund to the Board of Trustees of the University of Illinois for
20 Dixon Springs Agricultural Center.

1 Section 30. The sum of \$1,032,100, or so much thereof as
2 may be necessary, is appropriated from the Education Assistance
3 Fund to the Board of Trustees of the University of Illinois for
4 costs associated with the Public Policy Institute at the
5 Chicago campus.

6 Section 35. The sum of \$289,000, or so much thereof as may
7 be necessary, is appropriated from the Education Assistance
8 Fund to the Board of Trustees of the University of Illinois for
9 a grant to the College of Dentistry.

10 Section 40. The sum of \$4,155,700, or so much thereof as
11 may be necessary, is appropriated from the Fire Prevention Fund
12 to the Board of Trustees of the University of Illinois for the
13 purpose of maintaining the Illinois Fire Service Institute,
14 paying the Institute's expenses, and providing the Institute's
15 facilities and structures, including, but not limited to,
16 payment to the University for personal services and related
17 incurred costs.

18 Section 45. The sum of \$250,000, or so much thereof as may
19 be necessary, is appropriated from the State College and
20 University Trust Fund to the Board of Trustees of the University
21 of Illinois for scholarship grant awards, in accordance with
22 Public Act 91-0083.

1 Section 50. The sum of \$300,000, or so much thereof as may
2 be necessary, is appropriated from the Emergency Public Health
3 Fund to the University of Illinois for costs and expenses
4 related to or in support of emergency mosquito abatement.

5 Section 55. The sum of \$400,000, or so much thereof as may
6 be necessary, is appropriated from the Used Tire Management
7 Fund to the University of Illinois for costs and expenses
8 related to or in support of mosquito research and abatement.

9 Section 60. The sum of \$500,000, or so much thereof as may
10 be necessary, is appropriated from the Hazardous Waste Research
11 Fund to the University of Illinois for its ordinary and
12 contingent expenses.

13 Section 65. The sum of \$500,000, or so much thereof as may
14 be necessary, is appropriated from the General Professions
15 Dedicated Fund to the Board of Trustees of the University of
16 Illinois for costs associated with the development, support,
17 or administration of pharmacy practice education or training
18 programs for the College of Medicine at Rockford.

19 Section 99. Effective date. This Act takes effect July 1,
20 2019.
