A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The sum of \$0, or so much thereof as may be
6 necessary, is appropriated to the Illinois Student Assistance
7 Commission from the General Revenue Fund for costs associated
8 with marketing for the College Illinois! Prepaid Tuition
9 Program.

10 Section 10. The following named amount, or so much thereof
11 as may be necessary, is appropriated from the General Revenue
12 Fund to the Illinois Student Assistance Commission for the
13 following purpose:

14 To support outreach, research, and
15 training activities997,700

16 Section 15. The sum of \$401,341,900, or so much thereof
17 as may be necessary, is appropriated to the Illinois Student
18 Assistance Commission from the General Revenue Fund for grant
19 awards to students eligible for the Monetary Award Program, as
20 provided by law, and for agency administrative and operational

1 costs not to exceed 2 percent of the total appropriation in
2 this Section.

3 Section 20. The sum of \$26,400, or so much thereof as may
4 be necessary, is appropriated from the Education Assistance
5 Fund to the Illinois Student Assistance Commission for costs
6 associated with the Veterans' Home Nurses' Loan Repayment
7 Program pursuant to Public Act 95-0576.

8 Section 25. The sum of \$264,000, or so much thereof as may
9 be necessary, is appropriated from the Education Assistance
10 Fund to the Illinois Student Assistance Commission for grants
11 to eligible nurse educators to use for payment of their
12 educational loan pursuant to Public Act 94-1020.

13 Section 30. The following named sums, or so much thereof
14 as may be necessary, respectively, are appropriated from the
15 Education Assistance Fund to the Illinois Student Assistance
16 Commission for the following purposes:

17 Grants and Scholarships

18 For the payment of scholarships to students
19 who are children of policemen or firemen
20 killed in the line of duty, or who are
21 dependents of correctional officers killed
22 or permanently disabled in the line of

1	duty, as provided by law	1,237,400
2	For payment of Minority Teacher Scholarships	<u>1,900,000</u>
3	Total	\$3,137,400

4 Section 35. The sum of \$6,498,800, or so much thereof as
5 may be necessary, is appropriated from the Education Assistance
6 Fund to the Illinois Student Assistance Commission to the
7 Golden Apple Scholars of Illinois program, as provided by law.

8 Section 40. The sum of \$439,900, or so much thereof as may
9 be necessary, is appropriated from the Education Assistance
10 Fund to the Illinois Student Assistance Commission for the Loan
11 Repayment for Teachers Program.

12 Section 45. The sum of \$19,921,300 or so much thereof as
13 may be necessary, is appropriated to the Illinois Student
14 Assistance Commission from the Education Assistance Fund for
15 payment of military veterans' scholarships at state-controlled
16 universities and at public community colleges for students
17 eligible, as provided by law.

18 Section 50. The sum of \$11,343,000 or so much thereof as
19 may be necessary, is appropriated to the Illinois Student
20 Assistance Commission from the Education Assistance Fund for
21 payment of Illinois National Guard and Naval Militia

1 Scholarships at state-controlled universities and at public
2 community colleges for students eligible, as provided by law.

3 Section 55. The sum of \$300,000, or so much thereof as may
4 be necessary, is appropriated from the ISAC Accounts Receivable
5 Fund to the Illinois Student Assistance Commission for costs
6 associated with the collection of delinquent scholarship awards
7 pursuant to the Illinois State Collection Act of 1986.

8 Section 60. The sum of \$110,000, or so much thereof as may
9 be necessary, is appropriated to the Illinois Student
10 Assistance Commission from the University Grant Fund for
11 payment of grants for the Higher Education License Plate
12 Program, as provided by law.

13 Section 65. The following named sum, or so much thereof
14 as may be necessary, is appropriated from the Illinois Student
15 Assistance Commission Contracts and Grants Fund to the Illinois
16 Student Assistance Commission for the following purpose:

17 To support outreach, research, and
18 training activities10,000,000

19 Section 70. The following named sum, or so much thereof
20 as may be necessary, is appropriated from the Optometric
21 Licensing and Disciplinary Board Fund to the Illinois Student

1 Assistance Commission for the following purpose:

2 Grants and Scholarships

3 For payment of scholarships for the

4 Optometric Education Scholarship

5 Program, as provided by law50,000

6 Section 75. The following named sum, or so much thereof
7 as may be necessary, is appropriated from the National Guard
8 and Naval Militia Grant Fund to the Illinois Student Assistance
9 Commission for the following purpose:

10 Grants and Scholarships

11 For payment of Illinois National Guard and

12 Naval Militia Scholarships

13 at State-controlled universities

14 and public community colleges in

15 Illinois to students eligible to

16 receive such awards, as provided by law20,000

17 Section 80. The sum of \$100,000, or so much thereof as may
18 be necessary, is appropriated from the Golden Apple Scholars
19 of Illinois Fund to the Illinois Student Assistance Commission
20 for the Golden Apple Scholars of Illinois Program, as provided
21 by law.

22 Section 85. The following named sums, or so much thereof

1 as may be necessary, respectively, are appropriated to the
 2 Illinois Student Assistance Commission from the Student Loan
 3 Operating Fund for its ordinary and contingent expenses:

20 Section 90. The sum of \$2,500,000, or so much thereof as
 21 may be necessary, is appropriated to the Illinois Student
 22 Assistance Commission from the Student Loan Operating Fund for
 23 costs associated with Federal Loan System Development and
 24 Maintenance.

1 Section 95. The sum of \$1,000,000 or so much thereof as
 2 may be necessary, is appropriated to the Illinois Student
 3 Assistance Commission from the Student Loan Operating Fund for
 4 costs associated with the Illinois Designated Account Purchase
 5 Program.

6 Section 100. The sum of \$10,000,000, or so much thereof
 7 as may be necessary, is appropriated to the Illinois Student
 8 Assistance Commission from the Student Loan Operating Fund for
 9 distribution as necessary for the following: for payment of
 10 collection agency fees associated with collection activities
 11 for Federal Family Education Loans, for Default Aversion Fee
 12 reversals, and for distributions as necessary and provided for
 13 under the Federal Higher Education Act.

14 Section 105. The following named sum, or so much thereof
 15 as may be necessary, is appropriated from the Federal
 16 Congressional Teacher Scholarship Program Fund to the Illinois
 17 Student Assistance Commission for the following purpose:

18 For transferring repayment funds collected
 19 under the Paul Douglas Teacher Scholarship
 20 Program to the U.S. Treasury400,000

21 Section 110. The sum of \$200,000,000, or so much thereof

1 as may be necessary, is appropriated from the Federal Student
2 Loan Fund to the Illinois Student Assistance Commission for
3 distribution when necessary as a result of the following: for
4 guarantees of loans that are uncollectible, for collection
5 payments to the Student Loan Operating Fund as required under
6 agreements with the United States Secretary of Education, for
7 payment to the Student Loan Operating Fund for Default Aversion
8 Fees, for transfers to the U.S. Treasury, or for other
9 distributions as necessary and provided for under the Federal
10 Higher Education Act.

11 Section 115. The sum of \$13,000,000, or so much thereof
12 as may be necessary, is appropriated from the Federal Student
13 Incentive Trust Fund to the Illinois Student Assistance
14 Commission for allowable uses of federal grant funds related
15 to college access, outreach, and training, including but not
16 limited to funds received under the federal Gaining Early
17 Awareness and Readiness for Undergraduate Program.

18 Section 120. The sum of \$300,000, or so much thereof as
19 may be necessary, is appropriated from the Federal Student
20 Incentive Trust Fund to the Illinois Student Assistance
21 Commission for the John R. Justice Student Loan Repayment
22 Program.

1 Section 999. Effective Date. This Act takes effect July
2 1, 2018. Notwithstanding anything in this Act to the contrary,
3 appropriations authorized in this Act shall be used for all
4 costs incurred prior to July 1, 2019.
