2 WHEREAS, The members of the Illinois Senate are saddened to 3 learn of the death of Robbie C. Shoemaker Heitzman of Moline, 4 who passed away on August 29, 2017; and

5 WHEREAS, Robbie Heitzman was born in Nashville, Tennessee 6 to Pallie Pack and Charlie Morris on July 9, 1924; she moved to 7 Chicago at the age of three with her mother and graduated from 8 South Shore High School; and

WHEREAS, Robbie Heitzman worked for the New York Central Railroad before joining the United States Navy WAVES (Women Accepted for Volunteer Emergency Service) during World War II serving in communication intelligence as a telegrapher 3rd class; after her discharge in 1946, she attended the University of Illinois; she married George Shoemaker Jr. in Chicago on June 14, 1947; and

WHEREAS, Robbie Heitzman worked with her husband in the home building industry, where she decorated many show houses; she later worked for the United States Army Corps of Engineers in the Contracting Division, retiring in 1990; she founded a catering service from which she retired in 1999; after the passing of her first husband, she married Dale Heitzman in Rock Island on July 17, 1999; and

- 9 Craig (Janet) Shoemaker, Dawn (Blair) Gorsuch, and Kenn (Kathy)
