WHEREAS, Charles Curry was born in Starkville, Mississippi to Annie Laura (Pearson) and George Curry Sr. on July 30, 1938; as a young man, he spent time with his father, learning about the family businesses, including a grocery store, a gas station, and a farm; he would often sneak on to the back of the pick up truck to accompany his father; each day he would take his father an afternoon snack of homemade cake and a cup of coffee; as a child, he was a member of the Zion Franklin United Methodist Church in Starkville, where his parents were active members; and

WHEREAS, Charles Curry began selling milk, although he never actually milked the cows, and received his first check for his service at the age of 12, igniting his entrepreneurial spirit; he also learned to drive at an early age, even before he was tall enough to see over the steering wheel; he drove the school bus to transport his classmates to school, sparking his love for driving and appreciation of cars; he loved old cars and believed they should always be clean; he could often be found washing his truck or one of his cars outside of C. P.
