11 (a) The Secretary, upon receipt of all applicable fees and applications made in the form prescribed by the Secretary of 12 13 State, may issue, without the collection of any additional fee, special registration plates designated as U.S. Air Force 14 15 license plates to residents of Illinois who meet eligibility 16 requirements prescribed by the Secretary of State. The special 17 plate issued under this Section shall be affixed only to 18 passenger vehicles of the first division, motor vehicles of the second division weighing not more than 8,000 pounds, and 19 20 recreational vehicles as defined by Section 1-169 of this Code. 21 Plates issued under this Section shall expire according to the multi-year procedure established by Section 3-414.1 of this 22

2 (b) The design, color, and format of the plates shall be wholly within the discretion of the Secretary of State, except 3 that the U.S. Air Force emblem shall appear on the plates. The 4 5 Secretary may, in his or her discretion, allow the plates to be 6 issued as vanity or personalized plates in accordance with 7 Section 3-405.1 of this Code. The plates are not required to designate "Land Of Lincoln", as prescribed in subsection (b) of 8 Section 3-412 of this Code. The Secretary shall prescribe the 9 10 eligibility requirements and, in his or her discretion, shall 11 approve and prescribe stickers or decals as provided under 12 Section 3-412.

13 (c) (Blank). An applicant shall be charged a \$20 fee original issuance in addition to the applicable registration 14 fee. Of this additional fee, \$15 shall be deposited into the 15 16 Secretary of State Special License Plate Fund and \$5 shall be 17 deposited into the Octave Chanute Aerospace Heritage Fund. For each registration renewal period, a \$20 fee, in addition to the 18 appropriate registration fee, shall be charged. Of this 19 20 additional fee, \$2 shall be deposited into the Secretary of State Special License Plate Fund and \$18 shall be deposited 21 22 into the Octave Chanute Acrospace Heritage Fund.

(d) (Blank). The Octave Chanute Aerospace Heritage Fund is
 created as a special fund in the State treasury. All moneys in
 the Octave Chanute Aerospace Heritage Fund shall be paid,
 subject to appropriation by the General Assembly and approval
