1 AMENDMENT TO HOUSE BILL 2336 AMENDMENT NO. _____. Amend House Bill 2336 by replacing 2 everything after the enacting clause with the following: 3 "Section 1. It is the intent of the General Assembly that 4 5 all references made to vehicle license plates and license plate stickers be construed to include electronic vehicle license 6 7 plates and vehicle stickers as approved by the Secretary of State. It is the policy of this State to encourage the issuance 8 9 of a combination of metal and electronic license plates and vehicle stickers. 10 11 Section 5. The State Vehicle Identification Act is amended by changing Sections 2 and 3 as follows: 12

registration plate or digital registration plate covers or any covers, coating, wrappings, materials, streaking, distorting, holographic, reflective, or other devices that obstruct the visibility or electronic image recording of the plate or digital registration plate. This subsection (a) shall not apply to automatic vehicle identification transponder devices, cards or chips issued by a governmental body or authorized by a governmental body for the purpose of electronic payment of tolls or other authorized payments, the exemption of which shall preempt any local legislation to the contrary.

(b) If a State or local law enforcement officer having jurisdiction observes that a cover or other device or material or substance is obstructing the visibility or electronic image recording of the plate, the officer shall issue a Uniform Traffic Citation and shall confiscate the cover or other device that obstructs the visibility or electronic image recording of the plate. If the State or local law enforcement officer having jurisdiction observes that the plate itself has been physically treated with a substance or material that is obstructing the visibility or electronic image recording of the plate, the officer shall issue a Uniform Traffic Citation and shall confiscate the plate. The Secretary of State shall revoke the registration of any plate that has been found by a court or administrative tribunal to have been physically altered with any chemical or reflective substance or coating that obstructs the visibility or electronic image recording of the plate. A

- 1 fine of \$750 shall be imposed in any instance where a plate
- cover obstructs the visibility or electronic image recording of 2
- the plate. A fine of \$1,000 shall be imposed where a plate has 3
- 4 been physically altered with any chemical or reflective
- 5 substance or coating that obstructs the visibility or
- 6 electronic image recording of the plate.
- (c) The Illinois Attorney General may file suit against any 7
- individual or entity offering or marketing the sale, including 8
- 9 via the Internet, of any product advertised as having the
- 10 capacity to obstruct the visibility or electronic image
- 11 recording of a license plate or digital registration plate. In
- addition to injunctive and monetary relief, punitive damages, 12
- 13 and attorneys fees, the suit shall also seek a full accounting
- of the records of all sales to residents of or entities within 14

"Registration plate or digital registration plate cover" means any tinted, colored, painted, marked, clear, illuminated object that is designed to (i) cover any of the characters of a motor vehicle's registration plate or digital registration plate; or (ii) distort a recorded image of any of the characters of a motor vehicle's registration plate or digital registration plate recorded by an automated enforcement system as defined in Section 11-208.6, 11-208.8, or 11-1201.1 of this Code or recorded by an automated traffic control system as defined in Section 15 of the Automated Traffic Control Systems in Highway Construction or Maintenance Zones Act.

"Rental Owner" means an owner principally engaged, with respect to one or more rental fleets, in renting to others or offering for rental the vehicles of such fleets, without drivers.

"Restricted Plates" shall include, but is not limited to, dealer, manufacturer, transporter, farm, repossessor, and permanently mounted type plates. Vehicles displaying any of these type plates from a foreign jurisdiction that is a member of the International Registration Plan shall be granted reciprocity but shall be subject to the same limitations as similar plated Illinois registered vehicles.

Sec. 3-401.5. Commercial digital registration plates.

- (a) The Secretary of State shall implement a pilot program for the creation of commercial digital registration plates for the purpose of (i) providing accurate and reliable information to law enforcement regarding specific uses of commercial vehicles; (ii) reducing abuse and increasing compliance with the use and transfer of commercial license plates; (iii) providing for dual-number commercial digital registration plates and a dynamic plate numbering system with dynamic expiration for commercial digital registration plates; (iv) providing commercial digital registration plates for commercial vehicle sharing, car-sharing platforms, and non-owned commercial vehicle usage; (v) providing temporary and dynamic license plate numbering for temporary operational uses of commercial trucks, including U.S. Department of Transportation numbers and placards; and (vi) generating revenue for the State by and through in-state and out-of-state licensing for utilization across all states. This program shall only be available to no more than 1,000 motor vehicles that are used commercially, used for hire, or owned by a commercial business.
 - (b) As used in this Section:

24 "Commercial digital registration plate" means an 25 electronic display that is mounted on the back or side of a

- 9 (4) Other instruments deemed appropriate by the 10 Secretary.
 - (e) The Secretary shall enter into a contract by December 31, 2019 with a private vendor for the purposes of researching, reporting, developing, acquiring, and implementing the utilization of a commercial digital registration plate for operational uses of commercial vehicles. The contract shall include a requirement that the private vendor pay for the costs of all relevant activities incurred by the Secretary for implementation of the program pursuant to this Section. The contract shall permit the vendor to charge a fee for each operational use of a commercial digital registration plate. The vendor shall be permitted to retain 100% of the fee charged for each operational use until such time that it recovers its upfront costs of implementing the program, then 50% of the fee charged for each such use thereafter. The remainder shall be remitted to the Secretary for deposit into the Secretary of State Special License Plate Fund. The contract shall also

- 1 include a confidentiality provision sufficient to provide
- protection for the vendor's proprietary information and 2
- 3 methods.
- 4 All commercial digital registration plates used in this
- 5 State shall be capable of clearly displaying digital numbering
- 6 and must be capable of detection by equipment owned and
- operated by the Illinois State Toll Highway Authority. 7
- (f) Each operational use of a dynamic license plate number 8
- 9 shall require the vendor to utilize a variety of driver data,
- 10 including, but not limited to, cross-checking motor vehicle
- 11 records and the Global Terrorist Watch List database before
- issuing and authorizing the dynamic license plate number and 12
- 13 operational use. In no event shall any dynamic license plate
- 14 number be issued until after an applicant selects and purchases
- 15 temporary operational use insurance as made available through
- 16 the vendor. Such insurance shall be effective for the duration
- of the operational use and all properly licensed insurance 17
- providers may participate in the program. Each operational use 18

- (3) Any special mobile equipment as herein defined;
- (4) Any vehicle which is propelled exclusively by electric power obtained from overhead trolley wires though not operated upon rails;
- (5) Any vehicle which is equipped and used exclusively as a pumper, ladder truck, rescue vehicle, searchlight truck, or other fire apparatus, but not a vehicle of a type which would otherwise be subject to registration as a vehicle of the first division;
- (6) Any vehicle which is owned and operated by the federal government and externally displays evidence of federal ownership. It is the policy of the State of Illinois to promote and encourage the fullest use of its highways and to enhance the flow of commerce thus contributing to the economic, agricultural, industrial and social growth and development of this State, by authorizing the Secretary of State to negotiate and enter into reciprocal or proportional agreements or arrangements with other States, or to issue declarations setting forth reciprocal exemptions, benefits and privileges with respect to vehicles operated interstate which are properly registered in this and other States, assuring nevertheless proper registration of vehicles in Illinois as may be required by this Code;

- (7) Any converter dolly or tow dolly which merely serves as substitute wheels for another legally licensed vehicle. A title may be issued on a voluntary basis to a tow dolly upon receipt of the manufacturer's certificate of origin or the bill of sale;
 - (8) Any house trailer found to be an abandoned mobile home under the Abandoned Mobile Home Act;
 - (9) Any vehicle that is not properly registered or does not have registration plates or digital registration plates issued to the owner or operator affixed thereto, or that does have registration plates or digital registration plates issued to the owner or operator affixed thereto but the plates are not appropriate for the weight of the vehicle, provided that this exemption shall apply only while the vehicle is being transported or operated by a towing service and has a third tow plate affixed to it.
- B. Reciprocity. Any motor vehicle, trailer, semitrailer or pole trailer need not be registered under this Code provided the same is operated interstate and in accordance with the following provisions and any rules and regulations promulgated pursuant thereto:
 - (1) A nonresident owner, except as otherwise provided in this Section, owning any foreign registered vehicle of a type otherwise subject to registration hereunder, may operate or permit the operation of such vehicle within this State in interstate commerce without registering such

vehicle in, or paying any fees to, this State subject to the condition that such vehicle at all times when operated in this State is operated pursuant to a reciprocity agreement, arrangement or declaration by this State, and further subject to the condition that such vehicle at all times when operated in this State is duly registered in, and displays upon it, a valid registration card and registration plate or plates or digital registration plate or plates issued for such vehicle in the place of residence of such owner and is issued and maintains in such vehicle a valid Illinois reciprocity permit as required by the Secretary of State, and provided like privileges are afforded to residents of this State by the State of residence of such owner.

Every nonresident including any foreign corporation carrying on business within this State and owning and regularly operating in such business any motor vehicle, trailer or semitrailer within this State in intrastate commerce, shall be required to register each such vehicle and pay the same fees therefor as is required with reference to like vehicles owned by residents of this State.

- (2) Any motor vehicle, trailer, semitrailer and pole trailer operated interstate need not be registered in this State, provided:
 - (a) that the vehicle is properly registered in

another State pursuant to law or to a reciprocity agreement, arrangement or declaration; or

- (b) that such vehicle is part of a fleet of vehicles owned or operated by the same person who registers such fleet of vehicles pro rata among the various States in which such fleet operates; or
- (c) that such vehicle is part of a fleet of vehicles, a portion of which are registered with the Secretary of State of Illinois in accordance with an agreement or arrangement concurred in by the Secretary of State of Illinois based on one or more of the following factors: ratio of miles in Illinois as against total miles in all jurisdictions; situs or base of a vehicle, or where it is principally garaged, or from whence it is principally dispatched or where the movements of such vehicle usually originate; situs of the residence of the owner or operator thereof, or of his principal office or offices, or of his places of business; the routes traversed and whether regular or irregular routes are traversed, and the jurisdictions traversed and served; and such other factors as may be deemed material by the Secretary and the motor vehicle administrators of the other jurisdictions involved in such apportionment. School districts that have one or more school buses equipped with an automated traffic law enforcement system must provide notice to drivers by posting that information on their websites.

Each second division motor vehicle that pulls or draws a trailer, semitrailer or pole trailer, with a gross weight of 10,001 lbs or more or is registered for a gross weight of 10,001 lbs or more, motor bus, religious organization bus, school bus, senior citizen transportation vehicle, and limousine shall be subject to inspection by the Department and the Department is authorized to establish rules and regulations for the implementation of such inspections.

The owners of each salvage vehicle shall submit it to a "safety test" and secure a certificate of safety furnished by the Department prior to its salvage vehicle inspection pursuant to Section 3-308 of this Code. In implementing and enforcing the provisions of this Section, the Department and other authorized State agencies shall do so in a manner that is not inconsistent with any applicable federal law or regulation so that no federal funding or support is jeopardized by the enactment or application of these provisions.

However, none of the provisions of Chapter 13 requiring safety tests or a certificate of safety shall apply to:

- (a) farm tractors, machinery and implements, wagons, wagon-trailers or like farm vehicles used primarily in agricultural pursuits;
- (b) vehicles other than school buses, tow trucks and medical transport vehicles owned or operated by a municipal corporation or political subdivision having a population

- 1 of 1,000,000 or more inhabitants and which are subject to safety tests imposed by local ordinance or resolution; 2

For driver education vehicles used by public high schools, the vehicle must also be equipped with dual control brakes, a mirror on each side of the vehicle so located as to reflect to the driver a view of the highway for a distance of at least 200 feet to the rear, and a sign visible from the front and the rear identifying the vehicle as a driver education car.

For trucks, truck tractors, trailers, semi-trailers, buses, and first division vehicles including taxis which are used for a purpose that requires a school bus driver permit, the safety test shall be conducted in accordance with the Minimum Periodic Inspection Standards promulgated by the Federal Highway Administration of the U.S. Department of Transportation and contained in Appendix G to Subchapter B of Chapter III of Title 49 of the Code of Federal Regulations. Those standards, as now in effect, are made a part of this Code, in the same manner as though they were set out in full in this Code.

The passing of the safety test shall not be a bar at any time to prosecution for operating a second division vehicle, medical transport vehicle, motor vehicle used for driver education training, or vehicle designed to carry 15 or fewer passengers operated by a contract carrier as provided in this Section that is unsafe, as determined by the standards prescribed in this Code.

- (a) Computer-Matched Enforcement.
- (1) The provisions of this subsection (a) are operative until the implementation of the registration denial enforcement mechanism required by subsection (b).
