2	AMENDMENT NO Amend House Bill 2336 by replacing
3	everything after the enacting clause with the following:
4	"Section 1. It is the intent of the General Assembly that
5	all references made to vehicle license plates and license plate

7	plates and vehicle stickers as approved by the Secretary of
8	State. It is the policy of this State to encourage the issuance
9	of a combination of metal and electronic license plates and
10	vehicle stickers.

registration plate or digital registration plate covers or any covers, coating, wrappings, materials, streaking, distorting, holographic, reflective, or other devices that obstruct the visibility or electronic image recording of the plate or digital registration plate. This subsection (a) shall not apply to automatic vehicle identification transponder devices, cards or chips issued by a governmental body or authorized by a governmental body for the purpose of electronic payment of tolls or other authorized payments, the exemption of which shall preempt any local legislation to the contrary.

(b) If a State or local law enforcement officer having jurisdiction observes that a cover or other device or material or substance is obstructing the visibility or electronic image recording of the plate, the officer shall issue a Uniform Traffic Citation and shall confiscate the cover or other device that obstructs the visibility or electronic image recording of the plate. If the State or local law enforcement officer having jurisdiction observes that the plate itself has been physically treated with a substance or material that is obstructing the visibility or electronic image recording of the plate, the officer shall issue a Uniform Traffic Citation and shall confiscate the plate. The Secretary of State shall revoke the registration of any plate that has been found by a court or administrative tribunal to have been physically altered with any chemical or reflective substance or coating that obstructs the visibility or electronic image recording of the plate. A

- 1 fine of \$750 shall be imposed in any instance where a plate
- 2 cover obstructs the visibility or electronic image recording of
- 3 the plate. A fine of \$1,000 shall be imposed where a plate has
- 4 been physically altered with any chemical or reflective
- 5 substance or coating that obstructs the visibility or
- 6 electronic image recording of the plate.
- 7 (c) The Illinois Attorney General may file suit against any
- 8 individual or entity offering or marketing the sale, including

"Registration plate or digital registration plate cover" means any tinted, colored, painted, marked, clear, illuminated object that is designed to (i) cover any of the characters of a motor vehicle's registration plate or digital registration plate; or (ii) distort a recorded image of any of the characters of a motor vehicle's registration plate or digital registration plate recorded by an automated enforcement system as defined in Section 11-208.6, 11-208.8, or 11-1201.1 of this Code or recorded by an automated traffic control system as defined in Section 15 of the Automated Traffic Control Systems in Highway Construction or Maintenance Zones Act.

"Rental Owner" means an owner principally engaged, with respect to one or more rental fleets, in renting to others or offering for rental the vehicles of such fleets, without drivers.

"Restricted Plates" shall include, but is not limited to, dealer, manufacturer, transporter, farm, repossessor, and permanently mounted type plates. Vehicles displaying any of these type plates from a foreign jurisdiction that is a member of the International Registration Plan shall be granted reciprocity but shall be subject to the same limitations as similar plated Illinois registered vehicles.

- 4 (a) The Secretary of State may authorize the issuance of a 5 digital registration plate to a vehicle, in lieu of a set of static, metal registration plates, if the vehicle owner 6 separately purchases the digital registration plate for a 7 particular vehicle. The Secretary shall work with the vehicle 8 9 owner and the distributor of the digital registration plates to 10 coordinate the appropriate plate image and registration 11 expiration to appear on the digital registration plate. One

- 14 (b) The Secretary, for any vehicle owner that purchases a digital registration plate, may electronically renew the 15 digital registration plate upon receiving the appropriate 16 renewal registration fee as set forth in this Code. operational use of a commercial digital registration plate. The vendor shall be permitted to retain 100% of the fee charged for each operational use until such time that it recovers its upfront costs of implementing the program, then 50% of the fee charged for each such use thereafter. The remainder shall be remitted to the Secretary for deposit into the Secretary of State Special License Plate Fund. The contract shall also include a confidentiality provision sufficient to provide protection for the vendor's proprietary information and methods.

All commercial digital registration plates used in this State shall be capable of clearly displaying digital numbering and must be capable of detection by equipment owned and operated by the Illinois State Toll Highway Authority.

(f) Each operational use of a dynamic license plate number shall require the vendor to utilize a variety of driver data, including, but not limited to, cross-checking motor vehicle records and the Global Terrorist Watch List database before issuing and authorizing the dynamic license plate number and operational use. In no event shall any dynamic license plate number be issued until after an applicant selects and purchases temporary operational use insurance as made available through the vendor. Such insurance shall be effective for the duration of the operational use and all properly licensed insurance providers may participate in the program. Each operational use shall be subject to dynamic expiration at the termination of

- (2) Any implement of husbandry whether of a type otherwise subject to registration hereunder or not which is only incidentally operated or moved upon a highway, which shall include a not-for-hire movement for the purpose of delivering farm commodities to a place of first processing or sale, or to a place of storage;
  - (3) Any special mobile equipment as herein defined;
- (4) Any vehicle which is propelled exclusively by electric power obtained from overhead trolley wires though not operated upon rails;
- (5) Any vehicle which is equipped and used exclusively as a pumper, ladder truck, rescue vehicle, searchlight truck, or other fire apparatus, but not a vehicle of a type which would otherwise be subject to registration as a vehicle of the first division;
- (6) Any vehicle which is owned and operated by the federal government and externally displays evidence of federal ownership. It is the policy of the State of Illinois to promote and encourage the fullest use of its highways and to enhance the flow of commerce thus contributing to the economic, agricultural, industrial and social growth and development of this State, by authorizing the Secretary of State to negotiate and enter into

reciprocal or proportional agreements or arrangements with other States, or to issue declarations setting forth reciprocal exemptions, benefits and privileges with respect to vehicles operated interstate which are properly registered in this and other States, assuring nevertheless proper registration of vehicles in Illinois as may be required by this Code;

- (7) Any converter dolly or tow dolly which merely serves as substitute wheels for another legally licensed vehicle. A title may be issued on a voluntary basis to a tow dolly upon receipt of the manufacturer's certificate of origin or the bill of sale;
- (8) Any house trailer found to be an abandoned mobile home under the Abandoned Mobile Home Act;
- (9) Any vehicle that is not properly registered or does not have registration plates or digital registration plates issued to the owner or operator affixed thereto, or that does have registration plates or digital registration plates issued to the owner or operator affixed thereto but the plates are not appropriate for the weight of the vehicle, provided that this exemption shall apply only while the vehicle is being transported or operated by a towing service and has a third tow plate affixed to it.
- B. Reciprocity. Any motor vehicle, trailer, semitrailer or pole trailer need not be registered under this Code provided the same is operated interstate and in accordance with the

following provisions and any rules and regulations promulgated pursuant thereto:

> (1) A nonresident owner, except as otherwise provided in this Section, owning any foreign registered vehicle of a type otherwise subject to registration hereunder, may operate or permit the operation of such vehicle within this State in interstate commerce without registering such vehicle in, or paying any fees to, this State subject to the condition that such vehicle at all times when operated in this State is operated pursuant to a reciprocity agreement, arrangement or declaration by this State, and further subject to the condition that such vehicle at all times when operated in this State is duly registered in, and displays upon it, a valid registration card and registration plate or plates or digital registration plate or plates issued for such vehicle in the place of residence of such owner and is issued and maintains in such vehicle a valid Illinois reciprocity permit as required by the Secretary of State, and provided like privileges are afforded to residents of this State by the State of residence of such owner.

- (I) Limiting and tracking of the use of time extensions of the registration requirement to prevent repeated extensions;
- (J) Providing for meaningful penalties for cases of registration fraud;
- (K) Limiting and tracking exemptions to prevent abuse of the exemption policy for vehicles claimed to be out-of-state; and
- Encouraging enforcement of vehicle (L) registration transfer requirements when vehicle owners move into the affected counties by coordinating with local and State enforcement agencies and structuring other activities (e.g., driver's license issuance) to effect registration transfers.
- (2) The Agency shall cooperate in the enforcement of this Chapter by providing the owner or owners of complying vehicles with a Compliance Certificate stating that the vehicle meets all applicable requirements of this Chapter.

The Agency shall cooperate with the Secretary of State in the administration of this Chapter and the related provisions of Chapter 3, and shall provide the Secretary of State with such information as the Secretary of State may deem necessary for these purposes, including regular and timely access to vehicle inspection records.

The Secretary of State shall cooperate with the Agency in the administration of this Chapter and shall provide the Agency with such information as the Agency may deem necessary for the purposes of this Chapter, including regular and timely access to vehicle registration records. Section 2-123 of this Code does not apply to the provision of this information.

- Consistent with the requirements of Section 13C-15, the Secretary of State shall not renew any vehicle registration for a subject vehicle that has not complied with this Chapter. Additionally, the Secretary of State shall not allow the issuance of a new registration nor allow the transfer of a registration to a subject vehicle that has not complied with this Chapter.
- Secretary of State shall suspend registration of any vehicle which has permanent vehicle registration plates or digital registration plates that has not complied with the requirements of this Chapter. A suspension under this paragraph (4) shall not be terminated until satisfactory proof of compliance has been submitted the Secretary of State. permanent vehicle to No registration plate or digital registration plate that has been suspended under this Section may be reinstated or renewed, or transferred by the owner to any other vehicle, until the suspension has been terminated.

Sec. 20-401. Saving provisions. The repeal of any Act by this Chapter shall not affect any right accrued or liability incurred under said repealed Act to the effective date hereof.

The provisions of this Act, insofar as they are the same or substantially the same as those of any prior Act, shall be construed as a continuation of said prior Act. Any license, permit, certificate, registration, registration plate or digital registration plate, registration sticker or digital registration sticker, bond, policy of insurance or other instrument or document issued or filed or any deposit made under any such prior Act and still in effect on the effective date of this Act shall, except as otherwise specifically provided in this Act, be deemed the equivalent of a license, permit, certificate, registration, registration plate or digital registration plate, registration sticker or digital registration sticker, bond, policy of insurance, or other instrument or document issued or filed or any deposit made under this Act, and shall continue in effect until its expiration or until suspended, revoked, cancelled or forfeited under this Act.

Furthermore, when any section of any of the various laws or acts repealed by this Act is amended by an Amendatory Act of the 76th General Assembly, and such amended section becomes law prior to the effective date of this Act, then it is the intent

1 of the General Assembly that the corresponding section of this Code and Act be construed so as to give effect to such 2 3 amendment as if it were made a part of this Code. Should, 4 however, any such Amendatory Act amend a definition of a word 5 or phrase in an act repealed by this Act, and such becomes law prior to the effective date of this Act, it is the further 6 intent of the General Assembly that the corresponding section 7 8 of this Code specifically defining such word or phrase be construed so as to give effect to such amendment, and if not 9 10 specifically defined, that the corresponding section of 11 Chapter 1 of this Code be construed so as to give effect to such amendment.
