AMENDMENT TO HOUSE BILL 2682

AMENDMENT NO. _____. Amend House Bill 2682 by replacing everything after the enacting clause with the following:

"Section 5. The Liquor Control Act of 1934 is amended by changing Sections 5-5, 6-1, 6-5, and 6-27.1 and by adding Sections 5-7 and 6-28.8 as follows:

Sec. 5-5. Late filing fees. In the event that a liquor 8 license holder fails to submit a license renewal application to 9 10 the Commission before or on the expiration date of the current license, the licensee will be assessed a late filing fee of 11 12 \$25. Late applications and instruments of payment will be 13 returned to the licensee. Late filing fees will be in addition to any fines or penalties ordered for operating without a valid 14 15 license.

Late filing fees shall not apply to a liquor license holder

1	whose business or business operations have been suspended in
2	any capacity due to any executive order issued on or after
3	March 16, 2020 or any subsequent rule established by the
4	Department of Public Health or any other agency of the State as
5	a result of COVID-19. The late filing fee waiver shall remain

being encumbered or hypothecated. Such license shall not descend by the laws of testate or intestate devolution, but it shall cease upon the death of the licensee, provided that executors or administrators of the estate of any deceased licensee, and the trustee of any insolvent or bankrupt licensee, when such estate consists in part of alcoholic liquor, may continue the business of the sale or manufacture of alcoholic liquor under order of the appropriate court, and may exercise the privileges of the deceased or insolvent or bankrupt licensee after the death of such decedent, or such insolvency or bankruptcy until the expiration of such license but not longer than six months after the death, bankruptcy or insolvency of such licensee. Except in the case of non-beverage user's license, a refund shall be made of that portion of the license fees paid for any period in which the licensee shall be prevented from operating under such license in accordance with the provisions of this paragraph.

Any licensee may renew his license at the expiration thereof, provided he is then qualified to receive a license and the premises for which such renewal license is sought are suitable for such purpose; and provided further that the renewal privilege herein provided for shall not be construed as a vested right which shall in any case prevent the city council or village president and board of trustees or county board, as the case may be, from decreasing the number of licenses to be issued within its jurisdiction. No retailer's license shall be

renewed if the Department of Revenue has reported to the Illinois Liquor Control Commission that such retailer is delinquent in filing any required tax returns or paying any amounts owed to the State of Illinois until the applicant is issued a certificate by the Department of Revenue stating that all delinquent returns or amounts owed have been paid by guaranteed remittance or the payment agreement to pay all amounts owed has been accepted by the Department. No retailer's license issued by a local liquor control commissioner shall be renewed unless the applicant provides documentation that any tax owed to (i) the municipality in which the applicant is located (in the case of a license issued by the mayor or president of the board of trustees of a city, village or incorporated town acting as local liquor control commissioner) or (ii) the county in which the applicant is located (in the case of a license issued by the president or chairman of a county board acting as local liquor control commissioner) by the applicant has been satisfied by payment in the form of a cashier's check, certified check, money order, or cash.

For a liquor license holder whose business or business operations have been suspended in any capacity due to any executive order issued on or after March 16, 2020 or any subsequent rule established by the Department of Public Health or any other agency of the State as a result of COVID-19, renewal of the license shall be automatically approved and the license shall be extended without limitation for 120 days after

Sec. 6-5. Except as otherwise provided in this Section, it

1 is unlawful for any person having a retailer's license or any officer, associate, member, representative or agent of such 2 3 licensee to accept, receive or borrow money, or anything else 4 of value, or accept or receive credit (other than merchandising 5 credit in the ordinary course of business for a period not to 6 exceed 30 days) directly or indirectly from any manufacturer, importing distributor or distributor of alcoholic liquor, or 7 8 from any person connected with or in any way representing, or 9 from any member of the family of, such manufacturer, importing 10 distributor, distributor or wholesaler, or from any 11 stockholders in any corporation engaged in manufacturing, distributing or wholesaling of such liquor, or from any 12 13 officer, manager, agent or representative of said 14 manufacturer. Except as provided below, it is unlawful for any 15 manufacturer or distributor or importing distributor to give or 16 lend money or anything of value, or otherwise loan or extend (except such merchandising credit) 17 directly 18 indirectly to any retail licensee or to the representative, agent, officer or director of such licensee. A 19 20 manufacturer, distributor or importing distributor may furnish free advertising, posters, signs, brochures, hand-outs, or 2.1 other promotional devices or materials to any unit of 22 23 government owning or operating any auditorium, exhibition 24 hall, recreation facility or other similar facility holding a 25 retailer's license, provided that the primary purpose of such 26 promotional devices or materials is to promote public events

1 being held at such facility. A unit of government owning or operating such a facility holding a retailer's license may accept such promotional devices or materials designed primarily to promote public events held at the facility. No retail licensee delinquent beyond the 30 day period specified in this Section shall solicit, accept or receive credit, purchase or acquire alcoholic liquors, directly or indirectly from any other licensee, and no manufacturer, distributor or importing distributor shall knowingly grant or extend credit, sell, furnish or supply alcoholic liquors to any such delinquent retail licensee; provided that the purchase price of all beer sold to a retail licensee shall be paid by the retail licensee in cash on or before delivery of the beer, and unless the purchase price payable by a retail licensee for beer sold to him in returnable bottles shall expressly include a charge for the bottles and cases, the retail licensee shall, on or before delivery of such beer, pay the seller in cash a deposit in an amount not less than the deposit required to be paid by the distributor to the brewer; but where the brewer sells direct to the retailer, the deposit shall be an amount no less than that required by the brewer from his own distributors; and provided further, that in no instance shall this deposit be less than 50 cents for each case of beer in pint or smaller bottles and 60 cents for each case of beer in quart or half-gallon bottles; and provided further, that the purchase 26 price of all beer sold to an importing distributor or

distributor shall be paid by such importing distributor or distributor in cash on or before the 15th day (Sundays and holidays excepted) after delivery of such beer to such purchaser; and unless the purchase price payable by such importing distributor or distributor for beer returnable bottles and cases shall expressly include a charge for the bottles and cases, such importing distributor or distributor shall, on or before the 15th day (Sundays and holidays excepted) after delivery of such beer to such purchaser, pay the seller in cash a required amount as a deposit to assure the return of such bottles and cases. Nothing herein contained shall prohibit any licensee from crediting or refunding to a purchaser the actual amount of money paid for bottles, cases, kegs or barrels returned by the purchaser to the seller or paid by the purchaser as a deposit on bottles, cases, kegs or barrels, when such containers or packages are returned to the seller. Nothing herein contained shall prohibit any manufacturer, importing distributor or distributor from extending usual and customary credit for alcoholic liquor sold to customers or purchasers who live in or maintain places of business outside of this State when such alcoholic liquor is actually transported and delivered to such points outside of this State.

A manufacturer, distributor, or importing distributor may furnish free social media advertising to a retail licensee if the social media advertisement does not contain the retail

1 any alcoholic liquor and the social price of advertisement complies with any 2 applicable rules regulations issued by the Alcohol and Tobacco Tax and Trade 3 4 Bureau of the United States Department of the Treasury. A 5 manufacturer, distributor, or importing distributor may list 6 the names of one or more unaffiliated retailers in the advertisement of alcoholic liquor through social media. 7 Nothing in this Section shall prohibit a retailer from 8 communicating with a manufacturer, distributor, or importing 9 10 distributor on social media or sharing media on the social 11 media of manufacturer, distributor, or а importing distributor. A retailer may request free social media 12 13 advertising from a manufacturer, distributor, or importing 14 distributor. Nothing in this Section shall prohibit 15 manufacturer, distributor, or importing distributor from 16 sharing, reposting, or otherwise forwarding a social media post by a retail licensee, so long as the sharing, reposting, or 17 forwarding of the social media post does not contain the retail 18 price of any alcoholic liquor. No manufacturer, distributor, or 19 20 importing distributor shall pay or reimburse a retailer, directly or indirectly, for any social media advertising 2.1 22 services, except as specifically permitted in this Act. No 23 retailer shall accept any payment or reimbursement, directly or 24 indirectly, for any social media advertising services offered 25 by a manufacturer, distributor, or importing distributor, 26 except as specifically permitted in this Act. For the purposes

- 1 of this Section, "social media" means a service, platform, or
- site where users communicate with one another and share media,
- 3 such as pictures, videos, music, and blogs, with other users
- 4 free of charge.
- 5 No right of action shall exist for the collection of any
- claim based upon credit extended to a distributor, importing 6
- distributor or retail licensee contrary to the provisions of 7

- 9 Every manufacturer, importing distributor and distributor

Such written verified reports required to be submitted by this Section shall be posted by the State Commission in each of its offices in places available for public inspection not later than the day following receipt thereof by the Commission. The shall constitute notice reports so posted t.o manufacturer, importing distributor and distributor of the information contained therein. Actual notice to manufacturers, importing distributors and distributors of the information contained in any such posted reports, however received, shall also constitute notice of such information.

The 30 day merchandising credit period allowed by this Section shall commence with the day immediately following the date of invoice and shall include all successive days including Sundays and holidays to and including the 30th successive day.

In addition to other methods allowed by law, payment by check during the period for which merchandising credit may be extended under the provisions of this Section shall be considered payment. All checks received in payment for alcoholic liquor shall be promptly deposited for collection. A post dated check or a check dishonored on presentation for payment shall not be deemed payment.

A retail licensee shall not be deemed to be delinquent in payment for any alleged sale to him of alcoholic liquor when there exists a bona fide dispute between such retailer and a

- alleged sale. A retail licensee shall not be deemed to be 3

- 25 (a) Unless issued a valid server training certificate

between July 1, 2012 and July 1, 2015 by a certified Beverage 1 2 Alcohol Sellers and Servers Education and Training (BASSET) trainer, all alcohol servers in Cook County are required to 3 4 obtain and complete training in basic responsible alcohol 5 service as outlined in 77 Ill. Adm. Code 3500, as those provisions exist on July 1, 2015 (the effective date of Public 6 Act 98-939), by July 1, 2015 or within 120 days after the 7 alcohol server begins his or her employment, whichever is 8 9 later. All alcohol servers in a county, other than Cook County, 10 with a population of 200,000 inhabitants or more are required 11 to obtain and complete training in basic responsible alcohol service as outlined in 77 Ill. Adm. Code 3500, as those 12 13 provisions exist on July 1, 2015 (the effective date of Public Act 98-939), by July 1, 2016 or within 120 days after the 14 15 alcohol server begins his or her employment, whichever is 16 later. All alcohol servers in a county with a population of more than 30,000 inhabitants and less than 200,000 inhabitants 17 are required to obtain and complete training in basic 18 responsible alcohol service as outlined in 77 Ill. Adm. Code 19 20 3500, as those provisions exist on July 1, 2015 (the effective date of Public Act 98-939), by July 1, 2017 or within 120 days 2.1 22 after the alcohol server begins his or her employment, whichever is later. All alcohol servers in counties with a 23 24 population of 30,000 inhabitants or less are required to obtain 25 and complete training in basic responsible alcohol service as outlined in 77 Ill. Adm. his or her employment, whichever is later. 3

There is no limit to the amount of times a server may take the training. A certificate of training belongs to the server, and a server may transfer a certificate of training to a different employer, but shall not transfer a certificate of training to another server. Proof that an alcohol server has been trained must be available upon reasonable request by State law enforcement officials. For the purpose of this Section, "alcohol servers" means persons who sell or serve open containers of alcoholic beverages at retail, anyone who delivers mixed drinks under Section 6-28.8, and anyone whose job description entails the checking of identification for the purchase of open containers of alcoholic beverages at retail or for entry into the licensed premises. The definition does not include (i) a distributor or importing distributor conducting product sampling as authorized in Section 6-31 of this Act or a registered tasting representative, as provided in 11 Ill. Adm. Code 100.40, conducting a tasting, as defined in 11 Ill. Adm. Code 100.10; (ii) a volunteer serving alcoholic beverages at a charitable function; or (iii) an instructor engaged in training or educating on the proper technique for using a system that dispenses alcoholic beverages.

(b) Responsible alcohol service training must cover and assess knowledge of the topics noted in 77 Ill. Adm. Code

- (c) Beginning on the effective date of this amendatory Act 2 of the 98th General Assembly, but no later than October 1, 3 4 2015, all existing BASSET trainers who are already BASSET 5 certified as of the effective date of this amendatory Act of the 98th General Assembly shall be recertified by the State 6 Commission and be required to comply with the conditions for 7 8 server training set forth in this amendatory Act of the 98th 9 General Assembly.
 - (d) Training modules and certificate program plans must be approved by the State Commission. All documents, materials, or information related to responsible alcohol service training program approval that are submitted to the State Commission are confidential and shall not be open to public inspection or dissemination and are exempt from disclosure.
 - The State Commission shall only approve programs that meet the following criteria:
 - (1) the training course covers the content specified in 77 Ill. Adm. Code 3500.155;
 - (2) if the training course is classroom-based, the classroom training is at least 4 hours, is available in English and Spanish, and includes a test;
 - (3) if the training course is online or computer-based, the course is designed in a way that ensures that no content can be skipped, is interactive, has audio for content for servers that have a disability, and includes a

- (4) training and testing is based on a job task analysis that clearly identifies and focuses on the knowledge, skills, and abilities needed to responsibly serve alcoholic beverages and is developed using best practices in instructional design and exam development to ensure that the program is fair and legally defensible;
- (5) training and testing is conducted by any means available, including, but not limited to, online, computer, classroom, or live trainers; and
- (6) provide the program must access on а 24-hour-per-day, 7-days-per-week basis for certificate verification for State Commission, State law enforcement officials, and employers to be able to verify certificate authenticity.
- (e) Nothing in subsection (d) of this Section shall be construed to require a program to use a test administrator or proctor.
- (f) A certificate issued from a BASSET-licensed training program shall be accepted as meeting the training requirements for all server license and permit laws and ordinances in the State.
- 23 (g) A responsible alcohol service training certificate 24 from a BASSET-licensed program shall be valid for 3 years.
