1 AMENDMENT TO HOUSE BILL 2818 2 AMENDMENT NO. . Amend House Bill 2818 by replacing everything after the enacting clause with the following: 3 "Section 5. The Election Code is amended by changing 4 Section 20-3 as follows: 5 6 (10 ILCS 5/20-3) (from Ch. 46, par. 20-3) 7 Sec. 20-3. The election authority shall furnish the 8 following applications for registration by mail or vote by mail ballot which shall be considered a method of application in 9 10 lieu of the official postcard. 1. Members of the United States Service, citizens of the 11 12 United States temporarily residing outside the territorial limits of the United States, and certified program participants 13 14 under the Address Confidentiality for Victims of Domestic

Violence, Sexual Assault, or Stalking Act may make application

within the periods prescribed in Sections 20-2 or 20-2.1, as

- 9 Sec. 1. Short title. This Act may be cited as the Address
- Confidentiality for Victims of Domestic Violence, Sexual 10
- 11 Assault, or Stalking Act.

- Sec. 5. Legislative findings. The General Assembly finds 14
- that persons attempting to escape from actual or threatened 15
- domestic violence, sexual assault, or stalking frequently 16
- 17 establish new addresses in order to prevent their assailants or
- probable assailants from finding them. The purpose of this Act 18
- 19 is to enable State and local agencies to respond to requests
- 20 for public records without disclosing the location of a victim
- of domestic violence, sexual assault, or stalking, to enable 21
- 22 interagency cooperation with the Attorney General in providing
- 23 address confidentiality for victims of domestic violence,

- 1 sexual assault, or stalking, and to enable State and local
- agencies to accept a program participant's use of an address 2

- Sec. 10. Definitions. In this Act, unless the context 7
- 8 otherwise requires:
- 9 "Address" means a residential street address, school
- 10 address, or work address of an individual, as specified on the
- individual's application to be a program participant under this 11
- 12 Act.
- 13 "Program participant" means a person certified as a program
- 14 participant under this Act.
- 15 "Domestic violence" has the same meaning as in the Illinois
- Domestic Violence Act of 1986 and includes a threat of domestic 16
- violence against an individual in a domestic situation, 17
- regardless of whether the domestic violence or threat has been 18
- reported to law enforcement officers. 19
- 20 "Sexual assault" has the same meaning as sexual conduct or
- 21 sexual penetration as defined in the Civil No Contact Order
- Act. "Sexual assault" includes a threat of sexual assault, 22
- 23 regardless of whether the sexual assault or threat has been

- 7 Subject to appropriations for the purposes of this Act, the
- 8 Attorney General shall administer an address confidentiality
- 9 program for victims of domestic violence, sexual assault, or
- 10 stalking.

- 13 Sec. 15. Address confidentiality program; application;
- 14 certification.
- 15 (a) An adult person, a parent or guardian acting on behalf
- 16 of a minor, or a guardian acting on behalf of a person with a
- disability, as defined in Article 11a of the Probate Act of 17
- 18 1975, may apply to the Attorney General to have an address
- designated by the Attorney General serve as the person's 19
- address or the address of the minor or person with a 20
- 21 disability. The Attorney General shall approve an application
- 22 if it is filed in the manner and on the form prescribed by him
- 23 or her and if it contains:
- 24 (1) a sworn statement by the applicant that the

- applicant has good reason to believe (i) that the applicant, or the minor or person with a disability on whose behalf the application is made, is a victim of domestic violence, sexual assault, or stalking; and (ii) that the applicant fears for his or her safety or his or her children's safety, or the safety of the minor or person with a disability on whose behalf the application is made;
- (2) a designation of the Attorney General as agent for purposes of service of process and receipt of mail;
- (3) the mailing address where the applicant can be contacted by the Attorney General, and the phone number or numbers where the applicant can be called by the Attorney General;
- (4) the new address or addresses that the applicant requests not be disclosed for the reason that disclosure will increase the risk of domestic violence, sexual assault, or stalking; and
- (5) the signature of the applicant and of any individual or representative of any office designated in writing under Section 40 of this Act who assisted in the preparation of the application, and the date on which the applicant signed the application.
- (b) Applications shall be filed with the office of the Attorney General.
- 25 (c) Upon filing a properly completed application, the 26 Attorney General shall certify the applicant as a program

- 1 participant. Applicants shall be certified for 4 years
- 2 following the date of filing unless the certification is
- 3 withdrawn or invalidated before that date. The Attorney General
- 4 shall by rule establish a renewal procedure.
- 5 (d) A person who falsely attests in an application that
- 6 disclosure of the applicant's address would endanger the
- applicant's safety or the safety of the applicant's children or 7
- 8 the minor or incapacitated person on whose behalf the
- 9 application is made, or who knowingly provides false or
- 10 incorrect information upon making an application, is guilty of
- 11 a Class 3 felony.

- 19 assistance and counseling rendered by the office of the
- 20 Attorney General or its designees to applicants shall in no way
- 21 be construed as legal advice.
