## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

Section 5. The Illinois Insurance Code is amended by changing Section 356z.25 as follows:

Sec. 356z.25. Coverage for treatment of pediatric autoimmune neuropsychiatric disorders associated with streptococcal infections and pediatric acute neuropsychiatric syndrome. A group or individual policy of accident and health insurance or managed care plan that is amended, delivered, issued, or renewed after July 18, 2017 (the effective date of Public Act 100-24) shall provide coverage for treatment of pediatric autoimmune neuropsychiatric disorders associated with streptococcal infections and pediatric acute-onset neuropsychiatric syndrome, including, but not limited to, the use of intravenous immunoglobulin therapy. A treatment that is administered or prescribed after July 18, 2017 shall be covered.

For billing and diagnosis purposes, pediatric autoimmune neuropsychiatric disorders associated with streptococcal infections and pediatric acute onset neuropsychiatric syndrome shall be coded as autoimmune encephalitis until a code is

- 2 a diagnosis of autoimmune encephalopathy or autoimmune
- 3 <u>encephalitis.</u>
- If, at any time, the Secretary of the United States 5 Department of Health and Human Services, or its successor agency, promulgates rules or regulations to be published in the 6 Federal Register or publishes a comment in the Federal Register 7 or issues an opinion, quidance, or other action that would 8 9 require the State, pursuant to any provision of the Patient 10 Protection and Affordable Care Act (Public Law 111-148), 11 including, but not limited to, 42 U.S.C. 18031(d)(3)(B) or any 12 successor provision, to defray the cost of any coverage for 13 pediatric autoimmune neuropsychiatric disorders associated 14 with streptococcal infections and pediatric acute onset 15 neuropsychiatric syndrome outlined in this Section, then the 16 requirement that an insurer cover pediatric autoimmune 17 neuropsychiatric disorders associated with streptococcal infections and pediatric acute onset neuropsychiatric syndrome 18 19 is inoperative other than any such coverage authorized under 20 Section 1902 of the Social Security Act, 42 U.S.C. 1396a, and 21 the State shall not assume any obligation for the cost of 22 coverage for pediatric autoimmune neuropsychiatric disorders 23 associated with streptococcal infections and pediatric acute 24 onset neuropsychiatric syndrome.
