#### SYNOPSIS AS INTRODUCED:

Amends "An Act concerning appropriations", Public Act 100-586. Changes the amount of funds appropriated to the Department of Human Services for grants to provide assistance to Sexual Assault Victims and Sexual Assault Prevention Activities from \$6,659,700 to \$12,659,700. Effective immediately.

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. "An Act concerning appropriations", Public Act  
6 100-0586, approved June 4, 2018, is amended by changing Section  
7 200 of Article 92 as follows:

8 (P.A. 100-586, Art. 92, Sec. 200)

9 Section 200. The following named amounts, or so much  
10 thereof as may be necessary, respectively, for the objects
