

## 101ST GENERAL ASSEMBLY State of Illinois 2019 and 2020 HB4127

Introduced 1/22/2020, by Rep. Joe Sosnowski

## SYNOPSIS AS INTRODUCED:

705 ILCS 405/2-3 720 ILCS 5/12C-10 from Ch. 37, par. 802-3 was 720 ILCS 5/12-21.5

Amends the Juvenile Court Act of 1987. Provides that a neglected minor includes any minor under the age of 12 (rather than 14) years whose parent or other person responsible for the minor's welfare leaves the minor without supervision for an unreasonable period of time without regard for the mental or physical health, safety, or welfare of that minor. Provides that neglect does not include permitting a child, whose basic needs are met and who is of sufficient age and maturity to avoid harm or unreasonable risk of harm, to engage in independent activities, including: (1) traveling to and from school, including by walking, running, or bicycling; (2) traveling to and from nearby commercial or recreational activities; (3) engaging in outdoor play; (4) remaining in a vehicle unattended, except as otherwise provided by law; (5) remaining at home unattended; or (6) engaging in a similar independent activity. Amends the Criminal Code of 2012. Provides that a person commits child abandonment when he or she, as a parent, guardian, or other person having physical custody or control of a child, without regard for the mental or physical health, safety, or welfare of that child, knowingly leaves that child who is under the age of 12 (rather than 13) without supervision by a responsible person over the age of 14 for a period of 24 hours or more.

1 AN ACT concerning children.

## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Juvenile Court Act of 1987 is amended by changing Section 2-3 as follows:
- 6 (705 ILCS 405/2-3) (from Ch. 37, par. 802-3)
  - Sec. 2-3. Neglected or abused minor.
    - (1) Those who are neglected include:
      - (a) any minor under 18 years of age or a minor 18 years of age or older for whom the court has made a finding of probable cause to believe that the minor is abused, neglected, or dependent under subsection (1) of Section 2-10 prior to the minor's 18th birthday who is not receiving the proper or necessary support, education as required by law, or medical or other remedial care recognized under State law as necessary for a minor's well-being, or other care necessary for his or her well-being, including adequate food, clothing and shelter, or who is abandoned by his or her parent or parents or other person or persons responsible for the minor's welfare, except that a minor shall not be considered neglected for the sole reason that the minor's parent or parents or other person or persons responsible for the

minor's welfare have left the minor in the care of an adult relative for any period of time, who the parent or parents or other person responsible for the minor's welfare know is both a mentally capable adult relative and physically capable adult relative, as defined by this Act; or

- (b) any minor under 18 years of age or a minor 18 years of age or older for whom the court has made a finding of probable cause to believe that the minor is abused, neglected, or dependent under subsection (1) of Section 2-10 prior to the minor's 18th birthday whose environment is injurious to his or her welfare; or
- (c) any newborn infant whose blood, urine, or meconium contains any amount of a controlled substance as defined in subsection (f) of Section 102 of the Illinois Controlled Substances Act, as now or hereafter amended, or a metabolite of a controlled substance, with the exception of controlled substances or metabolites of such substances, the presence of which in the newborn infant is the result of medical treatment administered to the mother or the newborn infant; or
- (d) any minor under the age of <u>12</u> <u>14</u> years whose parent or other person responsible for the minor's welfare leaves the minor without supervision for an unreasonable period of time without regard for the mental or physical health, safety, or welfare of that minor; or
  - (e) any minor who has been provided with interim crisis

intervention services under Section 3-5 of this Act and whose parent, guardian, or custodian refuses to permit the minor to return home unless the minor is an immediate physical danger to himself, herself, or others living in the home.

Whether the minor was left without regard for the mental or physical health, safety, or welfare of that minor or the period of time was unreasonable shall be determined by considering the following factors, including but not limited to:

- (1) the age of the minor;
- (2) the number of minors left at the location;
- (3) special needs of the minor, including whether the minor is a person with a physical or mental disability, or otherwise in need of ongoing prescribed medical treatment such as periodic doses of insulin or other medications;
- (4) the duration of time in which the minor was left without supervision;
- (5) the condition and location of the place where the minor was left without supervision;
- (6) the time of day or night when the minor was left without supervision;
- (7) the weather conditions, including whether the minor was left in a location with adequate protection from the natural elements such as adequate heat or light;
- (8) the location of the parent or guardian at the time the minor was left without supervision, the physical

3	(9) whether the minor's movement was restricted, or the

6	(10) whether the minor was given a phone number of a

11	(12) whether any of the conduct is attributable to
12	economic hardship or illness and the parent, guardian or
13	other person having physical custody or control of the

16	(13) the age and physical and mental capabilities of
17	the person or persons who provided supervision for the
18	minor;
19	(14) whether the minor was left under the supervision
20	of another person;
21	(15) any other factor that would endanger the health

23	(1.5) Neglect does not include permitting a child, whose

10	A minor shall not be considered neglected for the sole

13	(2) Those who are abused include any minor under 18 years
14	of age or a minor 18 years of age or older for whom the court
15	has made a finding of probable cause to believe that the minor
16	is abused, neglected, or dependent under subsection (1) of
17	Section 2-10 prior to the minor's 18th birthday whose parent or
18	immediate family member, or any person responsible for the
19	minor's welfare, or any person who is in the same family or
20	household as the minor, or any individual residing in the same
21	home as the minor, or a paramour of the minor's parent:
22	(i) inflicts, causes to be inflicted, or allows to be
23	inflicted upon such minor physical injury, by other than
24	accidental means, which causes death, disfigurement,
25	impairment of physical or emotional health, or loss or
26	impairment of any bodily function;

- (ii) creates a substantial risk of physical injury to such minor by other than accidental means which would be likely to cause death, disfigurement, impairment of emotional health, or loss or impairment of any bodily function;
- (iii) commits or allows to be committed any sex offense against such minor, as such sex offenses are defined in the Criminal Code of 1961 or the Criminal Code of 2012, or in the Wrongs to Children Act, and extending those definitions of sex offenses to include minors under 18 years of age;
- (iv) commits or allows to be committed an act or acts of torture upon such minor;
  - (v) inflicts excessive corporal punishment;
- (vi) commits or allows to be committed the offense of involuntary servitude, involuntary sexual servitude of a minor, or trafficking in persons as defined in Section 10-9 of the Criminal Code of 1961 or the Criminal Code of 2012, upon such minor; or
- (vii) allows, encourages or requires a minor to commit any act of prostitution, as defined in the Criminal Code of 1961 or the Criminal Code of 2012, and extending those definitions to include minors under 18 years of age.
- A minor shall not be considered abused for the sole reason that the minor has been relinquished in accordance with the Abandoned Newborn Infant Protection Act.
  - (3) This Section does not apply to a minor who would be

- 4 (4) The changes made by this amendatory Act of the 101st
- 5 General Assembly apply to a case that is pending on or after

- 9 Section 10. The Criminal Code of 2012 is amended by
- 10 changing Section 12C-10 as follows:
- 11 (720 ILCS 5/12C-10) (was 720 ILCS 5/12-21.5)
- 12 Sec. 12C-10. Child abandonment.
- 13 (a) A person commits child abandonment when he or she, as a
- 14 parent, guardian, or other person having physical custody or
- 15 control of a child, without regard for the mental or physical
- health, safety, or welfare of that child, knowingly leaves that
- 17 child who is under the age of 12  $\frac{13}{13}$  without supervision by a
- 18 responsible person over the age of 14 for a period of 24 hours
- or more. It is not a violation of this Section for a person to
- 20 relinquish a child in accordance with the Abandoned Newborn
- 21 Infant Protection Act.
- 22 (b) For the purposes of determining whether the child was
- left without regard for the mental or physical health, safety,
- or welfare of that child, the trier of fact shall consider the

## following factors:

- (1) the age of the child;
  - (2) the number of children left at the location;
  - (3) special needs of the child, including whether the child is a person with a physical or mental disability, or otherwise in need of ongoing prescribed medical treatment such as periodic doses of insulin or other medications;
  - (4) the duration of time in which the child was left without supervision;
  - (5) the condition and location of the place where the child was left without supervision;
  - (6) the time of day or night when the child was left without supervision;
  - (7) the weather conditions, including whether the child was left in a location with adequate protection from the natural elements such as adequate heat or light;
  - (8) the location of the parent, guardian, or other person having physical custody or control of the child at the time the child was left without supervision, the physical distance the child was from the parent, guardian, or other person having physical custody or control of the child at the time the child was without supervision;
  - (9) whether the child's movement was restricted, or the child was otherwise locked within a room or other structure;
    - (10) whether the child was given a phone number of a

- person or location to call in the event of an emergency and whether the child was capable of making an emergency call;
  - (11) whether there was food and other provision left for the child;
  - (12) whether any of the conduct is attributable to economic hardship or illness and the parent, guardian or other person having physical custody or control of the child made a good faith effort to provide for the health and safety of the child;
  - (13) the age and physical and mental capabilities of the person or persons who provided supervision for the child;
  - (14) any other factor that would endanger the health or safety of that particular child;
    - (15) whether the child was left under the supervision of another person.
- 17 (c) Child abandonment is a Class 4 felony. A second or 18 subsequent offense after a prior conviction is a Class 3 19 felony. A parent, who is found to be in violation of this 20 Section with respect to his or her child, may be sentenced to 21 probation for this offense pursuant to Section 12C-15.
