2 AMENDMENT NO. \_\_\_\_\_. Amend Senate Bill 1862, AS AMENDED,  
3 by replacing everything after the enacting clause with the  
4 following:

5 "Section 5. The Illinois Vehicle Code is amended by  
6 changing Sections 1-154.7 and 5-302 as follows:

7 (625 ILCS 5/1-154.7)

8 Sec. 1-154.7. Out-of-state salvage vehicle buyer. A person  
9 who is licensed in another state or jurisdiction and acquires  
10 salvage or junk vehicles for the primary purpose of taking them  
11 out of this State ~~state~~.

14 Sec. 5-302. Out-of-state salvage vehicle buyer must be  
15 licensed.

1 (a) No person in this State shall sell ~~or offer~~ at auction  
2 a salvage vehicles to a nonresident individual or business  
3 licensed in the United States unless the nonresident is ~~who is~~  
4 ~~not~~ licensed in another state or jurisdiction and provides a  
5 resale tax certificate, if applicable, and one of the  
6 following: a National Motor Vehicle Title Information System  
7 (NMVTIS) number, a federal employer identification number, or a  
8 government-issued driver's license or passport. A person in  
9 this State shall not sell at auction a salvage vehicle to an  
10 out-of-country buyer, unless if the nonresident is licensed in  
11 a jurisdiction that is not a state, then the nonresident shall  
12 provide to the seller the number of the nonresident's license  
13 issued by that jurisdiction and a copy of the nonresident's  
14 passport or the passport of an owner or officer of the  
15 nonresident entity or a copy of another form of  
16 government-issued identification from the nonresident or an  
17 owner or officer of the nonresident entity.

4 address outside of the United States shall receive a salvage  
5 certificate stamped by the seller with the designation of "For  
6 Export Only" at the point of sale for each salvage vehicle  
7 purchased and the NMVTIS record shall be designated "EXPORT".
