2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 Section 115. The sum of \$393,700, or so much thereof as may
5 be necessary, is appropriated from the Community Association
6 Manager Licensing and Disciplinary Fund to the Department of
7 Financial and Professional Regulation for all costs associated
8 with administration of the Community Association Manager
9 Licensing and Disciplinary Act.

10 Section 120. The sum of \$19,000, or so much thereof as may
11 be necessary, is appropriated to the Department of Financial
12 and Professional Regulation from the Real Estate Research and
13 Education Fund for costs associated with the operation of the
14 Office of Real Estate Research at the University of Illinois.

15 Section 125. The sum of \$20,000, or so much thereof as may
16 be necessary, is appropriated from the Athletics Supervision
17 and Regulation Fund to the Department of Financial and
18 Professional Regulation for all costs associated with
19 administration of the Boxing and Full-contact Martial Arts Act.

20 Section 130. The sum of \$1,289,700, or so much thereof as
21 may be necessary, is appropriated from the Compassionate Use

1 of Medical Cannabis Fund to the Department of Financial and
2 Professional Regulation for all costs associated with
3 operational expenses of the department in relation to the
4 regulation of medical marijuana.

5 Section 99. Effective Date. This Act takes effect July 1,
6 2019.
