A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named amounts, or so much thereof  
6 as may be necessary, respectively, are appropriated to the  
7 Department of State Police for the following purposes:

8 DIVISION OF ADMINISTRATION

9 Payable from General Revenue Fund:

14 Section 10. The sum of \$4,000,000, or so much thereof as  
 15 may be necessary, is appropriated from the State Asset  
 16 Forfeiture Fund to the Department of State Police for payment  
 17 of their expenditures as outlined in the Illinois Drug Asset  
 18 Forfeiture Procedure Act, the Cannabis Control Act, the  
 19 Controlled Substances Act, and the Environmental Safety Act.

20 Section 15. The sum of \$2,500,000, or so much thereof as  
 21 may be necessary, is appropriated from the Federal Asset  
 22 Forfeiture Fund to the Department of State Police for payment  
 23 of their expenditures in accordance with the Federal Equitable

1 Sharing Guidelines.

2 Section 20. The sum of \$2,000,000, or so much thereof as  
3 may be necessary, is appropriated to the Department of State  
4 Police, Division of Administration, from the Money Laundering  
5 Asset Recovery Fund for the ordinary and contingent expenses  
6 incurred by the Department of State Police.

7 Section 25. The sum of \$1,000,000, or so much thereof as  
8 may be necessary, is appropriated from the LEADS Maintenance  
9 Fund to the Department of State Police, Division of  
10 Administration, for expenses related to the LEADS System.

11 Section 30. The following named amounts, or so much thereof  
12 as may be necessary, respectively, are appropriated to the  
13 Department of State Police for the following purposes:

23 Section 35. The following amount, or so much thereof as  
24 may be necessary for objects and purposes hereinafter named,

1 is appropriated from the Drug Traffic Prevention Fund to the  
 2 Department of State Police, Division of Operations, pursuant  
 3 to the provisions of the "Intergovernmental Drug Laws  
 4 Enforcement Act" for Grants to Metropolitan Enforcement Groups.

5 For Grants to Metropolitan Enforcement Groups:

6 Payable from the Drug Traffic  
 7 Prevention Fund .....500,000

8 Section 40. The sum of \$18,000,000, or so much thereof as  
 9 may be necessary, is appropriated from the State Police  
 10 Whistleblower Reward and Protection Fund to the Department of  
 11 State Police for payment of their expenditures for state law  
 12 enforcement purposes in accordance with the State Whistleblower  
 13 Protection Act.

14 Section 45. The sum of \$25,000,000, or so much thereof as  
 15 may be necessary, is appropriated from the State Police  
 16 Operations Assistance Fund to the Department of State Police  
 17 for the ordinary and contingent expenses incurred by the  
 18 Department of State Police.

19 Section 50. The sum of \$10,000, or so much thereof as may  
 20 be necessary, is appropriated from the State Police Streetgang-  
 21 Related Crime Fund to the Department of State Police for  
 22 operations related to streetgang-related Crime Initiatives.

1           Section 55. The sum of \$1,000,000, or so much thereof as  
 2           may be necessary, is appropriated from the Over Dimensional  
 3           Load Police Escort Fund to the Department of State Police for  
 4           expenses incurred for providing police escorts for over-  
 5           dimensional loads.

6           Section 60. The sum of \$100,000, or so much thereof as may  
 7           be necessary, is appropriated from the Medicaid Fraud and Abuse  
 8           Prevention Fund to the Department of State Police, Division of  
 9           Operations for the detection, investigation or prosecution of  
 10          recipient or vendor fraud.

11          Section 65. The sum of \$10,000,000, or so much thereof as  
 12          may be necessary is appropriated from the State Police Law  
 13          Enforcement Administration Fund to the Department of State  
 14          Police, Division of Operations, for all costs associated with  
 15          a cadet program for the Department of State Police.

16          Section 70. The following named amounts, or so much thereof  
 17          as may be necessary, respectively, are appropriated to the  
 18          Department of State Police for the following purposes:

21       Section 75. The sum of \$2,250,000, or so much thereof as  
 22 may be necessary, is appropriated to the Department of State  
 23 Police, Division of Forensic Services and Identification, from  
 24 the Mental Health Reporting Fund for expenses as outlined in

1 the Firearm Concealed Carry Act and the Firearm Owners  
2 Identification Card Act.

3 Section 80. The sum of \$22,000,000, or so much thereof  
4 as may be necessary, is appropriated to the Department of State  
5 Police from the State Police Firearm Services Fund for expenses  
6 as outlined in the Firearm Concealed Carry Act and the Firearm  
7 Owners Identification Card Act.

8 Section 85. The sum of \$5,000,000, or so much thereof as  
9 may be necessary, is appropriated to the Department of State  
10 Police, Division of Forensic Services and Identification, from  
11 the Firearm Dealer License Certification Fund, for expenses as  
12 outlined in the Firearm Dealer License Certification Act and  
13 the Gun Trafficking Information Act.

14 Section 90. The following amounts, or so much thereof as  
15 may be necessary, respectively, are appropriated to the  
16 Department of State Police for Internal Investigation expenses  
17 as follows:

9 Section 95. The sum of \$717,900, or so much thereof as may  
10 be necessary, is appropriated to the Department of State  
11 Police, Division of Internal Investigation, from the General  
12 Revenue Fund for the ordinary and contingent expenses incurred  
13 while operating the Nursing Home Identified Offender Program.

14 Section 100. The sum of \$215,000,000, or so much thereof  
15 as may be necessary, is appropriated from the Statewide 9-1-1  
16 Fund to the Department of State Police, Division of  
17 Administration, for costs pursuant to the Emergency Telephone  
18 System Act.

19 Section 999. Effective Date. This Act takes effect July  
20 1, 2019.
