- of State from the Secretary of State Evidence Fund for the
- purchase of evidence, for the employment of persons to obtain
- evidence, and for the payment for any goods or services related
- 17 to obtaining evidence.
- 18 Section 160. The sum of \$225,000, or so much thereof as may
- 19 be necessary, is appropriated from the Alternate Fuels Fund to
- 20 the Office of Secretary of State for the cost of administering
- 21 the Alternate Fuels Act.

- Section 165. The sum of \$16,000,000, or so much thereof as
- 2 may be necessary, is appropriated from the Secretary of State
- 3 Special Services Fund to the Office of the Secretary of State
- 4 for office automation and technology.
- 5 Section 170. The sum of \$16,000,000, or so much thereof as
- 6 may be necessary, is appropriated from the Motor Vehicle
- 7 License Plate Fund to the Office of the Secretary of State for
- 8 the cost incident to providing new or replacement plates for
- 9 motor vehicles.
- Section 175. The sum of \$2,500,000, or so much thereof as
- 11 may be necessary, is appropriated from the Secretary of State
- 12 DUI Administration Fund to the Office of Secretary of State for
- 13 operation of the Department of Administrative Hearings of the

- of State from the State Library Fund to increase the collection
- of books, records, and holdings; to hold public forums; to
- 16 purchase equipment and resource materials for the State
- 17 Library; and for the upkeep, repair, and maintenance of the
- 18 State Library building and grounds.
- 19 Section 200. The following sum, or so much thereof as may
- 20 be necessary, is appropriated to the Office of the Secretary
- of State for any operations, alterations, rehabilitations, new
- construction, and maintenance of the interior and exterior of

- Section 205. The sum of \$15,000,000, or so much thereof

 implementing identification security and theft prevention
 measures.
- Section 210. The sum of \$2,000,000, or so much thereof as
 may be necessary, is appropriated to the Office of the Secretary
 of State from the Driver Services Administration Fund for the
 payment of costs related to the issuance of temporary visitor's
 driver's licenses, and other operational costs, including
 personnel, facilities, computer programming, and data
 transmission.
- Section 215. The sum of \$2,200,000, or so much thereof as may be necessary, is appropriated from the Monitoring Device Driving Permit Administration Fee Fund to the Office of the Secretary of State for all Secretary of State costs associated

- 1 with administering Monitoring Device Driving Permits per Public
- 2 Act 95-0400.
- 3 Section 220. The sum of \$300,000, or so much thereof as
- 4 may be necessary, is appropriated from the Indigent BAIID Fund
- 5 to the Office of the Secretary of State to reimburse ignition
- 6 interlock device providers per Public Act 95-0400, including
- 7 reimbursements submitted in prior years.
- 8 Section 225. The sum of \$20,000,000, or so much thereof as
- 9 may be necessary, is appropriated to the Office of the Secretary
- 10 of State from the Motor Vehicle Theft Prevention and Insurance
- 11 Verification Trust Fund for awards, grants, and operational
- 12 support to implement the Illinois Motor Vehicle Theft
- 13 Prevention and Insurance Verification Act, and for operational
- 14 expenses of the Office to implement the Act.
- Section 230. The sum of \$60,000, or so much thereof as may
- 16 be necessary, is appropriated to the Secretary of State from
- 17 the Illinois Professional Golfers Association Junior Golf Fund
- 18 for grants to the Illinois Professional Golfers Association
- 19 Foundation to help Association members expose Illinois
- youngsters to the game of golf.
