SYNOPSIS AS INTRODUCED:

30 ILCS 500/20-20

30 ILCS 535/45

from Ch. 127, par. 4151-45

Amends the Illinois Procurement Code. Provides that any procurement of construction not exceeding \$250,000 (currently, \$100,000) may be made without competitive source selection. Amends the Architectural, Engineering, and Land Surveying Qualifications Based Selection Act. In a Section concerning small contracts under the Act, provides that specified provisions do not apply to architectural, engineering, and land surveying contracts with an estimated basic professional services fee of less than \$50,000 (currently, \$25,000).

A BILL FOR

1 AN ACT concerning finance.

2 **Be it enacted by the People of the State of Illinois,**
3 **represented in the General Assembly:**

4 Section 5. The Illinois Procurement Code is amended by
5 changing Section 20-20 as follows:

6 (30 ILCS 500/20-20)

7 Sec. 20-20. Small purchases.

8 (a) Amount. Any individual procurement of supplies or
9 services not exceeding \$100,000 and any procurement of
10 construction not exceeding \$250,000 ~~\$100,000~~, or any
11 individual procurement of professional or artistic services
12 not exceeding \$100,000 may be made without competitive source
13 selection. Procurements shall not be artificially divided so as
14 to constitute a small purchase under this Section. Any
15 procurement of construction not exceeding \$100,000 may be made
16 by an alternative competitive source selection. The
17 construction agency shall establish rules for an alternative
18 competitive source selection process. This Section does not
19 apply to construction-related professional services contracts
20 awarded in accordance with the provisions of the Architectural,
21 Engineering, and Land Surveying Qualifications Based Selection
22 Act.

23 (b) Adjustment. Each July 1, the small purchase maximum

1 established in subsection (a) shall be adjusted for inflation
2 as determined by the Consumer Price Index for All Urban
3 Consumers as determined by the United States Department of
4 Labor and rounded to the nearest \$100.

5 (c) Based upon rules proposed by the Board and rules
6 promulgated by the chief procurement officers, the small
7 purchase maximum established in subsection (a) may be modified.

9 Section 10. The Architectural, Engineering, and Land
10 Surveying Qualifications Based Selection Act is amended by
11 changing Section 45 as follows:

12 (30 ILCS 535/45) (from Ch. 127, par. 4151-45)

13 Sec. 45. Small contracts. The provisions of Sections 25,
14 30, and 35 do not apply to architectural, engineering, and land
15 surveying contracts with an estimated basic professional
16 services fee of less than \$50,000 ~~\$25,000~~.
