#### SYNOPSIS AS INTRODUCED:

20 ILCS 1605/21.13

Amends the Illinois Lottery Law. Provides that the special instant scratch-off game to benefit Alzheimer's awareness be conducted for the benefit of Alzheimer's care, support, education, and awareness (rather than specifically named "The End of Alzheimer's Begins with Me"). Removes language discontinuing the scratch-off on January 1, 2021. Effective immediately.

1 AN ACT concerning State government.

2 **Be it enacted by the People of the State of Illinois,**  
3 **represented in the General Assembly:**

4 Section 5. The Illinois Lottery Law is amended by changing  
5 Section 21.13 as follows:

6 (20 ILCS 1605/21.13)

7 Sec. 21.13. Scratch-off for Alzheimer's care, support,  
8 education, and awareness ~~The End of Alzheimer's Begins With Me~~  
9 ~~scratch-off game.~~

10 (a) The Department shall offer a special instant  
11 scratch-off game for the benefit of Alzheimer's care, support,  
12 education, and awareness ~~with the title of "The End of~~  
13 ~~Alzheimer's Begins With Me"~~. The game shall commence on January  
14 1, 2020 or as soon thereafter, at the discretion of the  
15 Director, as is reasonably practical, ~~and shall be discontinued~~  
16 ~~on January 1, 2021~~. The operation of the game shall be governed  
17 by this Act and any rules adopted by the Department. If any  
18 provision of this Section is inconsistent with any other  
19 provision of this Act, then this Section governs.

20 (b) The net revenue from the Alzheimer's care, support,  
21 education, and awareness ~~"The End of Alzheimer's Begins With~~  
22 ~~Me"~~ scratch-off game shall be deposited into the Alzheimer's  
23 Awareness Fund.

1 Moneys received for the purposes of this Section,  
2 including, without limitation, net revenue from the special  
3 instant scratch-off game and from gifts, grants, and awards  
4 from any public or private entity, must be deposited into the  
5 Fund. Any interest earned on moneys in the Fund must be  
6 deposited into the Fund.

7 For the purposes of this subsection, "net revenue" means  
8 the total amount for which tickets have been sold less the sum  
9 of the amount paid out in the prizes and the actual  
10 administrative expenses of the Department solely related to the  
11 scratch-off game under this Section.

12 (c) During the time that tickets are sold for the  
13 Alzheimer's care, support, education, and awareness ~~"The End of~~  
14 ~~Alzheimer's Begins With Me"~~ scratch-off game, the Department  
15 shall not unreasonably diminish the efforts devoted to  
16 marketing any other instant scratch-off lottery game.

17 (d) The Department may adopt any rules necessary to  
18 implement and administer the provisions of this Section.

20 Section 99. Effective date. This Act takes effect upon  
21 becoming law.
