9 Section 15. The amount of \$3,000,000, or so much thereof 10 as may be necessary, is appropriated from the General Revenue 11 Fund to the Law Enforcement Training Standards Board for 12 deposit into the Traffic and Criminal Conviction Surcharge 13 Fund. No portion of this appropriation shall be deposited into 14 the Traffic and Criminal Conviction Surcharge Fund unless and 15 until it is approved in writing by the Governor.

Section 99. Effective Date. This Act takes effect July 1, 2020.
