SYNOPSIS AS INTRODUCED:

625 ILCS 5/3-806

from Ch. 95 1/2, par. 3-806

Amends the Illinois Vehicle Code. Lowers the registration fee for motor vehicles of the first division, other than autocycles, motorcycles, motor driven cycles, and pedalcycles, from \$148 to \$120, not including surcharges.

AN ACT concerning transportation.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

4 Section 5. The Illinois Vehicle Code is amended by 5 changing Section 3-806 as follows:

6 (625 ILCS 5/3-806) (from Ch. 95 1/2, par. 3-806)

Sec. 3-806. Registration Fees; Motor Vehicles of the First Division. Every owner of any other motor vehicle of the first division, except as provided in Sections 3-804, 3-804.01, 3-804.3, 3-805, 3-806.3, 3-806.7, and 3-808, and every second division vehicle weighing 8,000 pounds or less, shall pay the Secretary of State an annual registration fee at the following rates:

3 Cycles and Pedalcycles

A \$1 surcharge shall be collected in addition to the above fees for motor vehicles of the first division, autocycles, motorcycles, motor driven cycles, and pedalcycles to be deposited into the State Police Vehicle Fund.

8 All of the proceeds of the additional fees imposed by 9 Public Act 96-34 shall be deposited into the Capital Projects 10 Fund.

A \$2 surcharge shall be collected in addition to the above 11 12 fees for motor vehicles of the first division, autocycles, motorcycles, motor driven cycles, and pedalcycles to be 13 deposited into the Park and Conservation Fund for the 14 15 Department of Natural Resources to use for conservation 16 efforts. The monies deposited into the Park and Conservation 17 Fund under this Section shall not be subject to administrative 18 charges or chargebacks unless otherwise authorized by this 19 Act.

Of the fees collected for motor vehicles of the first division other than Autocycles, Motorcycles, Motor Driven Cycles, and Pedalcycles, \$1 of the fees shall be deposited into the Secretary of State Special Services Fund and \$49 of the fees shall be deposited into the Road Fund.
