AN ACT concerning public employee benefits.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

4 Section 5. The Illinois Pension Code is amended by 5 changing Section 3-110.10 and by adding Section 7-139.14 as 6 follows:

7 (40 ILCS 5/3-110.10)

Sec. 3-110.10. Transfer from Article 7. Until January 1, 8 9 2009, a person may transfer to a fund established under this Article up to 8 years of creditable service accumulated under 10 Article 7 of this Code upon payment to the fund of an amount to 11 be determined by the board, equal to (i) the difference 12 between the amount of employee and employer contributions 13 transferred to the fund under Section 7-139.11 and the amounts 14 that would have been contributed had such contributions been 15 16 made at the rates applicable to an employee under this Article, plus (ii) interest thereon at the actuarially assumed 17 rate, compounded annually, from the date of service to the 18 date of payment. 19

Transfer to Article 3 pension fund. 16 (a) Within 6 months after the effective date of this 17 amendatory Act of the 102nd General Assembly, an active member of a pension fund established under Article 3 of this Code may 18 19 apply for transfer to that Article 3 pension fund of his or her 20 credits and creditable service accumulated in this Fund for 21 service as a sheriff's law enforcement employee, person 22 employed by a participating municipality to perform police duties, or law enforcement officer employed on a full-time 23 24 basis by a forest preserve district. The creditable service 25 shall be transferred only upon payment by this Fund to such

Article 3 pension fund of an amount equal to: 1 2 (1) the amounts accumulated to the credit of the applicant for the service to be transferred, including 3 interest; and 4 5 (2) an amount representing employer contributions, 6 equal to the total amount determined under item (1); and 7 (3) any interest paid by the applicant to reinstate 8 such service. 9 Participation in this Fund as to any credits transferred 10 under this Section shall terminate on the date of transfer. 11 (b) Notwithstanding any other provision of this Code, any 12 person applying to transfer service under this Section may 13 reinstate credits and creditable service terminated upon 14 receipt of a separation benefit by paying to the Fund the 15 amount of the separation benefit plus interest thereon at the 16 actuarially assumed rate of interest to the date of payment. 17 Such payment must be made within 90 days after notification by the Fund of the cost of such reinstatement. 18
